- (b) That the co-optees' allowances to the independent and parish council members, and the special responsibility allowances for the Chairman and the Chairman of the Consideration and Hearings Sub-Committee of the Standards Committee, be abolished; and
- (c) That it be noted that the Independent Remuneration Panel will re-examine the level of the special responsibility allowance to the Chairman of the Audit Committee when next it undertakes the required four-yearly review of the Council's Members' Allowances Scheme, at the end of 2013.
