As part of its highway network management review Hampshire County Council is setting up Highway Management Advisory Panels for each of the District Council areas. The terms of reference of the Panels are:

- (a) To receive reports on highway management topics and programmes, to offer advice and recommendations to the Highway Unit Manager and to monitor and review highway management activities;
- (b)To receive reports on the implementation of traffic management schemes in the Area Transport Strategy programmes relating to that district, to monitor and review progress on those schemes and to offer advice and recommendations as appropriate to the relevant project managers.

Two meetings per year are proposed.

All County Councillors for the electoral divisions within the District Council (i.e. 11 County Councillors), together with the County's Portfolio Holder for the Environment, will be the County Council's representatives on the Advisory Panel. The District Council is invited to appoint 11 Councillors to serve on the Panel. Standing deputies may also be appointed.
