

#### **CABINET - 4 DECEMBER 2002**

## REPRESENTATION ON REVIEW PANELS, OUTSIDE AND OTHER BODIES

#### 1. INTRODUCTION

- 1.1 Changes to some of the Council's representatives on outside and other bodies are necessary following -
  - (a) the resignation of Cllr Hayes as Leader of the Council and the appointment of Cllr Kendal to this position;
  - (b) the appointment of Cllr N L T Smith to the Cabinet as Environment Portfolio Holder:
  - (c) the resignation of Cllr Spikins from the Crime & Community Safety Action Group;
  - (d) the redundancy of the Director of Environment Services with effect from 31 December 2002.

#### 2. APPOINTMENTS

- 2.1 Cllr N Smith's appointment to the Cabinet means that there are vacancies on the Corporate & Finance and Environment Review Panels. The Conservative Group wishes both places filled by Cllr Hayes. This will require the approval of the Council.
- 2.2 Cllr Kendal (with Cllrs Holding and Wise) is a member of the New Forest/Test Valley Joint Committee. He wishes to resign this place and for it to be filled by Cllr N Smith. This is an appointment that the Cabinet may make.
- 2.3 Cllr N Smith (together with Cllrs Thierry and Dash) is a member of the New Forest/Test Valley Joint Overview and Scrutiny Committee, a position he has to relinquish now that he is a member of the Cabinet. The Conservative Group wishes this place filled by Cllr Woods. This will require the approval of the Council.
- 2.4 The appointments on outside bodies affected by the changes mentioned in paragraph 1.1 above are set out in Appendix 1. Where more than one representative serves on a body, or where deputies have been appointed, these are also shown.
- 2.5 Recommendations for appointments to the vacancies on outside bodies are set out in Appendix 2. These are appointments that the Cabinet may make.

#### 3. RECOMMENDATION

- 3.1 That Cllr N L T Smith be appointed to the NFDC/Test Valley Joint Committee in place of Cllr Kendal;
- 3.2 That it be recommended to the Council that Cllr Woods be appointed to the NFDC/Test Valley Joint Overview and Scrutiny Committee in place of Cllr Smith;
- 3.3 That it be recommended to the Council that the vacancies on the Corporate & Finance and Environment Review Panels caused by the appointment of Cllr N Smith to the Cabinet be filled by Cllr Hayes;
- 3.4 That the Cabinet reviews the appointments to outside bodies in the light of the changes set out in paragraph 1 of this report, and approves the representatives set out in Appendix 2;
- 3.5 That any changes involving the Director of Environment Services' appointments to outside bodies take effect from 1 January 2003.
