FEES & CHARGES APPLICABLE FROM 1 APRIL 2003

1. INTRODUCTION

- 1.1 The purpose of this report is to propose fees and charges applicable from 1 April 2003 for all Portfolios and General Purposes and Licensing and Planning Development Control Committees. Charges for recreation centres were considered by Cabinet on 4 December 2002.
- 1.2 The proposed fees and charges increases will be considered by the Review Panels in January 2003. Any comments from the Panels will be presented to Cabinet in February before final recommendations are made to Council.

2. PROPOSED FEES AND CHARGES

- 2.1 A schedule of the proposed fees and charges is attached as Appendix A. All fees and charges have been reviewed in accordance with the expenditure plan operational guidelines.
- 2.2 In accordance with the Corporate Charging Policy, the schedules shown in Appendix A contain the following information:

 - Year on year percentage increase
 - > An indicator box that will identify whether:
 - M Market comparisons have been undertaken
 - L Local Authority comparisons have been undertaken
 - S Charge is statutory based

5. FINANCIAL IMPLICATIONS


