## 13. Responsible Authority Delegations under the Gambling Act 2005

Under the Gambling Act 2005, a "responsible authority" may make representations to the licensing authority on a premises licence application. Where representations are made and not withdrawn, a hearing before the Licensing Sub-Committee will be required to determine the application. "Responsible authority" is defined in the Act as any of a number of specified bodies, including:

"the local planning authority ...... for an area in which the premises are wholly or partly situated" (section 157 (e) (i)), or

"an authority which has functions .... in respect of minimising or preventing the risk of pollution of the environment or of harm to human health in an area in which the premises are wholly or partly situated" (section 157 (g)).

It is considered that appropriate officers within the planning and environmental health sections of the Council should be authorised to make representations to the licensing section on a premises licence application, if they consider such representations necessary, for example because of concerns about the likely effect of the grant of a licence or the conditions which should apply to it.

The Cabinet therefore, in so far as they are empowered to do so by law:

### **RECOMMENDED:**

- (a) That the Head of Planning, Development Control Manager, Area Planning Officers, Principal Planning Officer and Senior Planning Officer – Enforcement be authorised to carry out the Council's functions as a responsible authority under section 157 (e) of the Gambling Act 2005;
- (b) That the Environmental Health Manager, Senior Environmental Health Officers, and Environmental Health Officers be authorised to carry out the Council's function as a responsible authority under section 157 (g) of the Gambling Act 2005.
