GREEN AUDIT DRAFT IMPROVEMENT PLANS

1 INTRODUCTION

- 1.1 This report sets out three of the improvement plans coming out of the Green Audit.
- 1.2 These plans relate to the following themes:
 - The way households are run
 - The way we work with businesses
 - The way communities are run
- 1.3 As part of the Green Audit process Cabinet asked to approve these plans.

2 THE WAY HOUSEHOLDS ARE RUN

- 2.1 This theme looks at the Council's approach to domestic waste management reduction, re-use and recycling of material and home energy conservation.
- 2.2 A copy of the draft improvement plan is attached at Appendix 1.

3 THE WAY WE WORK WITH BUSINESSES

- 3.1 This theme looks at the issue of commercial waste management and energy management.
- 3.2 A copy of the draft improvement plan is attached at Appendix 2.

4 THE WAY COMMUNITIES ARE RUN

- 4.1 This theme focuses on traffic management and street scene issues.
- 4.2 A copy of the draft improvement plan is attached at Appendix 3.

5 FINANCIAL IMPLICATIONS

5.1 There are no direct financial implications arising from the approval of these plans. Any cost savings will be identified as a result of monitoring the implementation of the plans. Any requirement for funding would form part of any future expenditure planning process. Any savings in carbon from April 2010 will reduce the cost of the carbon budget that is likely to be in place as a result of the Government's Carbon Reduction Commitment although it is still not yet clear whether the Council will be included in the first tranche of this.

6.1 The approval and implementation of all plans coming out of the Green Audit should make important contributions towards the environment, in particular reducing the Council's and the District's carbon footprint and making best use of non renewable natural resources.
