HAMPSHIRE LOCAL PUBLIC SERVICE AGREEMENT (LPSA2)

1. INTRODUCTION

- 1.1 As part of the countywide LPSA2 agreement the Council has received notification of its share of the reward grant totalling over £900,000. Cabinet needs to determine how this will be utilised.
- 1.2 In September 2005 Cabinet agreed to this Council's level of involvement in a number of targets being established across Hampshire for agreement with the Government under the LPSA2. The basis of the commitment was on the understanding that the Government would fund some pump priming of the work on the targets (£2m total across Hampshire) and that reward money was payable based on performance and level of involvement.
- 1.3 The targets developed across Hampshire and with the Government provided a focus on what was seen as priority issues. Many of the targets linked well with the Council's priorities and those contained within the District's Community Strategy.
- 1.4 The Agreement related to a 3 year period 1 April 2006 to 31 March 2009.

2. LPSA2 SIGN UP

- 2.1 Partners were able to sign up to one of three levels for each target:
 - Level 3 general sign up to the LPSA overall, no active contribution to the target. There was an expectation that at this level partners would be willing to share data and information where this would help improve performance (5% of all reward grant earned would be top sliced and allocated equally to all level 3 partners)
 - Level 2 active contribution to achieving the stretch in performance
 - Level 1 target lead, where a partner agrees to co-ordinate the work including the specific negotiations with the Government (10% of each target grant payable)
- 2.2 This Council signed up to 14 of the 16 targets at level 2 and 2 purely at level 3. This represented more active involvement than any other district level partner in Hampshire.
- 2.3 Performance was to be judged across Hampshire. For reward money to kick in at least 60% of target had to be met across the county area.

3. LPSA2 FINANCIAL IMPLICATIONS

- 3.1 The potential reward grant from the Government was £29m if every target achieved its 100% stretch.
- 3.2 Following an audit of performance and acceptance by Government a total reward grant for Hampshire of over £17m has and will be paid (due to paid in two instalments over two years 2009/10 and 2010/11).
- 3.3 This Council will receive £918,141 a figure more than any other district level partner.

4. THIS COUNCIL'S REWARD CONTRIBUTION

- # 4.1 Set out at Appendix A are details of the Council's Reward Grant share as assessed against each of the countywide 16 targets.
 - 4.2 Each target had its own challenges and different approaches to achieve improvement. Pump priming money was used where this was available. Some activity was delivered through partnership eg Community Safety targets, some through supporting partners to deliver eg arts and voluntary sector partners and others through direct delivery by the service itself.
 - 4.3 A principle of the LPSA2 arrangement is that a proportion of the Reward Grant would be reinvested in services that contributed towards the overall achievement and maintenance of the performance levels attained. Based upon this a number of specific proposals have been put forward for use of approximately £362,000 of the Reward Grant to enable projects which have contributed to the improvement in performance to continue. Details are set out at Appendix B.

5. FINANCIAL IMPLICATIONS

#

5.1 The Council's Medium Term Financial Plan has been developed on the basis that the reward grant would be shared between the specific services that supported the performance improvement and the general council tax payer. Expenditure related to LPSA 2 Reward Grant has therefore been provided for within the budget and the implications of its one off use are cost neutral.

6. PORTFOLIO HOLDERS COMMENTS

6.1 In these difficult times it is pleasing to be able to report on the Council's success which has benefited many in our community. The use of reward grant as set out will also provide benefits into the future. In addition to providing better services we are delighted that it will also provide funds to help the council taxpayer.

7. CONCLUSION

7.1 LPSA work has featured well in the Council's activities and has enabled it to improve performance on some priority issues whilst attracting significant additional funds from outside the district. It has also helped the Council maintain its good reputation as an organisation that is willing to work with others and deliver on agreed targets.

8. **RECOMMENDATION**

8.1 That the Council be recommended to agree that the use of the LPSA2 Reward
Grant be agreed as set out in Appendix B with the balance being allocated to support the Medium Term Financial Plan.
