# DELEGATION OF POWERS UNDER NEW FOOD SAFETY AND HYGIENE REGULATIONS

## 1. BACKGROUND

- 1.1 The European Parliament has issued a number Food Hygiene and Food Safety Regulations that apply directly in all EU member states and there are obligations on all EU member states to make national law to provide for the Regulations' enforcement. The Food Safety and Hygiene (England) Regulations 2013 ('the 2013 Regulations') have been made to consolidate the current regulations and continue to apply the European legislation into UK law. These Regulations will come into force on 31 December 2013 and repeal existing Regulations.
- 1.2 A review of legislation to control the safety of imported food and products of animal origin has identified amendments that need to be considered for delegation of powers.
- 1.3 The Food Hygiene and Food Safety enforcement powers for Environmental Health staff are derived from these Regulations.

### 2. CHANGES IN LEGISLATION

- 2.1 Legislators have identified concerns raised by food businesses that it can be difficult to find food safety law and food hygiene law that is relevant to them. In England there was previously two sets of Regulations which dealt with food safety (The General Food Regulations 2004) and food hygiene (The Food Hygiene (England Regulations) 2006) as well as various amending Statutory Instruments.
- 2.2 By consolidating the existing Regulations into one set of Regulations, it will make these provisions easier to find. In addition, following food poisoning from sprouts and seeds intended for sprouting, the European Commission has introduced a package of Regulations for the hygienic production of sprouts, which are intended to safeguard public health. These Regulations will be given effect in England in the 2013 Regulations.
- 2.3 A review of other legislation has identified the need to update some delegations and these are also included below.
- 2.4 The revised delegations of powers are a result of changes in legislation and do not introduce any new requirements for businesses.

## 3. REQUEST FOR DELEGATION OF POWERS

3.1 As New Forest District Council is the enforcement authority referred to in the 2013 Regulations it may authorise persons, in writing, to act in matters arising under the 2013 Regulations and relevant EU Regulations. The following powers are recommended to be delegated to the respective posts.

#### Source

Regulation 2 - The appointment of Authorised Officers.

#### **Delegated To**

Environmental Health Manager, or Senior Environmental Health Officers, or Environmental Health Officers, or Environmental Health Technicians.

Regulation 6 - to serve a Hygiene Improvement Notice on a food business operator

Regulation 7 – to serve a Hygiene Prohibition Order on the food business operator and to affix a copy to the premises and to issue a certificate that that the authority is satisfied that the health risk condition no longer exits.

Regulation 8 – to serve a Hygiene Emergency Prohibition Notice on a food business operator and to affix a copy to the premises.

Regulation 8 - to apply to a Magistrates Court for a Hygiene Emergency Prohibition Order.

Regulation 8 - To serve a copy of a Hygiene Emergency Prohibition Order on a food business operator and to affix a copy to the premises. To issue a certificate that that the authority is satisfied that the health risk no longer exits.

3.2 Delegation of the above powers supersedes existing entries in the list of Council delegations and the following should be deleted; ENV 57 to 68 inclusive, ENV 70, ENV 72, ENV 74 to 76 inclusive and ENV 83. This includes deleting reference to The Food Hygiene (England) Regulations 2006 which are repealed by the 2013 Regulations.

#### 4. FINANCIAL, ENVIRONMENTAL, CRIME AND DISORDER IMPLICATIONS

4.1 The powers contained in the new Regulations are not new as they have been consolidated from previous legislation, therefore there are no financial, environmental or crime and disorder implications as a result of this report.

## 5. PORTFOLIO HOLDERS COMMENTS

5.1 The Portfolio Holder supports the proposed delegations, which update the existing powers.

### 6. **RECOMMENDATION**

6.1 That the officers be delegated the powers as set out in Section 3.1 of this report and the current delegations which refer to the Food Hygiene (England) Regulations 2006 and other superseded entries, as set out in Section 3.2 of this report, be deleted from the Council's delegations, with effect from 31 December 2013.
