COMMUNITY OVERVIEW AND SCRUTINY PANEL: 20 JANUARY 2015

HEALTH AND LEISURE PORTFOLIO COMMUNITY GRANTS INITIAL RECOMMENDATIONS

1. PROCESS

- 1.1 Through the Corporate Overview and Scrutiny Panel, the Council has reviewed its process for the allocation of community grants. A new approach provides an opportunity for Members to comment on submitted grant requests ahead of consideration by the relevant Scrutiny Panel of the initial recommendations of the appropriate Portfolio Holder.
- 1.2 In respect of this Panel, community grant requests have been received and been made available for members' comments. Having considered the applications and comments received, the Portfolio Holder for Health and Leisure has made an initial assessment and this report seeks the Panel's observations on these initial recommendations.
- 1.3 After the discussion at Panel, the Portfolio Holder will consider any comments made, before making final recommendations as part of the budget paper presented to the February Cabinet meeting.

2. POLICY FRAMEWORK

2.1 The Council has established grant-aid criteria, which is available on Forestnet.

3. BUDGET IMPLICATIONS

3.1 All requests will be considered by the Cabinet in February as part of the budget setting process.

4. CONSULTATION

4.1 Members were consulted on the bids themselves before the Portfolio Holder considered their recommendations. Therefore the comments from Members are addressed at the principle of the bid, rather than the recommendation. The comments are included under each of the grant requests.

	Applemore College	Artificial Turf pitch

SUMMARY: Applemore College are progressing this scheme for a full size all-weather pitch. It will occupy a part of the College site which is under-used for sport. They will not only build the facility but also operate it. Planning Permission has been obtained and there is strong support from the Governing Bodies of football and rugby. Close ties have also been made with the local Armed Forces and an innovative programme connecting them with local community is being devised. There is a bid to Sport England which is key to the ability to deliver the scheme. Community use would be secured through the Council's own Agreement but there will also be conditions attached to any award from them.

MEMBER COMMENTS:

Cllr Alan Alvey: Agree that this is a worthwhile project. But would prefer to see funding going to NFDC or Parish projects. (Advised that all requests for grants are considered as part of the overall Budget process – so in effect the Council considers all of its spending at that one time))

It is competition with Fawley Parish Council's development of grass rugby pitches. Has drainage and grass provision been discussed? ((Advised that this is an all weather multi sports pitch that is intended for all day use, every day, so is not equivalent to grass))

The form shows a sum of \pounds 50,000 already committed from NFDC – is this just a rubber stamping exercise? ((Advised that this bid will go through the same process as all the others. Applicants will include sources to whom they've made bids))

Cllr Alan O'Sullivan: support the project but does this require investment by NFDC at Applemore Health and Leisure Centre? ((Advised the Leisure Centre is not involved)

An allocation of £50,000

	Brockenhurst Anglican Church	Refurbishment of village hall

TOTAL COST £ 300,000

OTHER FUNDS/INCOME £ 271,000

SUMMARY: The application is for the extension and refurbishment of the current village hall. The Hall has an exceptional programme of community activities that ranges across the age spectrum. Their strong track record means that demand exceeds capacity and hence the need for the project. It will revise the kitchen arrangements; provide a dedicated space for young

people; a crèche; a new disabled WC and larger office. The fundraising has been very successful to date and has largely been raised locally.

MEMBER COMMENTS:

Cllr Alan O'Sullivan: the application may be premature as £330k is a large target. There is a figure of £30K for charities we would need to be clear if this was being contributed to. ((Advised that any NFDC award would apply only to works)) Cllr Maureen Holding: It is crucial that Brockenhurst gets its money for the Church Hall. It is a much needed facility and serves the community well, including outreach, which it has done for a number of years. It is host to lots of youth organisations, young women's groups; WI etc. Costs are high as it is attached to a listed building.

	Hampshire County Council	Refurbishment of Lepe Country Park

TOTAL COST £2,350,000 **OTHER FUNDS/INCOME** £ 1,768,000

SUMMARY: The County Council are seeking to refurbish and develop the provision at Lepe Country Park. They have pursued bids to the Heritage Lottery Fund without success to date. In light of this the County is developing the project having first recognised it as a priority in their own capital planning. It is still in its formative stages but the intention is to improve visitor facilities (e.g. catering; toilets; parking) and the visitor experience (e.g. trails; signage; play equipment) with the aim of moving towards a facility that is self funding operationally. Without investment there are risks associated with temporary planning permissions and flood risk.

Cllr Alan O'Sullivan: support

	Lymington Community Association	Phase 1 pre-school re-development

TOTAL COST £ 250,000 **OTHER FUNDS/INCOME** £ 225,000 **SUMMARY:** The Association is faced with a long term need to refurbish the Centre. Taking a phased approach, this is the first project to be developed. The scheme is to provide a totally revised Pre School that offers 50% more places to two to five year olds. This is in an area which HCC advise is under provided with places. It will mean the provision meets current regulatory requirements and will provide facilities which give the children the best of learning environments. It is also a project which has to be done first to enable subsequent phases to follow.

MEMBER COMMENTS:

Cllr Alan O'Sullivan: Excellent community project. Could consider solar panels on the roof.

Cllr Elizabeth Lewis: Support the scheme wholeheartedly. It is the centre of the social an intellectual life in the Lymington area, with extensive programme of activities, as well as the cinema and theatre. The major alterations to the Centre will make it even more accessible to all. Support the Trustees by giving a grant to help the imaginative work they have begun.

An allocation of £25,000

This scheme is a HIGH PRIORITY as extension of an existing facility and one that will develop their programme of activity and participation. Previous grants: 2007: £25,000 to equip a new hall; 1983: £7,000 for an extension; 1979: £1,000 for fire and safety works

SUMMARY: The Association have short term tenure of what was St Aldhelm's Church in Sandleheath. There is some community use at present but this project aims to secure longer term tenure and to refurbish the building; upgrade toilets including a new disabled WC; improved insulation / lighting and so forth, so as to suit the needs of community use. It is the only community facility in the village and indications are that demand will be strong and it will make a positive contribution to village identity and community spirit. There are still important formalities to conclude – for example the lease and any award would be subject to successful conclusion of those matters.

MEMBER COMMENTS:

Cllr Alan O'Sullivan: good idea subject to leasing arrangements

RECOMMENDATION:

An allocation of £30,000

This scheme is a HIGH PRIORITY as effectively a new community facility with a programme of activities that will encourage more participation. Previous grants: None
