The Acting Head of Paid Service thanked members for his appointment and looked forward to working with the elected members and his fellow chief officers to meet the challenges which would come forward in the next year.

35. MONITORING OFFICER.

RESOLVED:

That the Acting Head of Paid Service be appointed as the Monitoring Officer for the Council with effect on 1 October 1995.

36. DELEGATION OF POWERS AND DUTIES.

RESOLVED:

That with effect on 1 October 1995 the Acting Head of Paid Service be authorised to exercise all powers, and undertake all duties ascribed to the Chief Executive in all of the Council's formal and informal documents, and in particular Standing Orders, Standing Orders with respect to Contracts, Financial Regulations, the Proper Officer provisions and the Delegated Power provisions.

37. CHIEF EXECUTIVE.

The Chairman of the Council moved the following:-

"That the best thanks of this Authority be accorded to Peter Hyde for his service as Chief Executive, and previously Treasurer, of the Council, and he be wished every success and happiness in his retirement."

The Chairman recalled Peter Hyde's career in local government, and in particular with this Authority, which he had joined in March 1977 as Treasurer. He had been appointed as General Manager in 1989, the post subsequently being re-named as Chief Executive. His many successes included this Council winning the first award from CIPFA for its published accounts in 1980. This Council retained the original trophy. The Chairman also spoke of his leadership abilities. Peter Hyde valued his staff members and motivated them to work to their full potential. He had demonstrated, through his actions, his commitment to the values of openness and trust.

Peter Hyde had taken the lead in presenting this Council's case for unitary authority status. The Minister had been impressed by the New Forest case, although sadly it had failed for political reasons. The Chairman thanked Peter Hyde for the help and support that he gave to all members, and in particular to himself during his Chairmanship.
