#### 5. **Political Representation on Committees**

- (a) To note the arrangements being made to fill the vacancy on the Council for the Ringwood North ward following the death of Cllr Mrs L K Errington.
- (b) (i) The Council does not have a duty to review political representation on committees when a vacancy arises, but has the power to conduct a review to determine the allocation of seats to political groups if it so decides.
