42. MINUTES.

RESOLVED:

That the minutes of the meetings held on 30 October and 9 November 2000, having been circulated, be signed by the Chairman as correct records.

Arising on the minutes:-

Severe Weather Conditions

Members joined the Chairman in thanking employees once again for their excellent response in supporting the people of the New Forest during the recent severe weather conditions.

43. CHAIRMAN'S ANNOUNCEMENTS.

(a) Mrs Eileen Alderson

The Chairman reported with regret the death of Mrs Eileen Alderson, the widow of the late Mr R Alderson, the Council's first Chairman. Mrs Alderson had passed away shortly before Christmas and her funeral had been held on Friday, 29 December at New Milton Parish Church. The Chairman had attended the funeral and had sent a letter of condolence to her family on behalf of members and officers of the Council.

(b) New Year's Honours

The Chairman was pleased to report that three local residents had been recognised in the Queen's New Year's Honours List.

Mr Peter Butt, of Totton, the former Superintendent Registrar at Southampton, had been awarded an MBE after a lifetime of dedicated service.

Miss Margaret Scott of New Milton, who had been the Acting Manager of Efford Horticulture Research Station at Lymington, had been awarded an MBE for services to horticulture.

Olympic Gold Medal Champion, Mr Ben Ainslie had been awarded an MBE for his outstanding achievements in sailing.

(c) Bike Raffle and Dinner and Dance 2001

The Chairman congratulated Mr Malyon, Director of Finance, on winning a 21 speed gents bicycle which was raffled amongst staff and members for Christmas. £174 had been raised for the Chairman's charity.

The Chairman reported that there would another opportunity to win prizes at his Dinner and Dance this year to be held at Bashley Park, New Milton on Friday, 6 April 2001.

(d) Drug Action Team

The Chairman was pleased to announce that Mr Gibbs, Director of Community Services, had been appointed Chairman of the New Drug Action team for Hampshire. The Hampshire Drug Action Team was one of the largest in the country covering a population of £1.2m people. Mr Gibbs' appointment would help him to build on the work that he had been doing over the last two years as Chairman of the Southampton and South West Hampshire Drug Action Team.

(e) Legal Section – Law Society Accreditation

The Chairman reported with pleasure that the Council's Legal Section had recently been awarded external accreditation by the Law Society.

The accreditation, called Lexcel, was awarded only to private solicitors' offices and legal practices within local authorities that met very strict requirements on a whole range of quality issues.

Currently only two other councils in Hampshire and a very small percentage of solicitors' firms nationally had received Lexcel accreditation.

Members joined the Chairman in congratulating all employees within the Legal Section for their good work.

44. GENERAL PURPOSES AND LICENSING COMMITTEE.

The Chairman of the Committee presented the report of the meetings held on 24 November and 1 December 2000. On the motion that the report be received and the recommendation be adopted it was:-

RESOLVED:

That the report be received and the recommendation adopted.

45. POLICY AND RESOURCES COMMITTEE.

The Chairman of the Committee presented the report of the meetings held on 15 November and 4 and 20 December 2000. On the motion that the report be received and the recommendations adopted:-

Cllrs Brooks, Dash, Harris, Kendal, M S Wade and Waddington declared non-pecuniary interests in item (a) below. They remained in the meeting but did not vote. There was no debate.

(a) Food and Environment Protection Act 1985 Part II – Port Development Proposals at Dibden Bay

A member enquired if notification had been received of the results of the inter-tidal recharge experiment which Associated British Ports had carried out last Autumn.

The Chairman of the Committee responded that the trial had been carried out and the results were being analysed and written up. The report was due to be published by English Nature later in January 2001. English Nature had given no indication of the success or otherwise of the trial but had said that the report would need to be read to appreciate the findings.

(b) Public Consultation on Proposals for Ringwood Town Centre

A member commented on the proposals for a "Stakeholder Dialogue" approach to the consultation which would enable consultees to inform themselves and share experiences. The method was a very cost effective and valuable way of carrying out a consultation. Another member agreed that the Stakeholder dialogue approach was a useful process. It had been used before in other consultations and had had a good response. It was noted that a good deal of local opinion and information had already been received and this would be used to inform the process further.

(c) Local Information Office and Affordable Housing at Stannington Car Park, Ashley Road/Spencer Road, New Milton

A member commented that whilst she was extremely supportive of the proposals she still had some concerns over the suggested rental to be paid by New Milton Town Council and the apparent lack of consultation with the Housing Corporation. Another member shared the concerns relating to the rental requirement and more generally to the siting of the scheme at Stannington Car Park.

It was moved that the scheme should be delayed to look, in conjunction with the housing association, at further options of alternative sites.

Members expressed concern at any further delay to the project. Clients were not currently well served by the facilities in the area, particularly visitors to the Citizens' Advice Bureau. It was hoped that the issue over rental would not affect the prospective tenancy rents and that the District Council and the Town Council would come to an agreement on what was reasonable to pay.

The proposal was not seconded and therefore fell.

The Vice-Chairman of the Committee said that the scheme would not be viable without a rental element being included. The rental payable by tenants would be assessed and set at a comparable level. It would not be reasonable to expect tenants to subsidise non housing elements of the scheme. The proposals for the new Local Information Office and the affordable housing had been long and protracted in order to try to accommodate all of the concerns of the parties involved.

A number of members expressed concern at the resultant loss of car park spaces in Stannington Car Park. It was noted that the scheme was still subject to the granting of planning permission and that the provision of car parking generally would be considered at that time.

The Chairman of the Committee commented that the success of the scheme did not necessarily depend on New Milton Town Council as a tenant. Others had expressed interests that would continue to make the proposals viable. The Housing Corporation had been involved and would continue to be so.

(d) Financial Strategy and Expenditure Plans 2001/02 – 2004/05

A member commented on proposals in the expenditure plans to increase the cost of clear sacks and reduce the provision of additional black sacks. Other members drew attention to the increasingly blurred division of responsibilities between the refuse collection and disposal roles of the District Council and the County Council; and the increase in fly tipping since the introduction of charges for special collections. It was noted that the Portfolio Performance and Review Panels would be considering the Financial Strategy and the Expenditure Plan Proposals over the next few days.

(e) Fluoridation of Water Supplies

Members noted that whilst there were no know current proposals to fluoridate local water supplies the government were awaiting a report on tooth decay and as a result might consider the option.

A member commented that a clean water supply without the addition of fluoride was a human right and that individuals could choose to add fluoride if they so wished.

It was moved and seconded that the Council should strongly reiterate their former objection to fluoride being included in the water supply.

Another member expressed the view that further information on the advantages and disadvantages of fluoridation of water supplies was needed before a decision should be taken.

It was moved and seconded that the matter should be deferred indefinitely. Upon a vote being taken this motion was lost.

A vote on the motion to strongly reiterate the Council's former objection to the inclusion of fluoride in the water supply was agreed.

It was therefore

RESOLVED:

That the Council strongly reiterate its former objection to the inclusion of fluoride in the water supply.

(f) Stillwater Mobile Home Park

A member asked the Chairman of the Committee to confirm the Council's intention to sell Stillwater Mobile Home Park and to use the proceeds to fund the Social Housing Programme. The residents had been invited to consider three options which had not included sale of the site to a private

owner. Next year's expenditure plans included funding that would result from any sale. It was felt that the Council should have offered independent advice to the residents. Prospective new site owners should have been asked to explain what they considered the future site ownership arrangements to be.

It was proposed and seconded that the consultation process should be halted and, following independent advice, a fuller and fairer consultation be carried out.

The Housing Portfolio Holder responded that no decision had been reached on whether or not the site should be sold. A letter had been sent to all residents in January 2001 asking for their views. All options were still open for consideration.

Whilst it was noted that there had initially been some confusion amongst the residents over the consultation process there was currently goodwill on all sides and it would not be helpful to stop the procedure.

The view was expressed that whilst the pressures on the housing function were appreciated it was necessary to ensure that the future of the residents at Stillwater Park was safeguarded. The site should be sold either to a social landlord or to Ringwood Town Council who had expressed an interest.

The Chairman of the Committee expressed concern at the effect on the residents of adverse speculation over the future of Stillwater Park. There was no suggestion that anything would be done that would be to the detriment of the residents. There was no intention to sell the site unless the circumstances were such that the residents' future was secure in a way in which the District Council found acceptable.

The motion that the Consultation be halted until independent advice was made available to the residents was put to the vote and was lost.

RESOLVED:

That the report be received and the recommendations adopted.

46. STANDARDS COMMITTEE.

The Chairman of the Committee presented the report of the meeting held on 15 December 2000. On the motion that the report be received and the recommendations adopted:-

(a) Members' Allowances Scheme

A member commented that the situation of the pensionability of members allowances remained unclear. In relation to the introduction of a dependant carers allowance a member asked for clarification on the definition of an immediate family member.

The Chairman responded that decisions relating to pensionability of members allowances could only be taken when further guidance was received from the Government. In relation to the definition of an immediate family member the Chairman commented that this matter would be dealt with when consideration was given to allowances as a whole in the next few months. It might be that members of the same household were excluded.
