9. Notice of Motion

In accordance with Standing Order 21, Cllr Pemberton will move the following Motion :-

"That the Chairman of the Council write to the Home Secretary stating the concern of the New Forest District Council that the system of vetting by the Criminal Records Bureau would not notify applicant organisations of any new case of abuse by an individual previously cleared, and that the new abuse would not be known to the original applicant organisation until it subsequently sought further clearance, up to three years later."

Unless the Chairman of the Council decides otherwise under Standing Order 41.2, the motion should, on being proposed and seconded, be referred without discussion to the Cabinet for consideration and report to the next meeting of the Council.

10. CIIr G Spikins – Attendance At Meetings

Members will know that Cllr G Spikins has been suffering from ill health. He last attended a meeting of the authority on 22 July 2002. Section 85 of the Local Government Act 1972 provides that if a member fails to attend a meeting of the authority throughout a continuous period of six months, he ceases to be a member of the authority, unless the failure was due to some reason approved by the authority.

Cllr Spikins hopes to return to Council duties in the New Year but if he is unable to attend a meeting before 22 January 2003, he shall cease to be a member of the Council, unless the Council approves the reason for his absence.

In view of the circumstances leading to Cllr Spikins' failure to attend meetings, it is

RECOMMENDED:

That the Council approves the failure by Cllr Spikins to attend meetings due to his ill health.

11. Meeting Dates for the 2003/04 Municipal Year

The Council is asked to agree the dates of its meetings for the 2003/04 Municipal Year. Once this has been done, the Cabinet, Regulatory Committees and Panels will be asked to consider their meeting dates for 2003/04 during the January 2003 cycle of meetings.

Historically, the Council has met six times a year (excluding special meetings). Members will recall that in 2002 it was agreed to hold an additional meeting in September. The Council will wish to consider whether to continue that arrangement, or whether to revert to the previous practice of an interval of nearly three months (which includes the main holiday period) between meetings in July and October. If Council decides to continue the September meeting, it may also wish to consider whether the October meeting should be held a little later than in previous years, to equalize the periods between meetings.
