# 7. Political Representation on Committees

In accordance with Section 15(1)(b) of the Local Government and Housing Act 1989, the Council must review the representation of political groups on committees at the annual meeting each year or as soon as practicable thereafter. For this purpose, "committees" includes the Council's Review Panels but excludes the Cabinet.

The Act prescribes, amongst other things, that –

- (a) the majority of seats on committees must be allocated to the majority political group; and
- (b) subject to (a) above, the number of seats on committees allocated to each political group must bear the same proportion as the total of the membership of that group to the membership of the authority;

These provisions need not be applied if a different position is agreed without any member of the authority voting against.

Following the election of Councillors on 1 May 2003, the representation of the two political groups on the Council is:

Conservative 32 Liberal Democrat 27 One Independent member has also been elected but this single member cannot formally constitute a "group" under the provisions Local Government and Housing Act.

The political group leaders have been advised of the numbers of seats allocated to their groups on each Committee and Panel under the principles set out in paragraphs (a) and (b) above. The recommendations for the appointment of members to Committees appearing under item 8 below reflect these principles, with the exception of the appointments to the Leisure Review Panel. The recommendations in respect of the appointments to that Panel may only be brought into effect if no member of the Council votes against.

#### RECOMMENDED:

That appointments be made to committees and panels in accordance with the principles for the allocation of seats to political parties as set out in Section 15 of the Local Government and Housing Act 1989, except in those cases where it is decided without any member voting against, not to apply the principles of proportionality.

## 8. Appointment of Committees and Panels (Report C)

To appoint members as proposed by the political groups.

#### 9. Constitution of Cabinet and Portfolios

In accordance with Standing Order 3.1 to agree:-

- (a) the number of Councillors to be appointed to the Cabinet for the ensuing municipal year (currently there are 8); and
- (b) the number and content of Cabinet Portfolios (the current Portfolios are circulated as Report D to this agenda).
