7. Portfolio Holders' Question Time

8. Notice(s) of Motion

(a) In accordance with Standing order No. 21, Cllr Pemberton will move the following motion:-

"That this Council makes representations to:

- OFWAT to give high priority as part of its funding review to alleviating the problems caused by sewer flooding, and ensure that Southern Water Services and Wessex Water have an adequate level of resources to address this issue; and
- (ii) Southern Water Services and Wessex Water to give high priority to alleviating the sewer flooding problems in the New Forest area".
- (b) In accordance with Standing Order No. 21, Cllr Mrs Robinson will move the following motion:-

"In view of the strong concerns expressed by residents about the risk to human health of the Tetra communications systems, along with the controversy surrounding the scientific evidence on the safety of this system, this Council resolves to refuse requests for permission for the erection of Tetra masts and associated equipment on any land or buildings owned or controlled by the New Forest District Council."

9. Members' Allowances Scheme

The Council is required each year formally to make a scheme of members' allowances. The current scheme provides for the allowances set out in the scheme to be adjusted each year, from a date to be determined by the Council, by the annual increase in the New Forest hourly earnings rate. The annual increase in the hourly earnings rate for 2003 was 9.2% (Office for National Statistics – New Earnings Survey 2003). The Independent Remuneration Panel has agreed with a suggestion by the Portfolio Holder that for 2004/05, the increase in allowances be half the increase in New Forest hourly earnings, i.e. 4.6%. The matter will be reappraised for 2005/06.

RECOMMENDED:

- (a) That the allowances set out in the Scheme of Members' Allowances be increased by 4.6% with effect from the day following the annual meeting of the Council, 18 May 2004;
- (b) That no other changes be made to the Scheme for 2004/05.
