## 44. DECLARATIONS OF INTEREST.

All members declared an interest in Minute 49

Cllr Kendal declared personal interests in Minutes 48 and 50.

Cllrs D Harrison, Rice and Smith declared personal interests in Minute 48.

## 45. MINUTES (PAPER A).

## **RESOLVED:**

That the minutes of the meeting held on 24 October 2005, having been circulated, be signed by the Chairman as a correct record.

### 46. CHAIRMAN'S ANNOUNCEMENTS.

## (a) The Holly and Ivy Charity Christmas Gift Fair

The Chairman was pleased to announce that £1,200 had been raised at his charity Christmas fair at Applemore Health and Leisure Centre on 19 November, 2005.

The Chairman thanked everyone who had supported the event and those who had volunteered their time to help run the event. The Chairman reminded members that he had two more charity events in 2006: The Chairman's Ball on Friday 24 March and the Planthunters Fair on Saturday 6 May.

## (b) National Fitness Industry Award of Excellence

The Chairman was pleased to report that the Council received a special mention and a standing ovation at the National Fitness Industry Awards when our five leisure centres came second in the 'Award of Excellence' and 'Commit to Get Fit'. There had been a 65% increase in the number of people taking part in fitness regimes in the district and this had been achieved through the hard work of employees in the Council's health and leisure centres. Members joined the Chairman in congratulating employees for promoting the work of the centres at a national level, particularly at a time when there was ever increasing competition within the industry.

# (c) Anne-Marie Brown, Duty Manager, New Milton Health and Leisure Centre

The Chairman congratulated Anne-Marie Brown who had used her specialist training in advanced resuscitation techniques to save the life of a local man in New Milton town centre.

## 47. CALSHOT TOILETS - PETITION.

Mr Holmes presented a petition on behalf of the beach hut owners at Calshot Spit.

In presenting the petition, he said that since the announcement of the planned closure of the Spithead toilets at Calshot he had been working with beach hut owners, councillors and visitors to the beach. He was at the Council meeting to demand the retention of that facility at Calshot beach.

He detailed the following points:

- The toilets were built in 1965 when beach huts were added along the
  eastern end of the spit. The Council recognised the need for a toilet
  block at both ends of the beach even though at that time there were
  fewer visitors. A New Forest District Council report in September
  2005 designated the Spithead toilets as high usage.
- In 1999, New Forest District Council planned a single restaurant/toilet complex centrally located.
- This failed, and the site was in-filled with new beach huts which raised significant revenue for New Forest District Council.
- In 2004 New Forest District Council approved plans to replace the Spithead toilets with toilets, a kiosk and showers, keeping Hillhead toilets open as they had been recently re-roofed.
- Difficulties with drainage at Spithead were encountered when seeking environmental permission although options were suggested by the Environment Agency.

In closing his speech , Mr Holmes said that in the space of 8 weeks, New Forest District Council had made a complete about turn, approving new plans to demolish both Spithead and Hillhead and rebuild Hillhead, without adequate consultation or thought of the impact on needs of the disabled, or on safety, or environmental considerations.

In accordance with Standing Order 38 the Chairman did not consider the matter to be urgent and it therefore stood referred to the Cabinet for consideration at their next meeting on 4 January 2006.

## 48. REPORTS OF CABINET.

Cllrs Kendal and D Harrison declared personal interests as a members of Hampshire County Council in so far as they might have related to matters within the Cabinet report. They did not consider their interest in any item affected to be prejudicial. They remained at the meeting took part in the discussion and voted.

Cllr Kendal, the Leader of the Council and the Chairman of the Cabinet, presented the reports of the meetings held on 2 November and 7 December 2005.

Cllrs Rice and Smith declared personal interests in view of their connections with the WRVS. They did not consider their interests to be prejudicial. They remained at the meeting, took part in the discussion and voted.

On the motion that the reports be received and the recommendations adopted it was :

## **RESOLVED:**

That the reports be received and the recommendations adopted.

### 49. STANDARDS COMMITTEE.

All members present declared personal interests in item 1 of this report (Members' Allowances 2006/07). They did not feel their interest was prejudicial, as the subject matter related to an exemption specified in the District Council's Code of Conduct.

Cllr Hutchins, the Chairman of the Standards Committee presented the report of the meeting held on 25 November 2005. In moving the report the Chairman proposed the following amendment:

Members' Allowances 2006/07 to 2009/10 – Report of Independent Remuneration Panel - Additional recommendation (vii):-

That paragraph 3 of the members' Allowances Scheme be amended to read:-

"That a Councillor may receive only one Special Responsibility Allowance (SRA) at any one time.

NB This does not apply to the SRAs expressed as session rates being paid for attending meetings of the Licensing Sub-Committee hearing applications under the Licensing Act 2003"

A member said that although he agreed entirely that extra payments should be made to members of the Licensing Committee he felt that the payments should be made for the hard work that those members had undertaken, rather than for any extra responsibility that they had taken on. Another member said that whilst commending the work of the Licensing Committee he did not agree with the recommendation of the Independent Remuneration Panel. He felt that other councillors took on equally important work as a matter of course and that this special responsibility allowance would set a precedent for a two tier payment system.

Other members were of the view that the Independent Remuneration Panel had taken into account the differing workloads of members and had specifically felt that members sitting on the Licensing Sub- Committee had a higher level of responsibility than others.

Members noted that when coming to a decision on applications that came before the Sub-Committee, the Sub-Committee had to come to a view without officers' advice and, if necessary, to personally defend those decisions in court.

On the motion that the report be received and the recommendations adopted it was :

## **RESOLVED:**

That the report be received and the recommendations adopted.

## 50. PORTFOLIO HOLDERS' QUESTION TIME.

Cllr Kendal declared a personal interest in Question No. 1 in that he was a member of the National Park Authority. He did not consider his interest to be prejudicial and remained at the meeting.

**Question No. 1 from:** Cllr Dunsdon to Cllr Thierry (Environment Portfolio Holder)

"Following on from the Calshot Toilets – Petition, if the Cabinet will not reverse its decision to close the Spithead Public Toilets at Calshot on 31 March 2006, will the Executive Member give a commitment that these toilets will not be demolished until all avenues for funding them are explored, e.g. discussing funding with the National Park Authority and other Agencies?"

#### Answer:

The current policy in respect of de-commissioned toilets will apply to the Spithead toilet in March 2006. The building will be sealed and all services disconnected. In line with other redundant toilet buildings the further use of the block will be evaluated. It could mean that the block might be used for other purposes or the final decision taken to demolish. However, that is a lengthy process, which will give adequate time for the discussions the member seeks. The National Park Authority have indicated that they may be prepared to consider facilities at Calshot at a future date.

In answer to a supplementary question relating to other sources of funding or alternative arrangements, the Portfolio Holder replied that the Council had taken advice from a number of other sources. It was a matter for other agencies to consider if they wished to work in partnership with the Council. Apart from the National Park Authority, discussions were also being undertaken with Calshot Activities Centre.

Question No. 2 from: Cllr Mrs Maynard to Cllr Mrs Holding (Health & Social Inclusion Portfolio Holder)

"Has the Portfolio Holder for Health and Social Inclusion read the letters in the Lymington Times on 19 November from Caroline Harris and D P Hadden saying that putting fluoride in drinking water is illegal?"

### **Answer**

The Portfolio Holder replied that she had seen the recent newspaper letters. In response to a supplementary question she said that the recent European Directive on Medicine indicated that it was not necessarily linked to fluoridation. Bournemouth and West Hampshire Water had been adding

fluoride to the water supply for over 30 years. The Water Supply Fluoridation Regulations 2005 regulated the matter. If the European Union therefore considered fluoride to be a medicine that may be a contrary view to the Government.

Question No. 3 from: Cllr Hale to Cllr Heron (Economy & Planning

Portfolio Holder)

"Could the Portfolio Holder please briefly outline his strategy to provide a top quality development control service to local residents?"

### Answer:

The Portfolio Holder replied that the Council continued to invest heavily in ICT to enable fast and effective processing of planning applications. The Council were looking at establishing ways of joint working with the National Park Authority to provide the best service to customers.

In response to a supplementary question in relation to the allocation of the Planning Delivery Grant budget, the Portfolio Holder said the budget was used to support the planning function across the Council as a whole. Some funding had been directed through the General Fund Revenue budget to support ICT which in turn supported the planning function.

**Question No. 4 from:** Cllr Walmsley to Cllr Heron (Economy & Planning Portfolio Holder)

"I have been asked by a resident of the Oak Park housing estate in Marchwood why it takes so long for the Parish Council to take over the site and perform some much needed maintenance. He has been told that the council cannot do that until the contractor has returned the site to a satisfactory standard. The resident says he has lived there for eight years and has seen no sign of progress or activity. What powers does the Portfolio

Holder have, and what actions can he take, to encourage the contractor to

make the necessary improvements?"

## Answer:

The Portfolio Holder said that the soft landscaping was the last work to be carried out on a development. He acknowledged that there was a backlog of work to be undertaken. However, there was now a dedicated officer in post to deal with the work and considerable progress had been made.

In answer to a supplementary question as to the length of time it would take to complete the works at Oak Park, the Portfolio Holder replied that the work there was progressing well and would be resolved as soon as possible.

Question No. 5 from: Cllr Hale to Cllr Kendal (Policy & Strategy Portfolio

Holder)

"What plans does Councillor Kendal's administration have to better involve the local community in the formation of council policy?"

### Answer:

The Portfolio welcomed the opportunity to respond on this issue. He said that the Council had a good record of providing opportunities of engaging both communities of interest and geographical communities however, the Council could always improve.

Service based involvement enabled users of services to input on an ongoing basis. This was done proactively through seeking comments through surveys, user and focus groups on proposals or through learning from any complaints received. All the Council's Service Plans should now identify details of how they have involved their communities and how the result of that engagement had influenced service delivery.

The Portfolio Holder said that the Council also carried out Corporate Consultation Initiatives. An annual programme of surveys for the Citizens' Panel and Young Peoples' Panel was agreed following input from all members through the Review Panels. Cabinet Question time had also provided several opportunities for communities to meet with Cabinet members.

In a supplementary question Cllr Hale said that some members of the public were still generally suspicious of the Council and would have expressed disappointment had they known that the new parking clocks had been delivered before the Cabinet decision had been made.

The Portfolio Holder said that a public consultation period had run from August – October 2005 on the introduction of the new clock arrangements. Once the main arrangements had been approved by HCC it was only the detail of the scheme that could have changed and therefore the clocks could still have been used. The Cabinet considered every individual objection that was received and the Portfolio Holder was confident that the consultation process had been a full and fair one.

**Question No. 6 from:** Cllr Hale to Cllr Greenfield (Housing Portfolio Holder)

"The Portfolio Holder will remember that at the last Council meeting, during discussions on traffic management issues, I raised the issue of the management of the council's stock of almost 2000 garages. A number of points came out of that not least the contribution these garages should be making to the council's traffic management strategy.

Could Cllr Greenfield say what measures he has taken since the meeting to review the management of the garage stock and when did he put those measures in place?"

In the absence of the Housing Portfolio Holder this question was deferred until the next meeting of the Council.
