# (a) Item 2 - Port of Southampton Master Plan 2009 – Consultation Paper

The Planning and Transportation Portfolio Holder reported that the Department of Transport had now published its draft national ports policy (NPS). The document would have significant bearing on proposals for a Dibden Bay. The closing date of the consultation was 15 February 2010. Local Authorities had also been given the opportunity to send comments to be taken into account by the Transport Select Committee in its own consideration of the NPS. Comments to the Committee had to be submitted by no later than Friday 15 January.

The Planning and Transportation Review Panel would consider the draft policy at their meeting on 20 January. Likewise the Cabinet would also consider this matter at their meeting on 3 February.

In order to pass on the Council's interim comments to the Transport Select Committee before 15 January, the Portfolio Holder would respond on behalf of the Council by way of Portfolio Holder decision.
