## 7. Appointment of Deputy Leader, Number and Content of Portfolios and Appointment of Portfolio Holders

#### 9. Political Representation on Committees

In accordance with Section 15(1)(b) of the Local Government and Housing Act 1989, the Council must review the representation of political groups on committees at the annual meeting each year or as soon as practicable thereafter. For this purpose, "committees" includes the Council's Overview Panels but excludes the Cabinet. The provisions of the Act relating to political proportionality do not apply to the Standards Committee.

The Act prescribes, amongst other things, that -

(a) the majority of seats on committees must be allocated to the majority political group; and

 (b) subject to (a) above, the number of seats on committees allocated to each political group must bear the same proportion as the total of the membership of that group to the membership of the authority;

These provisions need not be applied if a different position is agreed without any member of the authority voting against.

The political representation on the Council following the ordinary election of Councillors on 5 May 2011is as follows:

Conservative 54 Liberal Democrat 6

The political group leaders have been advised of the numbers of seats allocated to their groups on each Committee and Panel under the principles set out in paragraphs (a) and (b) above. Recommendations for the appointment of members to Committees and Panels will be circulated later for consideration under item 10 of this agenda.

#### **RECOMMENDED:**

That appointments be made to committees and panels in accordance with the principles for the allocation of seats to political parties as set out in Section 15 of the Local Government and Housing Act 1989, except in those cases where it is decided without any member voting against, not to apply the principles of proportionality;

#### 10. Appointment of Committees, Panels and Representatives on the National Park Authority (Report C)

- (a) To appoint members to the Committees and Panels set out in Report C, as proposed by the political groups, for the four year period commencing May 2011.
- (b) To appoint four members to the National Park Authority, appointments to which are required urgently.
