Cllr Penwarden took the chair and made the declaration of acceptance of office, which was formally witnessed by the Chief Executive.

Cllr Mrs Wyeth invested the Chairman with the chain and badge of office and presented Mrs Penwarden, the Chairman's consort, with a gift.

The Chairman thanked members of the Council for electing him as Chairman. He felt it an honour to have the opportunity to represent the Council, both within the District and across Hampshire and Dorset. As Chairman, he hoped to promote the Council's successes and to learn from other councils their solutions to common problems, which would be of benefit to this Council.
