PORTFOLIO HOLDER DECISION - ENVIRONMENT PORTFOLIO

MIXED GLASS COLLECTION

1. INTRODUCTION

- 1.1 New Forest District Council collects glass bottles and jars from more than 100 public recycling centres plus about 80 trade customers. Glass is collected as three separate colours clear, green and brown. Most of the glass collected by the Council is delivered to the Recresco glass reprocessing depot at Southampton Docks. Because of changes to the reprocessing arrangements at Recresco it is now possible for the Council to collected mixed glass.
- 1.2 Recresco are now better equipped to deal with mixed glass. The mixed glass is mechanically sorted at Southampton Docks into the three constituent colours clear, green and brown and is delivered to glass manufacturers in the UK and Ireland to be made into new bottles and jars.

2. MIXED GLASS COLLECTION

- 2.1 The collection of mixed glass was considered by the Environment Review Panel on 10 September 2009 (minute ref.25). The recommendation of the Environment Review Panel was that the Environment Portfolio Holder be advised that, following a critical evaluation of the costs and benefits of changing to a mixed colour glass collection service, the Panel has concluded that there are financial and environmental benefits to be gained from such a change. Accordingly, the Panel would advocate the introduction of mixed colour glass collection, as soon as possible, together with the consequent amendments to collection arrangements.
- 2.2 The collection of mixed glass will have a number of advantages. It will be more straightforward for the public to be able to put all their clear, green and brown glass into one recycling container. The Council will be able to make efficiency savings by collecting all colours of glass together with reductions in vehicle mileage and fuel costs. It will be possible to provide additional local sites for glass recycling in urban areas because it will only be necessary to have one mixed glass container at each site, instead of three one for clear glass, one for green glass and one for brown glass.
- 2.3 By delivering mixed glass to the reprocessing site, the Council will receive approximately £5 per tonne less from Recresco. Amendments to collection routes, however, mean that all the glass collected by the Council would be able to be taken to Recresco and attract an income, whereas as present, glass collected in the west of the District is taken to Hurn, with no financial return. In addition, it is anticipated that the revised arrangements will mean that glass which is currently collected by an external contractor will be able to be brought in house. It is therefore anticipated that the efficiency savings made by switching to mixed glass collections and the greater tonnages that will be taken to Recresco will more than compensate for the reduction in income per tonne. Long term improvements in the market for recycled glass mean that that there is a secure outlet for mixed glass and that all the mixed glass collected by the Council will be colour sorted and used to make new glass containers.

3. ALTERNATIVES CONSIDERED

3.1 The alternative to collection of mixed glass would be to continue to collect glass in three separate colours. The Council would then miss the opportunity to make efficiency savings and achieve environmental benefits by switching to mixed glass collection.
