## **CHRISTMAS REFUSE COLLECTION ARRANGEMENTS 2010/11**

#### 1. CHRISTMAS REFUSE COLLECTION

1.1 The Portfolio Holder for the Environment proposes to revise the refuse collection arrangements for Christmas 2010 and New Year 2011 in order to accommodate Public Holidays on Monday 27 December 2010 and Tuesday 28 December 2010. The proposed refuse collection arrangements are as follows:

Saturday 25 December 2010	No Collection
Sunday 26 December 2010	No Collection
Monday 27 December 2010	No Collection
Tuesday 28 December 2010	No Collection
Wednesday 29 December 2010	Normal WEDNESDAY Collection
Thursday 30 December 2010	Normal THURSDAY Collection
Friday 31 December 2010	Normal FRIDAY Collection
Saturday 1 January 2011	No Collection
Sunday 2 January 2011	No Collection
Monday 3 January 2011	Double MONDAY collection
Tuesday 4 January 2011	Double TUESDAY collection

1.2 These proposed arrangements will have the following effect:

REFUSE COLLECTION DAY	REVISED ARRANGEMENTS
MONDAY	No collection on 27 December. Double collection on Monday 3 January.
TUESDAY	No collection on 28 December. Double collection on Tuesday 4 January.
WEDNESDAY	No Change.
THURSDAY	No Change.
FRIDAY	No Change.

- 1.3 The revised refuse collection arrangements for Christmas 2010 have been agreed with Trade Union representatives. There is an additional holiday for New Forest District Council staff on Wednesday 29 December, but the Council's refuse collectors have agreed to work on that day and will receive a day off in lieu at a later time.
- 1.4 To minimise disruption, staff have also agreed to work on Monday 3<sup>rd</sup> January 2011 which is a Bank Holiday

#### 2. REASON

2.1 Although Christmas Day 2010 falls on a Saturday and Boxing Day 2010 falls on a Sunday, there are Public Holidays on Monday 27 December and Tuesday 28 December 2010. It would be unreasonable to expect the Council's refuse collectors to work on these two public holidays. The proposed revised refuse collection arrangements will inconvenience some New Forest residents but disruption to services at Christmas time is inevitable. These revised arrangements minimise disruption and allow the refuse collection service to get back to normal as quickly as possible.

## 3. ALTERNATIVES CONSIDERED

- 3.1 Another alternative which has been considered would be to collect refuse on 27
  December and 28 December which are Public Holldays. This would require overtime payments to staff. There would be practical difficulties in providing a refuse collection service on these Public Holldays, such as missed collections, problems gaining access to residential areas, noise and disturbance. Refuse collection could only be provided on Public Holldays if Hampshire County Council agreed to open the waste disposal sites.
- 3.2 In previous years staff have worked on the Saturday between Christmas and New Year, but due to New Years Day falling on the Saturday it has been decided that this option is not available to us this year as the disposal points will be closed.
