GENERAL PURPOSES AND LICENSING COMMITTEE – 16 MARCH 2007

GAMBLING ACT 2005 – DEMOCRATIC PROCESS

1. INTRODUCTION

1.1 This report proposes changes to the Licensing Sub-Committee's Terms of Reference and proposes delegation of powers to officers in order to facilitate decision-making under the Gambling Act 2005.

2. TERMS OF REFERENCE OF THE SUB-COMMITTEE

- 2.1 Members will be familiar with the current procedures for arranging hearings of the Licensing Sub-Committee, the Sub-Committee will continue to hold hearings in respect of the Licensing Act 2003 as well hearings under the Gambling Act 2005. It is proposed that the terms of reference for the Licensing Sub-Committee be amended to reflect the requirements under the Gambling Act 2005 as set out in Appendix 1 to this report. (Proposed additions are shown in bold italic print).
- 2.2 The Proceedings of Licensing Committees and Sub-Committees in relation to the Gambling Act 2005 have now been published and there are marginal differences between these regulations and those of the Licensing Act 2003. These differences include allowing the Local Authority greater flexibility in timescales when fixing dates for hearings. In order to facilitate hearings under the Gambling Act 2005, it is proposed that the Committee agree the adoption of the hearing procedures currently used under liquor licensing and allow the Head of Democratic Services authority to make appropriate changes to these procedures.

3. DELEGATIONS TO OFFICERS

3.1 Proposed delegations to officers under the Gambling Act 2005 are attached at Appendix 2 to this report. While it is clear from the legislation that the Committee has the power to approve those delegations relating specifically to Parts 8 and 9 of the Act, (which are the majority), it appears that full Council may need to approve a few of the proposed delegations.

4. ENVIRONMENTAL IMPLICATIONS

4.1 There are no environmental implications arising from this report.

5. FINANCIAL IMPLICATIONS

5.1 There are no financial implications arising from this report.

6. CRIME AND DISORDER IMPLICATIONS

6.1 There are no crime and disorder implications arising from this report.

7. EQUALITY AND DIVERSITY IMPLICATIONS

7.1 The Council's Statement of Gambling Principles addresses any impact the functions of the Gambling Act might have, on the Council's residents, customers and employees by reference to their disability, age, gender, religion and beliefs, sexuality and race.

8. **RECOMMENDATIONS**

- 8.1 That the amendments to the Licensing Sub-Committee's Terms of Reference as set out in Appendix 1 to this report be approved;
- 8.2 That the Head of Legal and Democratic Services be authorised to prepare a procedure for hearings under the Gambling Act 2005 before the Licensing Sub-Committee in consultation with the Chairman of the General Purposes and Licensing Committee and the Opposition Group Spokesperson; and
- 8.3 That , the Committee approve the delegation of powers to officers listed at Appendix 2 to this report, in respect of those functions delegated to the Committee by law under Parts 8 & 9 of the Act;
- 8.4 That, it be recommended to the Council that the delegation of powers to officers listed at Appendix 2 to this report be approved in respect of those functions that are for the Licensing Authority, but are not delegated to the Committee by law under Parts 8 & 9 of the Act.

APPENDIX 1

LICENSING SUB-COMMITTEE

Councillors:

Any 3 members of the General Purposes and Licensing Committee, as determined by the Head of Legal and Democratic Services

Terms of Reference:

- 1. To conduct hearings where these are required under the Licensing Act 2003 *and Gambling Act 2005* and make determinations accordingly.
- 2. To make determinations where a hearing would have been necessary but for the fact that all interested parties have agreed that a hearing is unnecessary.
- Where officers are unable or feel it is inappropriate to make a decision under their delegated powers, to determine any matter under the Licensing Act 2003 and Gambling Act 2005 and any matter relating to the licensing, registration and public rights of way functions in the Local Authorities (Functions and Responsibilities) (England) Regulations 2000.
- 4. To consider whether to make representations on matters arising under the Licensing Act 2003 *and Gambling Act 2005* where the Council is a consultee and not the authority making the determination.
