## POLLING DISTRICTS AND POLLING PLACES REVIEW

## 1. INTRODUCTION

1.1 The Committee will recall that the Electoral Administration Act 2006 introduced a requirement for all electoral registration authorities to undertake a review of the polling districts and polling places in their areas by 31 December 2007, and at four-yearly intervals thereafter.
1.2 The designation of polling districts is a matter for the Council, while polling places are a matter for the Executive. The Council has delegated authority to this Committee to undertake the review of polling districts and to agree any changes that it considers advisable. The Committee at its meeting on 14 September 2007 appointed a Working Party to consider representations received in response to the review, and to make recommendations to the Committee. This report contains the Working Party's recommendations.
1.3 The Cabinet on 7 November agreed to continue with this Authority's previous practice of designating the whole of each of the polling districts as the polling place for that district. Designation of the individual polling stations therefore remains a matter for the Returning Officer for the elections. The Returning Officer has invited comments on individual polling stations as part of the review.
1.4 It is hoped that the Committee will be able to agree any changes it wishes to make to polling districts at this meeting, to enable the revised register of electors published on 1 December 2007 to incorporate those changes. Recommendations on polling stations will be forwarded to the Returning Officer.

## 2. BACKGROUND

2.1 Information relating to the review was published on the Council's website. All councillors, parish and town councils, political parties and disability groups were consulted. Particular views were sought on those polling stations that are little used and where costs per elector are high. These are set out in Appendix 1 to this report.
2.2 In undertaking the review, authorities are required to bear in mind that, under the provisions of the Representation of the People Act 1983 (as amended), Councils must seek to ensure that:
(a) all electors have such reasonable facilities for voting as are practicable in the circumstances; and
(b) as far as is reasonable and practicable, every polling place is accessible to electors who are disabled.
(c) the polling place for a polling district must be within the area of the polling district unless special circumstances make it desirable to designate an areas either wholly or partly outside the polling district.

## 3. ISSUES FOR THE COMMITTEE'S CONSIDERATION

3.1 A schedule showing the representations received in response to the consultations is attached at Appendix 2. These were considered at a meeting of the Working Party on 15 October 2007. At that meeting, officers were asked to undertake further investigation into some of the representations received, and there was further consideration of these issues a second meeting of the Working Party on 8 November. A synopsis of the issues considered by the Working Party, together with detailed recommendations for change, are set out below. Maps of the proposals will be available at the meeting.:

### 3.1.1. Furzedown and Hardley Ward <br> FI polling district - Fountain Court Hotel Polling Station

Representations were received from Hythe and Dibden Parish Council regarding the disabled access this polling station. The polling station is a function room within the hotel and there is direct access from outside via a number of steps. Disabled access is through the public areas of the hotel and disabled voters have to make their way through these public areas to reach the polling station.

The hotel was approached to explore whether it was possible to locate the polling station closer to the disabled access. Unfortunately, while the hotel would like to be of assistance, there are no private rooms in closer proximity to the disabled access. There are no other suitable alternative venues within the polling district for use as a polling station, and the Working Party therefore

## RECOMMENDS:

That the current arrangements remain, but that the Returning Officer be requested to ensure that the disabled access is clearly marked when future elections are held.

### 3.1.2 Hythe West and Langdown Ward HK, HL \& HM Polling Districts - Waterside Primary School, Hythe \& Dibden Community Centre, and proposed new polling station at The Grove, St John's Street <br> Dibden and Hythe East Ward (part) HI Polling District - Hythe \& Dibden Community Centre

Repesentations were received from Hythe and Dibden Parish Council that the Waterside Primary School is not in a logical or convenient place for all HK voters within Hythe West and Langdown Ward. Voters to the north of the ward naturally gravitate to the shopping areas immediately to the east, rather than south to their current polling station at the Waterside Primary School. Similarly, the Working Party heard that HM voters had also expressed a preference to vote closer to the centre of town, rather than at the Waterside Primary School.

Following discussions with representatives of the Parish Council, the Working Party

## RECOMMENDS:

(a) That it be recommended to the Returning Officer that a new polling station be established at Parish Council offices at The Grove, St John's Street (this polling station is within Dibden \& Hythe East ward);
(b) That a new polling district be created for those voters (approximatey 258) north of the railway line in HK polling district and, because of the special circumstances that apply, that it be recommended to the Returning Officer that these voters be assigned to The Grove;
(c) That it be recommended to the Returning Officer that HI voters (approximately 1340) in Dibden \& Hythe East Ward be reassigned to The Grove from the Community Centre;
(d) That it be recommended to the Returning Officer that, because of the special circumstances that apply, HL (approximately1670) and HM (approximately 1737) voters (in Hythe West \& Langdown ward) be assigned to the Community Centre within Dibden \& Hythe East Ward. (These recommendations will leave approximately 1402 HK (Hythe West \& Langdown) voters at Waterside Primary School which is within the ward.

### 3.1.3 Fawley, Blackfield \& Langley Ward (part) Blackfield Baptist Church and proposed new polling station at St Francis Church Hall, Langley

The polling station at Blackfield Baptist Church is within Holbury \& North Blackfield Ward and serves FE voters (approximately 1104) from that ward. It also serves FC (approximately 1437) and FD (approximately 1836) voters from Fawley, Blackfield and Langley Ward. This polling station is extremely busy at peak times but until now no suitable alternative polling stations have been put forward.

Cllr Dunsdon has suggested that a new polling station be created at St Francis Church Hall, West Common, Langley. The Working Party fully supports this recommendation. Cllr Dunsdon has suggested that voters to the south of FD polling district be assigned to this proposed new polling station, while those to the north of the polling district continue to vote at Blackfield Baptist. His request is supported by the Fawley Parish Council. Both local members for the ward, Cllrs McEvoy and Wappet, favour reassigning all FD voters to the St Francis Church Hall and the Working Party supports this view.

### 3.1.4 Holbury \& North Blackfield Ward (part) <br> Blackfield Baptist Church and request for new polling station at Blackfield Neighbourhood Centre

Cllr Dunsdon has requested the creation of a new polling station at the Blackfield Neighbourhood Centre, to serve part of FE polling district approximately 789 voters in Heather Road and adjoining roads. He has suggested that the remaining approximately 330 FE voters continue to vote at the Blackfield Baptist Church Hall. This would mean creating a new polling
district for those voters. Cllr Dunsdon's request is supported by the Fawley Parish Council.

The Working Party does not support this recommendation. It considers that the Holbury \& North Blackfield Ward is adequately served by three polling stations - the Blackfield Baptist Church Hall, the Good Shepherd Church Hall and the Waterside Theatre. It appreciates that Cllr Dunsdon's request arises from a wish to encourage turnout in the Heather Road area, but convenience to voters has to be balanced against cost and in this case the Working Party considers that an additional polling station in close proximity to a well-used and well-known facility at Blackfield Baptist Church cannot be justified.

## RECOMMENDATION:

(a) That it be recommended to the Returning Officer that a new polling station be created at St Francis Church Hall, West Common, Langley and that the whole of FD polling district (approximately 1851 electors) be assigned to that polling station; and
(b) That no other changes to the polling arrangements in Fawley parish be made.

### 3.1.5 Totton East Ward

TC, TD and TE Polling Districts - Oakfield Primary School, The Salmon Leap, Totton \& Eling Community Centre and proposed new polling station at Testwood Baptist Church, Salisbury Road

An approach was received from the Testwood Baptist Church, which is at present undergoing substantial extensions and renovations, to use the Church premises as a polling station instead of Oakfield Primary School. The premises have been inspected and are ideal. The Working Party favours this change as it is acknowledged that use of schools as polling stations is a considerable inconvenience to the schools and every effort is made to avoid using school premises where this is possible.

Cllr Weeks has furthermore suggested that use of the Salmon Leap (where TD voters are allocated) be discontinued. He has expressed the view that two polling stations per ward are sufficient in a built-up area such as Totton. He suggested allocating Salmon Leap voters to the Testwood Baptist Church and the Totton \& Eling Community Centre instead. This is supported by local members Cllrs Britton and Lagdon, and by Totton \& Eling Town Council. Cllr David Harrison, County Councillor for the area, would like the Salmon Leap retained as a polling station.

The Working Party supports Cllr Weeks's views.

## RECOMMENDATION:

(a) That it be recommended to the Returning Officer -

[^0](ii) That use of the Oakfield Primary School and the Salmon Leap, be discontinued;
(iii) That TC (approximately 1982) voters be reassigned from the Oakfield primary school to the Testwood Baptist Church
(b) That TC polling district be extended to encompass all properties north and west of 103 Testwood Lane (935 Voters) currently in TD polling district, and that it be recommended to the Returning Officer that these voters be reassigned to the Testwood Baptist Church; and
(c) That TE polling district be extended to encompass all properties south and east of 101 Testwood Lane (360 Voters) currently in TD polling district and that it be recommended to the Returning Officer that these voters be reassigned to the Totton \& Eling Community Centre.

### 3.1.6 Totton North Ward

TF, TG \& TH Polling Districts- Calmore Village Hall and Calmore Community Centre ( 2 polling stations at Community Centre)

Cllr Weeks has proposed that use of Calmore Village Hall for Totton North voters be discontinued and that all Totton North voters be assigned to Calmore Community Centre. Cllr Weeks pointed out that he polling station is not well used by Totton North voters and expressed the view that many would prefer to travel to the Calmore Community Centre rather than the Village Hall. The proposal was supported by the Totton \& Eling Town Council.

The Working Party favours this suggestion and has noted that the Village Hall is far from ideal as a polling station as it is situated on a narrow, unlit, road with very limited parking facilities. The Village Hall is also used as a polling station for NA voters in the Ashurst, Copythorne North and Netley Marsh ward and attempts to find an alternative polling station to serve those voters will continue.

## RECOMMENDATION:

(a) That it be recommended to the Returning Officer that use of the Calmore Village Hall as a polling station for Totton North ward be discontinued and that all Totton North voters be assigned to two polling stations at the Calmore Community Centre;
(b) That that part of TF polling district west and south of Calmore Drive (235 electors) be combined with TG polling district; and
(c) That that part of TF polling district east and north of Calmore Drive (767 electors) be combined with TH polling district.

### 3.1.7 Pennington Ward

LF, LG \& LH Polling Districts - Pennington WI Hall and proposed polling station at Lymington Health \& Leisure Centre

All voters in Pennington ward vote at two polling stations at the Pennington WI Hall. In 2003 there was a polling station at Priestlands School but this proved unsatisfactory and it was discontinued.

Town Cllr Mrs Vernon-Jackson has pointed out that the WI Hall is situated too far north in the ward to be convenient to all voters. She has suggested use of the Lymington Health \& Leisure Centre as an alternative or additional polling station. The Centre Manager would welcome a polling station at the Centre. The Working Party recommends that an additional polling station be created at the Centre. This would bring the number of premises used as polling stations in the ward to two. The proposal is supported by Cllr Hickman, one of the District Councillors for the ward.

## RECOMMENDATION:

That it be recommended to the Returning Officer that a new polling station be created at Lymington Health \& Leisure, and that LG (approximately 2037) and LH (approximately 772) voters be assigned to this polling station
(This recommendation would leave 1904 LF electors voting at the Pennington WI Hall)

### 3.1.8 Polling Stations with Low Usage

Those polling stations that have low usage are set out in Appendix 1. The Working Party has reviewed these in the light of the criteria set out in paragraph 2.2 above.

The Working Party is concerned at the high cost per vote cast at some of these polling stations, but recognises that they serve distinct communities or parts of communities, and, in percentage terms, are fairly well-used. The exception is the Fritham Free Church, but turnout at that polling station was undoubtedly affected by the fact that the elections due on 3 May was countermanded following the death of one of the candidates. The election was re-run on 14 June and turnout on that date was lower than on 3 May.

On balance, the Working Party considers that the position with regard to these polling stations should be reassessed following the next Parliamentary election, when a fairer reflection of turnout at each may be gauged.

## RECOMMENDATION:

That continued use of the polling stations set out in Appendix 1 be reassessed following the next Parliamentary election.

## 4. ENVIRONMENTAL, CRIME \& DISORDER AND EQUALITY \& DIVERSITY IMPLICATIONS

4.1 Locating polling stations within, or as close as possible to the centre of the catchment area for that polling station reduces distances voters have to travel. The Working Party has had regard to this in putting forward recommendations for polling stations, but, in some cases, has had to weigh up environmental considerations against cost. Also, premises suitable for use as polling stations are not always ideally located for the catchment area.
4.2 There are no crime and disorder implications.
4.3 Disability and Equality groups were consulted at the outset of the review and no issues were raised. The Working Party has been mindful of the need to identify accessible premises for use as polling stations and has tried to do this in formulating all its recommendations but unfortunately in some cases fully accessible premises are not available.
5. FINANCIAL IMPLICATIONS
5.1 The recommendations appearing above should be cost-neutral - two additional polling stations are recommended but two are recommended for closure. The cost of the review will be in the region of $£ 2,000$ (mainly in the production of maps, postage and other documents for public inspection), excluding officer time.

## 6. RECOMMENDATION:

6.1 That the recommendations in paragraph 3 be agreed.
