

GENERAL PURPOSES AND LICENSING COMMITTEE - 10 SEPTEMBER 2010

REVIEW OF POLLING DISTRICTS AND POLLING PLACES

1. INTRODUCTION

- 1.1 This report requests the Committee to consider the following three issues:—
 - (a) whether to commence the next general review of polling districts and polling places in the District in advance of the timetable required by legislation;
 - (b) the continued use of the smaller polling stations in the District. The Committee in 2007 asked to review these following the next Parliamentary election.
 - (c) the allocation of voters to The Grove, St John's Street, and the Community Centre, Brinton Lane, in Hythe.
- 1.2 If the Committee is minded to make a change to (c), a decision is needed soon so that any changes that might be necessary to the polling district may be reflected in the revised version of the register to be published on 1 December 2010.
- 1.3 For the information of members, the following are responsible for polling districts, polling places and polling stations which are elements dealt with in this report:
 - The designation of polling districts (a geographical subdivision of an electoral area, such as a parliamentary constituency or a district ward), usually known by distinctive letters such as LA, RD, etc, is a matter for the Council (on the recommendation of this Committee).
 - The designation of polling places (the geographical area in which a polling station is situated) is a matter for the Cabinet. The Cabinet on 7 November 2007 decided that the whole of a polling district be designated as the polling place.
 - The designation of polling stations (the buildings where polling takes place) is a matter for the Returning Officer
- 1.4 Polling districts, polling places and polling stations are interlinked. Adjustments to any one will often affect the others.

2. GENERAL REVIEW OF POLLING DISTRICTS AND POLLING PLACES

2.1 The Electoral Administration Act 2006 introduced a duty on all local authorities in Great Britain to review their polling districts and polling places at least once every four years. The first review under the Act had to be completed by the end of 2007. This Council completed its review in November 2007, so the law requires the next review to be completed by the end of 2011.

- 2.2 Notwithstanding the legal requirements, the Electoral Commission has strongly recommended that all local authorities take immediate steps to begin the process of conducting their next general reviews of polling districts and polling places. Their recommendation arises as a result of problems encountered in some areas at the May 2010 elections. These problems related to:
 - Unsuitable premises used as polling stations
 - Inadequate polling stations for the number of electors allocated to them
 - Insufficient pre-planning and risk management of the numerous processes involved with an election
 - Mistakes in poll cards and postal vote packs
 - Mistakes in ballot papers
- 2.3 The Commission wishes the review of polling stations expedited to ensure that any issues arising from unsuitable polling stations, or inappropriate allocation of voters to polling stations, are dealt with expeditiously.
- 2.4 None of the problems outlined by the Commission occurred in this District at the May 2010 elections. However, this is no reason to be complacent. The planning and management of an election is now a major logistical task. The election in May 2011 is likely to be the most challenging yet, with scheduled District and Parish quadrennial elections and the referendum on the alternative voting system planned for the same day. It remains to be seen whether there will be a higher turnout than is normal for local elections because of the combination with the referendum, but it is clear that many voters will require assistance and guidance at the polling stations, and most will take longer to vote. It is very important therefore that polling stations are adequate but ideal premises are not always available.
- 2.5 Two elections have taken place since changes arising from the 2007 polling districts/places review were implemented. Most changes appear to have been well received, or have not elicited complaints, but there is an issue with the allocation of voters to The Grove (the Hythe and Dibden Parish Council's offices, shared with NFDC local information office) and the Community Centre in Brinton Lane, Hythe. This issue is dealt with in paragraph 4.
- 2.6 The Returning Officer does not have power to "requisition" buildings other than schools for use as polling stations and has to rely on the goodwill of the owners of premises to make them available. Some polling stations in the District are not ideal but most are adequate. Feedback from polling station staff and polling station inspectors at the May 2010 election has not revealed any major difficulties but a review with wider input might result in some improvements.
- 2.7 Because a general review involves a significant degree of consultation, it is suggested that the review commences soon. When the 2007 review was undertaken the Committee appointed a Working Group to examine issues in detail and to make recommendations to the Committee. The Committee is requested to consider whether it wishes to follow a similar process for the proposed review.

3. LOW USAGE POLLING STATIONS

3.1 The Committee will recall that, as part of the 2007 review, it was decided to reassess the continued use of the six smallest (in terms of voters allocated) polling stations following the next Parliamentary election. This was on the basis that a fairer reflection of the turnout at each could be gauged after a Parliamentary election.

- 3.2 Attached at Appendix 1 is a schedule showing the turnout at all polling stations in the District at the May elections, together with the direct costs (polling station hire and staffing costs) of each. The smaller polling stations identified for further review are shaded.
- 3.3 In the light of the recommendation that the general review of polling stations and polling places commences earlier than anticipated, it is suggested that the low use polling stations form part of the wider review.

4. ALLOCATION OF VOTERS TO THE GROVE AND THE COMMUNITY CENTRE, HYTHE

4.1 Following representations from Hythe and Dibden Parish Council and local members that voters from the Hythe West and Langdown Ward (HK, HL and HM polling districts) would prefer to vote closer to the centre of Hythe than at the Waterside Primary School, one of the decisions from the 2007 review was to allocate voters in the Dibden & Hythe East and Hythe West & Langdown Wards to the following polling stations:

4.2 Amongst other things, this meant the reallocation of HI voters (Dibiden & Hythe East) from the Community Centre in Brinton Lane (in Dibden & Hythe East Ward) to The Grove, and the reallocation of HL and HM voters (Hythe West & Langdown) to the Community Centre. Legislation requires that voters must vote at a polling station within their polling district, unless special circumstances can be demonstrated. In recommending the change, the Committee expressed the view that special circumstances existed to justify HL and HM electors voting at a polling station not within their polling district.

- 4.3 Following both the 2009 (European Parliamentary and County) and 2010 (Parliamentary) elections, a few complaints were received from HI voters that they now had to vote at a polling station further from their homes than previously. Most of these complaints came from residents of Ewart Court (a sheltered housing complex located very close to the Community Centre) some of whom find it difficult to walk the longer distance to The Grove. The complaints were mainly by telephone and were not recorded, but approximately 5 were received on each occasion. It is understood that dissatisfaction at the new arrangements was also expressed to polling station staff and to tellers at The Grove. The Hythe & Dibden Parish Council has asked that the matter be reconsidered before the next election.
- 4.4 Further enquiries have been made of the Community Centre where there are already two polling stations one for HL and one for HM. It appears that it would now be possible to create a third polling station at the Centre. This was not an option before recent improvement works took place. In the circumstances it is suggested that HI voters be allocated back to the Community Centre. A map showing the area is attached at Appendix 2.
- 4.5 Care would have to be exercised with signage and it is likely that an additional member of staff would need to be employed across the three polling stations to direct voters to the correct station. Additional costs would probably be in the region of £150.

5. FINANCIAL IMPLICATIONS

- 5.1 Creation of a Working Party to oversee the proposed review would mean additional member travel and printing costs, but these are likely to be minimal. Officer time will be spent on the review but because of the legal requirement for a review to be completed by the end of 2011, would have to be incurred anyway. The recommendation brings forward the dedication of that officer time.
- 5.2 Reallocation of HI voters back to the Community Centre at Hythe will mean slightly increased costs at elections.

6. ENVIRONMENTAL, CRIME & DISORDER AND EQUALITIES & DIVERSITY IMPLICATIONS

6.1 Siting polling stations close to centres of population reduces the need to travel to polling stations by car and should be borne in mind when the review is undertaken. There are no crime and disorder implications. Ensuring equal access for all is also an important consideration when considering polling stations and will be taken into account.

7. RECOMMENDATIONS

- 7.1 That a general review of polling districts and polling places commence before the end of 2010, and that a Working Party be established to oversee the review and to make recommendations to the Committee.
- 7.2 That the review includes the continued use of the smaller polling stations in the District.
- 7.3 That the Committee determines the size and political composition of the Working Party and appoints members to serve on the Working Party.

7.4 That the terms of reference of the Working Party be:

To oversee the review of the polling districts and polling places in New Forest District under Section 16 of the Electoral Administration Act 2006 and to make recommendations to the General Purposes and Licensing Committee.

7.5 That it be recommended to the Returning Officer that HI voters be reallocated to the Community Centre in Brinton Lane, Hythe.
