## 3. MINUTES.

#### **RESOLVED:**

### 4. DECLARATIONS OF INTEREST.

No declarations of interest were made by members in connection with an agenda item.

# 5. PUBLIC PARTICIPATION.

There was none.

### 6. CHAIRMAN'S ANNOUNCEMENTS.

The Chairman announced that a by election would be held in the Milford ward in July following Cllr Pemberton's resignation from the Council. The Police and Crime Commissioner elections would be held on 15 November.

## 7. HEALTH AND SAFETY INTERVENTION PLAN FOR 2012/13 (REPORT A).

The Committee considered the proposed Health and Safety Intervention Plan for the coming year. The plan reviewed the work of the service for the previous year and proposed a full range of work for the year ahead.

Members considered the various aspects of the plan in detail including the risk based approach. This meant that the service would allocate more officer time to high risk businesses and service requests. It was confirmed that this would not impact on the comprehensive programme of inspections relating to food hygiene.

The current levels of staffing within the service were considered appropriate and the planned work for 2012/13 was based on these levels.

Members were informed that as of April 2012 RIDDOR's (Reporting of Injuries, Diseases and Dangerous Occurrences Regulations 1995) over-three-day injury reporting requirement had changed. The trigger point had increased from over three days' to over seven days' incapacitation. This would mean that the Service would receive fewer reports of injuries but it might not reduce overall workload.

Discussion ensued regarding the proper and safe storage of building materials at residential properties and the most effective way to raise public awareness of tick bites and Lyme disease.

Mr Stone was congratulated on the comprehensive report.

## 8. PRESENTATION ON THE CHANGES TO THE LICENSING ACT 2003.
