# COMMUNITY ALARM AND TELECARE FEES AND CHARGES

### 1. INTRODUCTION

1.1 As part of the review of the Community Alarms Service, a Portfolio holder decision is needed to make amendments to the current fees and charges structure for community alarms for the 2014/15 financial year.

## 2. BACKGROUND

- 2.1 There are two main elements to the pricing changes. Last year's council decision to combine the CCTV and Community Alarm services included suggested initial changes to the pricing structure, including charging for additional equipment and installation fees. These charges have been reviewed and considered as part of the review of the service. The proposed amended fees and charges are attached as Appendix 1.
- 2.2 The second element relates to weekly charges for the rental, monitoring and maintenance of all community alarm equipment. The weekly charges were not increased in 2013 and recent market analysis shows us to be at the lower end in terms of price comparison.

# 3. POLICY CONSIDERATIONS

3.1 The decision over fees and charges has to be made within the constraints of the overall financial framework and the medium term financial plan. At the same time decision making regarding these charges needs to be made to reflect a "commercial" environment where there is a need to react swiftly and proactively to changing market conditions. As a result the power to agree fees and charges or to make formal arrangements for the setting of fees and charges within a Portfolio is delegated to the Portfolio Holder.

The pricing chart shown in Appendix 1 shows a weekly charge for peripheral telecare. This fee is calculated by recouping the cost of the equipment to NFDC within one year by charging the relevant rate to the customer weekly. It would be beneficial to the service if this pricing policy was recognised as sufficient across the board, meaning any new equipment that is provided has a clear pricing point upon introduction, subject to consultation with the Portfolio Holder.

# 4 CONSULTATION UNDERTAKEN

4.1 The Head of Service has implemented consultation procedures as appropriate for the various fees and charges applicable and the Portfolio Holder, in making the final decision, will have due regard to any issues which have emerged from consultation. In this case some market comparison has been undertaken.

### 5. FINANCIAL IMPLICATIONS

5.1 The introduction of a formula when pricing new products will allow the service to respond quickly to innovation and new products in the market place.

5.2 Any financial implications have been or will be reported as part of the ongoing Portfolio Plan and budgetary control process. These charges will be agreed with the Portfolio Holder on a regular basis during the year to meet the needs of the service and to make them competitive in the changing market.
