Moreover, there are no noise controls specified in the application to control this activity and following a site visit to the premise on the 14th June there are no noise polices at the premises.

I have discussed the licensing application with the licensee Deborah Beecher.

The police have some concern about the closing time of the pub being 0030 Mon-Sunday, however we are not planning t object to the proposed hours at this time.

We are objecting now to the list of non standard timings listed within section E.. The view of the force solicitor is that requests on this scale are not in the spirit of the act and I have requested that this list be restricted to a maximum of 12 dates.

We have serious concerns about the end time of live music being set at midnight 7 days a week. This pub is situated on residential estate and the potential for noise pollution on residents at a late hour during the week is unacceptable. This w be a matter for EHO assessment and decision by the licensing committee.

The licensee was unwilling to accept an earlier end time to live music on the basis of the decision is one of the company and not her.

We also have concern that the licensee cannot be specific regarding the nature of the intended live music. She would discount the possibility of band performances which obviously has implications for noise control and existing PEL type requirements which the pub does not have now.

I have copied this to Blake Lapthorn solicitors in the hope that they can clarify these points to your dept before the deadlin of 14th June 2005.

Re: The Saxon Pub Calmore

We understand the Saxon Pub in Calmore has applied to extend their opening hours and to increase the number of nights for disco music. We are writing to record our objection to this application.

In actual fact we have recently accepted an offer on our house. Our buyers and all our other viewers specifically asked whether we experienced any problems when customers left the Saxon pub. Generally speaking it has not been too much of a problem but it can be noisy, especially in the summer months. Double glazing helps to cut the noise down but this, of course, means the closure of all windows. We also believe damage occurs to property after 'turn out' time. As an example most of the coving to our brick walls has been pushed off.

Personally, we don't have young children to consider but the area surrounding the Saxon pub is totally residential and has a significant amount of families with young children. The only other commercial premises is the adjacent Tesco's which has it's own anti-social problems. They have to have constant security guard presence.

There have been occasions where loud, drunken people have caused us to wake at night and in the early hours of the morning, it can be rather intimidating. I have also witnessed people passing out and laying for sometime (waiting for emergency attendance) on the 'green' opposite our house.

We doubt that police resources can afford to allocate extra policing for the area. Neither can we see any social or community benefit in extending the hours so we hope that common sense prevails and this application is turned down.

I have heard that the Saxon pub in Calmore, Totton is applying to extend its opening hours, and also increase the number of evenings that it has discos. I have looked for the planning application up, but can't find it so I can only going on what I have heard from a neighbour who saw it and had to go into the pub to ask about it as he said that it was so high he couldn't read it!

As local residents, my husband and I strongly object to the evening hours being extended (although we have no objection to an earlier opening), and also to the idea that there would be more evenings with load music. I don't know if the music issue has anything to do with the license, or if it is just about the hours.

We are often disturbed by drunken people staggering home at 11.30 or so, and many times there are arguments going on between groups or couples—I have often watched after couples arguing as they wind their way slowly down the road to keep an eye on the women involved in case things turned nasty. There have been many cases of vandalism to cars and property, mine included, which have happened around pub closing time, not to mention the smashed bottles and pint glasses littering the streets.

If the hours were to be extended then we would not just get our late evenings disturbed but we would be getting woken at all times during the early morning hours. There would be more drunks, as people WILL continue drinking until the pub closes, whatever time it does. There will probably be more rubbish, more noise, more vandalism.

There was even a problem some months back when a man dropped dead on the road outside my house after a fight in the pub.

Disco music can be heard from quite some distance.

Please say NO to this application!

I wish to make an appeal to restrict the application for extended licensing hours to the 'Saxon Inn' at Calmore.

After reading the posted notice I am concerned with the potential effects of the extended license and the impact the new situation will have to me, my property and the local area.

I understand that although an increase in hours for the sale of alcohol and entertainment may be granted, it's not a forgone conclusion that the landlord will make full use of the new license.

My concerns are as follows: -

- 1) Once an extended license is offered, should the landlord decides to make full use of the extended hours no objection will be recognized. That is to say the situation may not change at the moment, but with the new license changes may take place in the future with out objection.
- 2) It's a common belief and fact that the culture of binge drinking exists in the UK. Only last year a local man died having been allowed to drink himself to the extent of not being in control, and was then left to leave the Saxon. He was found seriously injured outside the main road, and later died in hospital.
- 3) Domestic disturbances are not un-common at kicking out time and I can recall late sleepless nights last summer having to hear the results of alcohol aggravated scenes between men and women leaving the pub. Boyfriend and girlfriend arguments broke out and went on until the early hours, with bad language and violence being the result.
- 4) The increased license makes it easier for teenagers to obtain alcohol and become drunk, quite often local paths at the backs of gardens are used as a gathering point for arguments with the result of increased noise, and violence. Although I've no proof of damage as a result of alcohol from the Saxon, it's obvious this will increase the opportunity for teenagers to get loud and become out of control.
- 5) The noise from entertainment if allowed to go on to 1.00am in the morning will increase stress and a loss of privacy to the local neighbors. Windows are quite often left open in the summer, and the thought of having to listen to the likes of '70's pop music' to the early hours without the ability to complain gives me concern. Noise travels farther at night and even with doors closed the base levels penetrate into local homes

My main issue is the duty of care required from the increased freedom to sell alcohol and to provide entertainment.

I fear that once the pub is empty as far as the staff who run the pub are concerned they're not responsible for the way people behave. It's all to easy to improve your sales and profit from selling alcohol but what is the landlord going to do to control the effects of these increased hours. How will he respect the neighbors that surround him?

Local Police resources are stretched to capacity and it's unlikely they will offer preventative help, it's likely they will only react once a criminal act has occurred, and then only with proof of the circumstance at the time.

Altercations and domestic disturbances are not easily resolved or prevented; only the situation, which allows them, can be controlled.

I would like to object to the above mentioned public house having a licence extension because of the late night disturbance that this would cause.

The noise levels at closing time are at present often extremely unsociable with drunk people regularly screaming and rowing on a Friday and Saturday evening. This would become worse if the pub was to be open for longer and later into the night.

I live in Charmus Road and have two small children and find the aggressive nature of some of the current disturbances very unsettling. If the pub cannot sort out this problem then how can they justify opening for longer. This is a very built up and populated area and I feel very strongly that it is not appropriate to extend the licence for this public house. Surely the concerns should be for the greater community rather than a few late drinkers.

Saxon Inn is part of and operated by Mitchells & Butlers Group (MAB). MAB own and operate over 2000 separate managed businesses within the United Kingdom. Managers are employed by the company and operate under the direction and procedures of the company. We adopt a corporate approach to risk management across the whole estate. This ensures a consistent approach to the management of risk in each of our businesses through a range of policies, procedures and roles. This approach is fundamental to our operating principles and is integrated into the way we run our businesses.

We refer to the attached document, "Mitchells & Butler – A Guide to our Policies". This document, which does **not** form part of this operating schedule, demonstrates our total commitment to best practice policies, enforced and monitored at this site. It is not possible to submit such policies as potential conditions as they are obviously subject to other legislation, corporate responsibility considerations and market conditions, and are therefore liable to change from time to time.

This is a variation application that does not represent a fundamental change in the way in which this premises has already been trading under its existing licences and conditions. We are required in schedule 1, part B2 to state "any additional steps that you intend to take in order to promote the four licensing objectives if the proposed variation is granted". We have carefully considered the risks and benefits associated with the additional hour(s) applied for and where additional steps are necessary and proportionate to address the licensing objectives have indicated them.

We will continue to train our staff in the standards required by the relevant legislation and as required by company policy.

Our voluntary closure policy for the operation is 30 minutes after the approved closure time for the supply of alcohol.

b) The prevention of crime and disorder

The company monitors the need for door supervisors and in so doing takes into account any advice given by the Police.

The pub manager is required to actively participate in and support local the Pubwatch scheme (where active).

Text and/or radio pagers, where already used will be used for any additional hours.

Toughened glass is currently in use and will continue to be used during any additional hours.

Existing CCTV system will continue to operate during the additional hours.

In line with our Alcohol and Social Responsibility Policy there will be no promotions that encourage illegal, irresponsible or immoderate consumption.

c) Public safety

We already understand our obligations under existing Health and Safety legislation, take our responsibilities seriously and have extensive policies and practices in place to meet these obligations (see "Guide to our Policies").

It is our opinion that the nature of the operation and proposed variation will not lead to any increase in risk of the public safety. The existing policies will simply be extended to cover the relatively small increase in opening hours. Our internal health and safety due diligence and incident reporting system will operate during the additional hour(s).

d) The prevention of public nuisance

The style and nature of the operation will not differ significantly from the existing trading operation during the extended hour(s). Indeed, the grant of the additional hour(s) will of itself promote the licensing objectives as stated at paragraph 3.29 of the **Guidance**, in allowing customers to emerge from premises at a more gradual rate.


