

The style and operation of the pub will not differ significantly during the extended hours. Where this is appropriate, non-alcoholic refreshment will be available in the extended period.

The premises will respect Spirit Group's Approach to Responsible Drinking (a copy of which is enclosed in support of this application). Our policies change at regular intervals to reflect current trends and it would be inappropriate to standardise them on a permanent basis. The enclosed policy is included for information only and not as suggested conditions or to form part of any other Operating Schedule.

b) The prevention of crime and disorder

We are introducing Security Industry Authority (SIA) approved door supervisors across our estate, in line with the Government approved implementation plan.

A zero tolerance towards illegal drugs will be enforced at all times.

If a disc jockey is used on any night then he/she will ask customers to leave quietly.

If a CCTV system is installed at this site, it will continue to operate during the additional hours of trading and notices will be displayed.

All instances of crime and disorder will be reported to the police and will be kept in an incident log book.

c) Public safety

Public safety is integral to the way that the Spirit Group runs its business and is reviewed regularly through our health and safety policy. This policy is fully briefed and trained to all management and staff and we will continue to train our staff to the standards required by relevant legislation. Free drinking water will be available at all times.

d) The prevention of public nuisance

Additional patrols will take place by members of staff, internally and externally, to limit any noise pollution when entertainment is being offered within the premises.

If appropriate, notices will be displayed asking our customers to respect our neighbours when leaving the premises.

Where already used text/radio pagers will continue to be used for the additional hours of trading and will be monitored by a responsible member of staff.

Soft drinks and non-alcoholic refreshment will be available if we decide to use the option to stay open for an extended period between the cessation of the supply of alcohol and the closure of the premises (see above under General).

e) The protection of children from harm

When children are allowed upon the premises, any entertainment offered within the premises will be suitable for young persons.

Children will be required to be supervised by the accompanying adult at all times.

A no smoking area will be provided.

Soft drinks and non-alcoholic drinks will be available.

A recognised Proof of Age Policy will be enforced.

Application by Spirit Group to vary the Premises Licence for Croft Tavern

We are writing to object to the above application. As residents living in close proximity to the above public house, we are concerned about several aspects of the application, namely:

- To extend the hours when alcohol is sold
- To remove restrictions on drinking up time
- To allow credit sales
- To allow provision of late night refreshments

The Croft is located in a residential area removed from the village centre or any other entertainment establishments. If granted, we believe that the Croft would be the only pub offering late night drinking, and for that reason is likely to attract additional customers specifically wanting to continue drinking after other local pubs have closed. The result may be an increase of activity both inside and outside the pub, just as residents are preparing for bed.

The current local pub management (as opposed to the Spirit Group), have done an excellent job in minimising trouble within the pub, and reducing impact on residents, by enforcing a "no under 21's" rule from Thursday to Sunday evenings. If this rule was revoked in the future, perhaps by different local management, and increased late night drinking was permitted, (perhaps encouraged by credit sales), we believe that there would be a considerable increase in public nuisance and disorder.

With this background, we object on the following grounds:

The prevention of crime & disorder:

The Croft pub has banned under 21 year olds from drinking on Thursday to Sunday evenings. We understand that this was due to disorderly behaviour. Since this, the decrease in the level of noise and incidents at closing time has been very noticeable by the residents living close by. Damage to property has decreased considerably. We are concerned that not only will this disorder re-occur but it will be later at night.

Public safety:

There is a minimal public transport to and from the pub - the last bus is at midnight. The alternative is taxis which would increase noise and nuisance in the early hours of the morning. There is a real concern, given the transport issues and the extended drinking time, that this could result in an increase risk of drink driving.

The prevention of public nuisance:

The pub is located in the middle of a quiet residential area. The noise levels both inside the pub during opening hours and also outside the pub after closing time will be disturbing to the local residents. Prior to the improvements made by the current management, we regularly experienced people depositing rubbish or urinating on our premises, and on several occasions garden fences were kicked in or partly pulled down on the adjacent property. Increased late night drinking is likely to repeat and exacerbate this problem.

We hope that you will take this into consideration when you are assessing the application.

- We are already suffering more than enough noise late at night by shouting and loutish behaviour from clients coming out of the Croft Tavern.
- We have had our front gates lifted from their hinges and thrown 2. down the highway late at night and can only surmise that these are inebriated clients from the Croft Tavern.
- Our front fence was recently kicked down and broken which meant 3. added expense to repair and maintain.
- We have had arguments with Croft Tavern clients who were urinating in our drive, which resulted in our car being given a "thump" as they made their unhurried exit accompanied with loud swearing and loutish behaviour.

As a near neighbour of the Croft Tavern, please may I formally object to the following aspect of the aforementioned Premises License variations:

1) to extend the hours for the sale and supply of alcohol and other licensable activities to: Sunday 00.30, Monday 00.00, Tuesday 00.00, Wednesday 00.00, Thursday 01.00, Friday 01.30, Saturday 01.30

My objections to this aspect is based on concerns of public safety and public nuisance. The Croft is located in a residential area, with residential houses in very close proximity; ours being one. Extending its licensing hours will increase the level of unacceptable disturbance caused by patrons leaving the premises at a significantly more inconvenient hour for those residents than currently exists. Extended licensing hours will also encourage excessive drinking by certain patrons, which gives cause for concern for the safety of the public and our children when passing this location at closing time. The Croft is located on a busy main road, extended licensing hours will lead to a significantly higher risk of road traffic accident on this road at closing time.

While acknowledging that "The Croft" is at present a well managed Pub with good services, especially for food, there are a number of points which lead us to oppose the application for extended hours every day of the week in a residential area.

- 1. A persistent whine from the kitchen extraction fan which faces to the front is an annoyance to those of us living across the road within 400yds of the pub. This is most obvious during the late evening and extended hours may mean prolonged noise and public inconvenience.
- 2. There have been a number of occasions in the past when disorderly behaviour has caused trouble in the late evening. This is generally because people are drinking too much and their behaviour gets out of hand. Recently the pub was closed early to avoid disruptive behaviour after a televised football match. A few years ago there was a tragic death due to out of control behaviour. We cannot help feeling that extended hours will increase the chance of these incidents occurring and that "The Croft" will become a focus for late night drinkers leaving the pub on foot causing noise and aggravation.
- 3. The lane where we live is opposite the pub and is regularly used by people leaving the pub at night as a tipping ground for their rubbish and even as a urinal. This will only increase with longer opening hours, likewise the noise level will be prolonged later into the night after most residents have retired. This can only add to the public nuisance effect.

I see that Spirit Group are applying to vary their premises licence at The Croft, and as a very local resident — we live almost opposite — I should like to lodge a limited objection under the licensing objective 'Prevention of public nuisance.'

There are seven variations proposed, of which I would have no difficulty with four;

- allowing accompanied children under 16 into the bar
- allowing credit sales
- provision of late night refreshment [provided the noise levels are reasonable]
- allowing limited entertainment

I do not understand the scope of one proposed variation:

removal of certain existing conditions.

I can quite well put up with other people enjoying themselves even if they are a bit noisy; on only two occasions has anyone thrown stones over here and scored direct hits on my car or on my lavatory window. However, two proposed variations do seem to me to be going a bit too far, and would be undesirable in this neighbourhood, which is residential, and apart from the noise of traffic calm and peaceful (except sometimes when Southampton plays at home!):


- · extending the hours till midnight or beyond, and
- removing the restriction on drinking-up time.

May I please ask the people assessing this application to think carefully before allowing these two variations? On special occasions (when Southampton re playing at home, perhaps?) a special extension might be applied for, but a general permission to operate a pub in the middle of the night seems highly undesirable.

We have lived at 38 Langdown Lawn on the opposite side of Langdown Lawn from The Croft, 50 meters towards Beaulieu Road to Dibden Purlieu for 42 years.

During this time the behaviour of the customers leaving at closing time in the evening has varied from the simply noisy to destructive. My house name plate and house number have been repeatedly uprooted and left in the hedge further towards Dibden Purlieu or behind the bus shelter. The hedge is used as a place to deposit beer glasses and bottles. My front gate standing back from the pavement is regularly used as a urinal. Other residents have had gates removed and thrown onto their front gardens.

These annoyances do not happen all the time but often enough to make us worried about later drinking times.

Langdown |Lawn is a residential area and not a tourist or town centre where people expect to be entertained long into the night.

We therefore would urge you not to grant the application for extended hours from Spirit Group.

With regard to the application made by Spirit Group to vary the Premises Licence for Croft Tavern, Langdown Lawn, Hythe, Southampton, SO45 5GS, we wish to submit the following representation.

We regard the application to extend the hours for the sale and supply of alcohol to be inappropriate. Already, with the existing hours of trading, the disturbance produced by groups of people departing from the Croft Tavern, late on Friday and Saturday nights in particular, is excessive both in Langdown Lawn and in neighbouring areas. A great deal of mischief occurs at these times, resulting in damage to both public property (road signs, bollards etc.) and private property (damage to and defacing of fence panels). The frequent discarding of cans, bottles and beer glasses in gardens and hedges and at the roadside is also unpleasant and hazardous. We consider that the extension of the hours of trading as specified in Spirit Group's application would substantially extend the period over which such noise and mischief occur and would be a considerable nuisance to local residents.

We therefore urge New Forest District Council to refuse the particular section of Spirit Group's application that relates to the extension of the hours of trading.

We write to object to the proposed variations to the licence at the above named premises for the following reasons:

There is already considerable noise for sometime after closing, particularly on Friday and Saturday nights. This takes the form of shouting, screaming and foul language and is often accompanied by horrendous bangs as individuals attempt to smash the nearby bus shelters and road signs. We, as residents, already find this bad enough. However, if the Croft is allowed to open until later then this anti-social behaviour will also take place later and so, instead of being disturbed at about the time we go to bed, we will have our sleep interrupted. The area surrounding the Croft is exclusively residential and therefore many other people will also be affected.

As the point of altering the licence must be to extend the trade at the Croft we feel that the increased usage will exacerbate the situation described above to intolerable levels, particularly during the summer months when we sleep with our windows open.

It is widely reported in the press that providing young people with extra drinking time results in extra anti-social behaviour and violence. The area already suffers from vandalism and the Croft has had a bad reputation for violence in the past, with one incident resulting in the death of a young person. As residents we therefore find the idea of allowing increased drinking hours to be unacceptable.
