#### **Non-standard timings**

The licensable activities detailed at sections E. F. and M. above will be permitted until 00.30 hours on:

- New Years Day (running over from New Years Eve)
- 3 further occasions (in any 12 month period) to be notified to the Licensing Authority at least 7 days in advance.

When the non-standard timings are permitted as above in respect of the licensable activities detailed at sections E. F. and M. above the premises will be permitted to remain open until 01.00 hours.

### **Mandatory conditions:**

As provided in the Licensing Act 2003

#### Other conditions:

- 1. All external doors and windows shall be kept closed, other than for access and egress, in all rooms when events involving live or recorded music (including amplified speech) are taking place.
- 2. Notices shall be displayed in prominent positions within and outside the premises requiring patrons to leave quietly and respect local residents.
- 3. No part of the premises outside the enclosed building shall be used for the consumption of alcohol after 23.00 on any day

#### 7. Reasons for the Decision

In respect of the finish time for the licensing activities, the Sub-Committee had particular regard to representations concerning noise nuisance, mainly from the sound of music emanating from the premises.

The Sub-Committee considered that the supply of alcohol to 23:30 every day except Sunday (which would be limited to 22:30) was not unreasonable.

They considered that allowing a later closing time during the working week (with a normal work or school day the next day) would have the potential of creating noise nuisance to people living in the vicinity at an unacceptably late hour and felt this was unreasonable. They considered however, that on a Friday and Saturday evening, a later closing of 00:00 was acceptable.

They were also satisfied that on 4 extra occasions per year, the licensing objectives would not be compromised with allowing the supply of alcohol and closing to take place up to 00:30 (also to include live and recorded music) and 01:00 respectively.

With regard to the provision of live and recorded music, the Sub-Committee considered that a finish time of 23:00 during the working week with an earlier finish time of 22:00 on Sunday would better promote the licensing objectives. They were however, happy to permit a later finishing time for such music until 23:30 on Friday and Saturday evenings.
