This statement sets out the issues that the applicant has considered having regard to the above. The applicant offers the specific Proposed Conditions attached, which are based on the Model Pool in Government Guidance, for the promotion of the licensing objectives.

The applicant has considered the nature of the premises and facilities offered, and the surrounding area. The premises are operated primarily as a quality restaurant and bar with customary facilities for ancillary entertainments and functions.

There are no external drinking areas. The premises are popular with both the locals and visitors to the area.

The style of the premises and the customer base is such that there are few issues and none are anticipated as the proposed operation reinstates and enhances the entertainments etc that are mainly enjoyed as embedded rights.

#### **Prevention of Crime and Disorder**

As a responsible operator, the applicant is aware that there are issues which need to be addressed in an operation of this nature.

The following matters are considered

#### General criminal activity

- The employment of trained staff. Their duties will include checks on customers behaviour.
- Close liaison with the Police when appropriate.

**Excess Consumption of alcohol** 

The style of operation on this site does not lead to problems of this nature.

Staff will continue to be vigilant to ensure that this remains the case.

**Drugs** 

There have been no issues with this site. If necessary, the site will enforce a Zero Tolerance approach.

Capacity

# MAINE RESTAURANT - LYMINGTON

We observe with some concern that Maine Restaurant has applied to you for a music licence extension until midnight.

As background, I and the local residents group (of which I am the secretary), have battled for some years with previous owners of this restaurant (under various names) in an effort to reduce the amount of noise and anti-social behaviour emanating from the above premises. We took them to court and thought that we had won a partial victory when they agreed to keep their windows and doors closed when music was playing. (They never fulfilled their side of the bargain). We also observed that with the granting of their music licence there was an upsurge in the amount of drunken the granting of their music licence there was an abouting. In short the music appeared to attract a less responsible type of clientele.

In fairness, we have encountered none of the above symptoms since the new owners took over and enjoy a good relationship with them. However we firmly believe that if the extension of licence is granted to 'Maine' that the noise being broadcast via their open windows and doors will cause us and our neighbours to lose sleep.

As you will be aware, Ashley Lane is a quiet, residential lane with no parking available to guests of the restaurant. It has no air-conditioning system. We therefore believe that the premises are unsuited to an extension of licence as specified.

I am writing to you with an objection that I wish to raise regarding the Licensing Application by Maine Restaurant for a Full Entertainment License.

As a local resident with residency directly next to the restaurant on Ashley Lane, I wish to object for the following reasons:

- Ashley Lane is a dead end public highway with no parking facilities. People exiting Maine Restaurant step out directly out onto the public highway and in doing so cause a nuisance to neighbouring residents late at night.
- The restaurant is not only semi-detached to a private residence but is narrowly surrounded on all sides by residential houses. Any public entertainment on a permanent basis would therefore be a definite public nuisance and cause noise pollution. Indeed the restaurant has a history of public nuisance and under previous ownership, as 'Preachers' was the subject of a court order taken out by New Forest District Council.
- Ashley Lane and Grove Gardens, which is in close proximity to the restaurant, both have a history of crime and disorder and need no further encouragement in this direction.

In summary, I feel that the site of the restaurant and its location make it completely unsuitable for the type of license for which it is applying.

I hope that you will see fit to refuse this licence application.

Re Maine Restaurant, Ashley Lane, Lymington, Hants.

I write to lodge my objection to the licensing application by Maine Restaurant as above. My objection is on the grounds of prevention of public nuisance as well as public safety.

1. Prevention of Public Nuisance. Maine Restaurant is situated in the middle of a residential area with many houses close by. My house for example is around 20 metres away. For a number of years, the premises have been the subject of an order prohibiting the use of music or entertainment which is produced electrically or electronically. This has worked well as it has allowed the premises to feature live, unamplified musicians but has not disturbed the neighbours. I understand that the current application requests removal of current restrictions and thus electronically amplified music may be allowed if the application is approved. From my point of view this would be appalling as the idea that loud music could emanate from the restaurant until midnight would totally ruin the peace and quiet I enjoy in my house. I believe this would also be true for the other neighbours surround the restaurant. This is a quiet residential area and should remain so.

There have been several restaurants on the site in the past and there have been a considerable number of complaints from local neighbours, including myself, regarding the noise generated by the restaurant and, drunken behaviour in the Lane. This behaviour was caused by previous managements and I should add that under the current management, up to now there has been no trouble from drunken customers. However, an increase in licensing hours until midnight may change that situation. In addition, any future management may well not take the same attitude and be more interested in selling alcohol in quantity and less interested in the consequences.

2. Public Safety. Ashley Lane is a narrow, one-car-width lane running down in a southerly direction off Lymington High Street. The only vehicular exit to the Lane is to the High Street. My house, where I park my car, is to the south of Maine Restaurant, in other words the restaurant is between my house and the High Street. I therefore have to drive along the Lane past the restaurant to get out into the High Street.

The Lane is also used by many old people in their electric cars as there is an old people's home to the south of the end of the lane. In fact there is even a special hoop type barrier at the south end of the Lane to prevent cars being driven down there but to allow old peoples' electric cars through. Effectively the Lane is the old peoples' main route to the High Street and they use it constantly.

At the moment, delivery vans, taxis and customer traffic quite often park outside Maine Restaurant and block the lane. This makes it impossible for me to drive up the public highway to leave my house. When I ask them to move, sometimes the delivery

van drivers claim that they are "delivering goods" and thus have a right to block the lane for the time the delivery takes. Obviously, this causes the old people to be obstructed and sometimes they take a risk and try and squeeze through the gap at the side of the vehicle. Up to now this has not caused any problem, but I can foresee a situation whereby a delivery driver may not see the rather low electric car of some elderly person and squash them.

I am concerned that with the increased facilities that have been applied for – regulated entertainment, indoor sports and the use of DVD and video entertainment, may cause the traffic generated by the restaurant to increase considerably. There is already a problem both for me and for the old people and any increase may make the situation unbearable and perhaps dangerous.

For the above reasons, I respectfully request you to refuse this application.
