





I am very concerned to hear that the licencees of the **Trown Inn at Everton** have applied for an extension to the existing licencing hours and additionally for a music licence.

As a local resident living very close to the Inn, I feel I must register my protest against the application.

The Music licence is wholly inappropriate for the quiet village location of the pub. The pub is surrounded by residential properties whose inhabitants include young children and elderly people whose lives and basic human rights to live and sleep in peace will be severely affected if the licence is granted.

In addition, the extension to the alcohol licencing hours is also inappropriate. As mentioned above, Everton is a quiet village. I am sure I speak for others in the village when I say that we are happy to have a pub and we are satisfied with the current opening hours. An extension of these hours is not needed, would be out of character with the village and would only lead to an increase in disturbances as people leave the pub after more hours drinking. The location of the pub would inevitably mean very real risk of an increase in the number of drunk drivers, as Everton does not have any alternative transport to match these extended hours.

I am informed that there were regular disturbances in the village and property was damaged when the opening hours at the Village Club were extended some years ago. This situation is sure to be repeated if this application is passed.

I would like to object to this application on the following grounds:

- too many cars parked until all hours in the road; Old Christchurch Road is a busy road and quite narrow. Residents find it increasingly dangerous to cross the road as the parked cars obstruct the view. A few months ago my elderly neighbour was knocked down by a car she could not see approaching.

## THE CROWN INN EVERTON LYMINGTON HANTS

We understand that the Crown Inn has applied for a licence for extended opening hours.

Being pensioners, we are very disturbed about this application. Our property is close to the garden and car park and we already get considerable noise from the garden at times. If the hours are extended we are concerned that this will cause further noise and public nuisance to the residents of Everton, due to rowdy behaviour from customers as a result of excess drinking due to longer opening hours. My husband is disabled and does need to have undisturbed sleep. It is a known fact that excess drinking does lead to vandalism, crime and disorder. We never see police here in Everton and it is a concern that there are not enough police to enforce orderly behaviour in our currently quiet village.

My husband is disabled and does walk with a walking frame in the village on his own during the day. However, The Crown could attract a younger element of people, if the licencing hours are extended, which in turn could pose a threat to his welfare and safety. It is good for his well-being and health to be independent and take exercise; I feel this may have to be curtailed if we get younger people taking excess alcohol and becoming abusive and threatening in the village. This situation would also apply to other residents of Everton. In the interests of security for residents, I would suggest that the street lighting in East Lane, Centre Lane and West Lane should be improved, if this licence is granted, as at present it is very poor.

The majority of Everton residents are retired and came to live here because of its quiet location, we do not want to encourage our village to become a place of crime and disorder, where we feel threatened and unable to lead a normal independent life.
