b) The prevention of crime and disorder

Premises employees are instructed not to serve customers who are drunk, or appear to be so, nor to allow customers who arrive in a drunken and/or disorderly manner to be admitted to the premises, or for customers who start to behave in such a manner to remain on the premises. The provision of remaining open for half an hour after alcohol is no longer served will facilitate the quiet and orderly drinking up by customers and allow customers to leave in a phased and orderly manner to minimise disruption to the surrounding area.

c) Public safety

The premises complies with Health & Safety and Fire Precautions regulations. Following risk assessment, preventative and control measures are in place to ensure the safety of customers, employees and entertainers whilst on the premises. Fire action notices are posted and escape routes signposted.

d) The prevention of public nuisance

Prior to 23.00 music and noise emanating from the premises whilst audible, is so low that distinct tunes, lyrics, musical instrumets and any base beat cannot be recognised at the boundary of all noise sensitive premises. The licence holder or nominated representative shall receive and respond to complaints throughout the duration of the regulated entertainment. We understand noise sensitive premises includes premises used for residential purposes, hospitals, or similar institutions, educational establishements (when in use) or places of worship during recognised times and days of worship or any premises used for any other purpose likely to be affected by the music noise.

e) The protection of children from harm

Persons under 18 are only allowed in the dining area if accompanied by an adult. Persons under 18 are not allowed in the bar. All staff are instruced in the offence provisions fo the Licensing Act 2003 relating to alcohol and the protection of children. # Application by King's Head, Quay Hill, Lymington to Extend Licensing Hours

I write to OBJECT to the proposed extension of licensing hours at the King's Head, Quay Hill, Lymington to 12.30am Monday to Thursday; to 1.30am on Friday and Saturday and to midnight on Sunday.

I have lived at 2 The Old Mill, Mill Lane, Lymington at the bottom of Quay Hill from 1988 to 2004 and since then at 6 Trafalgar Place at the top of Quay Hill. Consequently I have long experience of the effect of existing drinking hours at the King's Head.

It is commonplace for drinkers to spill out onto Quay Hill to stand, talk and drink. There is no effective and permanent way of stopping this. It is not unusual, particularly in the summer, for up to 30 people to be attracted by the pleasant atmosphere of Quay Hill and many are not then bothered to push their way back into the crowded public house for "necessary functions".

As a result I can personally testify to innumerable incidents of people urinating and being sick at the lower entrance to Trafalgar Place off Mill Lane or the upper entrance to Trafalgar Place off Gosport Street. At the same time, an intimidating atmosphere is created for people walking up Quay Hill, there is litter, broken and intact glasses and bottles and petty vandalism to shop windows in Quay Street and to flower baskets. There is no CCTV coverage and the district council removed the proposed camera because of it's effect on the listed Solent House at the bottom of Quay Hill and the conservation area. I have been verbally abused when I remonstrated with one young man urinating outside the bedroom window of my former home in Mill Lane and the arches below number 9 Trafalgar Place are regularly used as a toilet.

In addition to these wholly unacceptable practices, noise, drunken shouting and petty vandalism occur at pub closing time and for up to an hour or more afterwards. There is never any police presence. This disturbance will now extend well into the middle of the night and the associated rowdyism and noise created by drunken people will increase at the most sensitive time in people's sleep patterns.

This proposed increase in drinking time is wholly wrong given the King's Head's location and I strongly request that ANY extension of existing hours is refused.

We wish to register an objection to the proposed extension of Opening Hours for the King's Head.

You will be aware that clients' of the King's Head often use Quay Hill as an overspill, particularly on summer's evenings. We recognise that this is a harmless and reasonable activity, even if sometimes the clients' unfortunately create noise and refuse. However, with the current licensing hours, the substantial noise nuisance abates by midnight to an acceptable level.

Extending the hours to 12am, 12.30am, or 1.30am will mean that the noise nuisance will persist to 1am or even to 2.30am. We think you will agree that this is unacceptable in a residential area populated by generally elderly residents.

We recognise that the licensee needs to make a reasonable living. We would be happy to see a blanket extension of the hours to 11.30pm each night if the licensee was able to reassure us that his clients would have departed the vicinity by midnight. We understand that the King's Head Inn has applied for extended opening hours that will continue until 12.30 a.m. from Monday to Thursday; until 01.30 a.m. on Friday and Saturday (i.e. until Sunday morning); and until midnight on Sunday night. The pub has also applied for a license to have live/recorded music during opening hours. We strongly object to having the licensing hours extended so late and to the pub having music.

Quay Hill is a short pedestrian street with shops at street level, many with accommodation above. There are also some private residences, including our house. All those living in Quay Hill, and the other residents nearby, will be adversely affected by the proposed changes of the opening hours of the King's Head. The proposal will lead to increased noise and disturbance that will continue until the early hours of the morning (well after closing time) every day of the week, making it almost impossible to sleep normally in our bedrooms.

We have taken note of your Statement of Licensing Policy, published on 7<sup>th</sup> January 2005, and observe that as the proposals will impact negatively on members of the public living nearby they will be unlikely to satisfy aspects of Policy A1, Policy C1, or Policy C2, particularly 'when residents are sleeping or attempting to sleep'. The advantages to the pub of extended opening hours, and attracting more drinkers through music, are not proportional to the disadvantages faced by the residents.

Specific points we would ask you to bear in mind are:

1. Noise.

The pub premises are popular, but are small with low ceilings, so the customers frequently emerge with their drinks and stand talking and laughing outside the premises - becoming a noisy crowd spreading across Quay Hill and sometimes blocking the street. Furthermore, the request for the provision of live/recorded

entertainment in such confined premises is a potential source of further noise as the main door will often be open. You should be aware that the cobbles and buildings of Quay Hill funnel the sound along the street and, as it is a pedestrian area, there is little other noise in the vicinity in the evenings. A group of three or four people talking together in Quay Hill makes a substantial amount of noise that can be heard for some distance.

### 2. Disturbance.

The King's Head is by far the nearest pub to our house and we have already had our windows broken by drunks (as can be confirmed by the Police) and bottles have been thrown at the house. Glasses are often left outside the pub after busy sessions and are kicked and broken around the street. We cannot anticipate that extending the hours will lead to any fewer problems – and the problems that occur will be even later in the nights.

Except at closing times and on busy evenings like Fridays and Saturdays, Quay Hill is relatively quiet and we enjoy the peace here. We can accept the present level of disturbance when it happens, but cannot accept that it will continue until after midnight and well into the early hours of Saturday and Sunday mornings.

For these reasons we would see any significant extension of the licensing hours as a serious infringement of our human rights. We therefore ask you not to grant permission to extend the hours and have additional music as requested.

We wish to object most strongly to any extension of the licensing hours of The King's Head, Quay Hill, Lymington. Furthermore we object to any license being granted for the playing of any form of music during existing opening hours.

We have lived in the end house of Trafalgar Place adjoining Quay Hill for ten years and already find that the disturbance from The King's Head can be intolerable and not only at closing time. The pub is well-used but the premises are extremely small with low ceilings so the doors and windows are always open. Regularly, customers use Quay Hill as the pub beer garden both during the day and in the evening – they block the way for passers by, intimidate non-users of the pub and leave bottles and glasses on steps and paths.

Closing time is particularly noisy at weekends with drunken revellers singing, shouting and sometimes fighting, with complete disregard for people living near-by. Local residents are the target of petty but scary vandalism with bottles thrown through windows and into gardens. I am writing to you on behalf of the eighteen residents of Fisherman's Quay, Mill Lane, Lymington.

I understand that the King's Head Inn has applied for extended opening hours that will continue until 12.30 a.m. from Monday to Thursday; until 01.30 a.m. on Friday and Saturday (i.e. until Sunday morning); and until midnight on Sunday night. The pub has also applied for a license to have live/recorded music during opening hours. We strongly object to having the licensing hours extended so late and to the pub having music.

Fisherman's Quay is a block of 18 flats, the front of which face onto the Quay and the flats at the back face onto Mill Lane which leads off of Quay Hill. Fisherman's Quay is surrounded by a public pedestrian walkway which has access from Quay Hill.

The residents have already been affected by drunken males urinating on our premises, throwing glasses and fighting on the walkway, which passes alongside most of the bedrooms of the flats in Fisherman's Quay. This is particularly worrying to the residents on the ground floor.

All those living in Quay Hill, Fisherman's Quay and other residences nearby will be adversely affected by the proposed changes of the opening hours of the King's Head. 

We note that the above premises have applied for a new or renewed licence taking advantage of the new regulations now available.

We firmly object to this proposal based on our experience of more than 25 years as a retailer in this area. Over these years we have suffered many tribulations from people who have over indulged in alcohol. These matters have included vandalism, destruction of street flower decorations, broken windows, broken glasses and bottles and street corners are utilised as toilets. Vehicle damage on The Quay is not an uncommon event and in recent years much damage has been caused to the new toilet and shower facilities. The police are often called to attend these late night incidents of drunken stupidity which only increases the pressure on them when they could be better employed elsewhere. It is our opinion that increased drinking hours can only aggravate these problems causing distress to local residents and retailers alike.

We also note that the notice on The Kings Head of this application was only displayed for a very short period, which we believe is incorrect.

We also believe that The Ship Inn on The Quay have also made a similar application though no notice has been seen. If this is so obviously the same objections apply.

We do not subscribe to the opinion that extended drinking hours will improve peoples behaviour, this defies all logic and is totally opposite to experience.

I am writing to express my strong objection to the proposed extension of licensing hours at the Kings Head public house to 12.30am Monday to Thursday; to 1.30am on Friday and Saturday and to midnight on Sunday.

As a resident of Trafalgar Place I am frequently aware of the noise and activity caused by the drinkers leaving the pub at closing time, and although it does already bother my family and I, were the opening hours to be extended it would be far more disturbing. This is especially heightened by the fact that I have three daughters who would be in a deep sleep by the time the drinkers left the pub, and would certainly be awoken by the noise at a very unsociable hour.

The extended opening hours would be sure to encourage further the consumption of excess amounts of alcohol, which already results in people being sick and even urinating in the streets off Quay Hill.
