





This application has only just been brought to our notice by a neighbour. The Notification has been posted on a rear window to the premises and is far from visible to public inspection. The Notice indicates that a copy of the application may be found on the NFDC website but we understand from your office that this is not so.

We wish to object to any permanent extension to any of the licensing hours for The Hunters Lodge under the heading of:

## **Prevention of Public Nuisance**

We have lived at this address for over twenty years and have been accustomed to ever increasing amounts of noise from loud music, car doors slamming, car engines over-revving, shouting and screaming which thankfully ceases soon after 11 pm. The prospect of this nuisance continuing until after 2 am on a regular basis is not acceptable and we trust that the application for an extension of hours be refused.

I learn with some dismay that the above named brewery has applied for a variance in its' operating remit, that is it wishes to be able to stay open for the sale of drinks and regulated entertainment until 01.30hrs. and to serve light refreshments until 02.00hrs.

My family and I live on the corner of Southampton Road and Middleton Road, this being diagonally across Southampton Road from the Hunter's Lodge public house. We have lived here for more than eighteen years and have seen the establishment change from a good pub that served excellent cooked food at lunch and dinner times to one which is seemingly solely for drinking and entertainment. On the evenings when musical entertainment is offered the noise emanating through the open doors of the pub is very loud and heard all too loudly in our home. Even with double glazing it is impossible to escape the sound of music and the enthusiastic MC.

Worse still is the situation at the end of the evening when spirits are high and the MC seeks to ensure everyone is enjoying themselves, then the noise increases in intensity and volume. The noise continues until 11.30hrs. and later on some occasions, this is before the extended goodbyes, car doors banging and cars leaving. There have also been occasions where groups have stayed on outside and disagreements have taken place which have necessitated police intervention which means disturbances into the early hours. If this were to become a regular occurrence with a licence until 1.30am the quality of life for the area would be considerably reduced.

We find it impossible to get to sleep before all this noise has abated and of course cannot have our bedroom windows open even in the summer months which is no joke believe me!

We feel if refreshments are going to be served until 2.00am they are likely to be of the fast food variety and the litter, potential smells and half eaten food discarded round the pub and garden will be an instant attraction to rodents. It will also mean that if food can be served until 2.00am the finishing/clearing up process will take us on to 2.30 am. The whole environs and character of the pub will be changed as realistically it is a rural pub in a residential area and not an entertainment venue in a city centre near other similar clubs and eating houses.

I ask you to carefully consider the application made by Hall & Woodhouse Limited and realise the impact this could have on those of us who live in earshot of the pub, remember please this is a residential area. My family and I do not object to the

existence of the pub, though we are sad at its' decline, but we do very strongly oppose the proposal to extend the hours in which nearby residents are forced to listen to gratuitous noise.,

May I finally point out that the copy of the notice of application was displayed in the rear window of the pub, situated such that only a minority of visitors to the pub would have been aware of its' existence and passers-by oblivious. It would seem that the applicators wish for very little public discussion of their wishes.

I understand that the application is in part for an extended licence to 01.30 a.m. and for refreshments to be served until 02.00 a.m. together with a variation to the entertainment licence. (I do not have details as I cannot locate the application on your web-site).

The pub concerned is situated in the middle of a residential area, and as such the granting of an extended licence until the early hours would prove disruptive to the local residents, both from the point of view of noise from the building itself, and the ability of drinkers to call in at the pub on the way home from the town centre to have further drinks. This would undoubtedly cause noise and vandalism locally. Our bungalow is only 100 metres from the pub car park, and on a direct cut-through to a local estate and we have no wish for additional traffic and passers-by late at night.

Furthermore any ability on the part of the pub to have a disco or other band at the premises would have the same result.

I have no problem with the pub with its existing hours. However recently this escalated into property damage to the rear of our property with fencing being dislodged and entrance to our front property being used to collect garden gravel and used as missiles. Recent noise levels from the Hunters Lodge has also increased over the summer as if the night of Karaoke is a nice summer evening the windows are open and those drinking in the garden join in with the entertainment, sometimes to our entertainment and sometimes not.

## License application - Hunters Lodge Public House, Southampton Road, Ringwood, Hampshire

It has come to our attention via an anonymous letter that the an application has been made by Hall and Woodhouse/ Maria Urwin & Doug Scrimshaw for a new license which essentially involves the extension of the liquor license until 1.30am and a similar extension of the entertainment license.

My husband and I live directly opposite the pub and from time to time frequent it. We have not been made aware of this application by the licensees neither was the notice evident in the pub. The notice of this application is in the rear window of the pub overlooking the car park and is not near the entrance. This immediately strikes us as being slightly underhand and certainly not public spirited.

Doug and Maria have been the licensees for some time now and to date we have not had any major issues arising from the way in which they manage it and I infact worked there for over a year whilst I was completing my studies at University.

However that aside we have a number of reservations relating to the granting of this license, I will for simplicity list them below:

The pub is situated in a residential area with its nearest neighbours all being houses. We do hear the entertainment, on a Saturday evening in particular, although as this finishes promptly with the customers being quickly dispersed it has not been a problem. However if the entertainment continues on later and they are able to continue drinking not only does this cause a nuisance in terms of the noise but the customers will be leaving later and more intoxicated and thus will be more of a disturbance especially as our children sleep in the front bedroom of the house.

Is there going to be any additional security measures put in place? The local Police struggled to deal with the customers of the nightclub in Ringwood and as a local business person we have had to deal with several smashed windows and mindless vandalism following the customers leaving the nightclub in the early hours and fear that the extra hours drinking may result in a similar problem for the residents of Southampton Road and the surrounding areas whilst the customers make their way home.

How many other pubs in Ringwood have made such an application? Our concern is that if very few pubs have chosen to apply for a new license and the Hunters is one of only a few it will attract additional custom thus further impacting on the disturbance it may cause. In addition it is on a major thoroughfare to a high percentage of the residential areas of Ringwood, we are worried that people will leave the town centre and wander up to the Hunters for a late night drink especially now the nightclub has shut.

I am writing to you regarding the current licensing application from the Hunters Lodge Public House, Southampton Road, Ringwood.

I wish to object to any changes to the existing license for the Hunters Lodge on the grounds of noise and disturbance, in what is a purely residential area of Ringwood.

My house, No. 101 Southampton Road is almost directly opposite the Hunters Lodge and we are regularly disturbed by the noise from members of the public leaving the public house after closing time, particularly during the weekends. This disturbance, whilst unnecessary is manageable because we know that it will not go on past midnight, based upon the current hours of opening. Our main bedroom faces outwards, directly towards the car park of the Hunters Lodge and I feel it is unacceptable for these disturbances to be permitted later by the granting of extended opening hours, which will in turn to lead to more disturbed nights and a lack of sleep. Even now, with double glazing, we are unable to sleep with the windows open, due to the noise from the public house at closing time.

In addition, the Hunters Lodge currently runs entertainment such as disco's or karaoke, which is so loud it can be clearly heard outside of the building and in our house over the road - any extension to the opening hours I believe will only see an increase to the nuisance caused by these events in the Hunters Lodge.

I trust that you will consider our views when reviewing the licensing application which has been made by the Hunters Lodge.



The application by the above pub could result in adding to the problems already experienced by adjacent property owners.

Apart from the noise factor, which could escalate from extended hours, there is also the regular Karioki nights, which are ok for us within the current hours, but would be a problem if the singers or groups went on any later, into the night.

There is already a problem in Southampton Road, where groups friends move from the Hunters Lodge, on many weekend evenings, and trundle on to Ringwood. Later after 11.30 - 2.00/3.00 am, they return, somewhat the worse for ware. They return towards Poulner, usually unaware that many other folk are now in bed.

The Police have improved matters in this direction recently, after neighbours, including us, advised them, that home bound locals, would relieve themselves along the route, including my garden, and of the general racket, experienced most Friday and Saturday nights, caused by some individuals.

One night a ladder, I had left flat in our front garden, was taken. The drunk then ran up the road to a neighbour where it was placed on a wall, with such a racket that the neighbour opened his bedroom window, and in a state of shock, to be confronted by the drunk on the ladder. The drunk, then ran down the road with the ladder to deposit it in the roadway.

Other youngsters have run over cars, causing dents in car roof etc.

One chap would return from Ringwood swearing continuously and quite loudly, for weeks, he, fortunately has disappeared recently.

We are therefore concerned that if the Hunters, gets its extension it could also be a magnet for others to come back from Ringwood, and stop off for even more refreshments, entertainment, etc. An extension, particular for some hours will only extend the problems already experienced, not just those around the Hunters but all the Southampton Road along to Poulner.

I understand the government are already bringing in plans to give the Police more powers to kerb drink problems, whatever else happens we should wait to see how effective these powers are. Also at a time when health authorities are warning that excessive alcohol consumption, is damaging peoples health, particularly among the young, this application, if granted, would only add to this greater problem.

There is separate problem!, the state of the large Hunters Lodge car park. It seems the Manager/owner, might keep a tidy pub, but the car park is littered with bottles, tins, cigarette boxes, and general litter. There seems no attempt made to have a clean up. If an extension etc is granted, it should be made a condition that he clears the car park of rubbish, mostly generated by his customers, on a daily or weekly basis.

Ringwood is after all the gateway to the NF National Park, regardless of Licensing laws.

#### ON LICENCE

#### 1. Permitted Hours

Alcohol shall not be sold or supplied except during permitted hours. In this condition permitted hours means:

- a) On weekdays, other than Christmas Day, Good Friday or New Year's Eve, 10am to 11pm
- b) On Sundays, other than Christmas Day or New Year's Eve, noon to 10.30pm
- c) On Good Friday, noon to 10.30pm
- d) On Christmas Day, noon to 3pm and 7pm to 10.30pm
- e) On New Year's Eve, except on a Sunday, 10am to 11pm
- f) On New Year's on a Sunday, noon to 10.30pm
- g) On New Year's Eve from the end of permitted hours on New Year's Eve to the start of permitted hours on the following day

#### Restrictions

The above restrictions do not prohibit:

- During the first twenty minutes after the above hours the consumption of the alcohol on the premises;
- During the first twenty minutes after the above hours, the taking of the alcohol from the premises unless the alcohol is supplied or taken in an open vessel;
- During the first thirty minutes after the above hours the consumption of the alcohol on the premises by persons taking meals there if the alcohol was supplied for consumption as ancillary to the meals;
- Consumption of the alcohol on the premises or the taking of sale or supply of alcohol to any person residing in the licensed premises;
- The ordering of alcohol to be consumed off the premises, or the despatch by the vendor of the alcohol so ordered;
- f) The sale of alcohol to a trader or club for the purposes of the trade or club;



# OFF LICENCES AND OFF SALES DEPARTMENTS OF ON LICENSED PREMISES

#### 1. Permitted Hours

Alcohol shall not be sold or supplied except during permitted hours. In this condition, permitted hours means:

- a) On weekdays, other than Christmas Day, 8am to 11pm

- c) On Christmas Day, noon to 3pm and 7pm to 10.30pm
- d) On Good Friday, 8am to 10.30pm

#### Restrictions

The above restrictions do not prohibit:

- During the first twenty minutes after the above hours, the taking of the alcohol from the premises, unless the alcohol is supplied or taken in an open vessel;
- b) The ordering of alcohol to be consumed off the premises, or the despatch by the vendor of the alcohol so ordered;
- c) The sale of alcohol to a trader or club for the purposes of the trade or club;
- d) The sale or supply of alcohol to any canteen or mess, being a canteen in which the sale or supply of alcohol is carried out under the authority of the Secretary of State or an authorised mess of members of Her Majesty's naval, military or air forces;

2. Alcohol shall not be sold in an open container or be consumed on the licensed premises.

#### 3. Credit Sales

Alcohol shall not be sold or supplied unless it is paid for before or at the time when it is sold or supplied, except alcohol sold or supplied to a canteen or mess.
