# 6. Decision of the Sub-Committee

The application is granted on the following terms and conditions.

#### Licensable activities and times permitted:

M: Supply of Alcohol

Monday 10.00 to 22.00 hours Tuesday 10.00 to 22.00 hours Wednesday 10.00 to 22.00 hours Thursday 10.00 to 22.00 hours Friday 10.00 to 22.00 hours Saturday 10.00 to 22.00 hours Sunday 10.00 to 22.00 hours

#### Hours premises to be open to the public

Monday 06.00 to 22.00 hours Tuesday 06.00 to 22.00 hours Wednesday 06.00 to 22.00 hours Thursday 06.00 to 22.00 hours Friday 06.00 to 22.00 hours Saturday 06.00 to 22.00 hours Sunday 06.00 to 22.00 hours

# **Mandatory conditions:**

As provided in the Licensing Act 2003

#### Other conditions:

- 1. Any CCTV should be installed and maintained at the premises to the satisfaction of the Licensing Authority and Police. As a minimum it shall enable surveillance of both internal and external areas of the premises including all entrances and exits. Recordings from the system shall be to a standard acceptable as evidence in a court of law and shall be securely retained for a minimum of 30 days after the recording and shall be surrendered to Hampshire Constabulary or the Licensing Authority immediately on request.
- 2. The holder of the premises licence shall ensure that every individual who appears to be under 21 years of age seeking to purchase or be supplied with alcohol at or from the premises shall produce means of identification of a category to type previously agreed by acceptable to the Licensing Authority providing that individual to be 18 years of age or older. If the person seeking alcohol is unable to produce acceptable means of identification, no sale or supply of alcohol will be made to or for that person.
- 3. While the shop is open for service of alcohol to the public there will always be a personal licence holder on the premises.
- 4. Between the hours of 19.00 22.00 hours the staffing levels at the premises shall be at least two persons.

#### 7. Reasons for the Decision

The Sub-Committee carefully considered the evidence, both written and oral, supplied by the parties.

In respect of the start time for the sale of alcohol the applicant varied the time from 8.00am to 10.00am in response to a concern expressed by the Sub-Committee about the potential of school children seeking to acquire alcohol prior to attending school.

The Sub-Committee heard from Mr Coy that in the two years that he owned the station that there had been no attempted break-ins; whilst the alarm had gone off a few times, this was down to a fault and not as a result of a break-in.

The Sub-Committee considered that the sale of alcohol would not result in an increase in anti-social behaviour amongst young people as long as the staffing levels in the service station were increased to two between the hours of 19.00 and 22.00 hours.

The Sub-Committee considered that there was no highway impediment to granting the application. This would act as a deterrent to anyone seeking to cause trouble whilst the premises were open.
