#### 7. Reasons for the Decision

The Sub-Committee carefully considered the evidence, both written and oral, supplied by the parties.

The Sub-Committee were satisfied that although the residency of the Objectors was not within the 'vicinity' in its broadest terms under the Act, they demonstrated that they would regularly use the main road on which the premises was situated and lived within the town the supermarket and filling station were intended to serve. The Sub-Committee was therefore satisfied to take on board their concerns.

The Sub-Committee heard from the Objectors of their concerns that the sale of alcohol at premises attached to a filling station could increase the incidences of drink driving and could cause further congestion on an already busy road. However the Sub-Committee considered the evidence from the Applicant that there were sufficient checks and balances in operation within the premises to ensure the maintenance of the four licensing objectives satisfied these concerns. The Sub-Committee also considered that there was no highway impediment to granting the application.
