

I wish to withdraw my objection to the licence application for Finn M'Couls in Ringwood. This is on the basis of the significant change from their initial application, and the agreement of further conditions on their licence. It should be clarified that this department has received no complaint with regards to the current operation of the premises.

The premises has now requested that:

- 1. People can use the garden until midnight on Friday and Saturday nights, Christmas Eve, New Years Eve, St Patricks Day and Pedal Car Race Day Only. They have asked for the following condition to control this activity: "Between the hours of 2300 and 0000 when the patio is open. It shall be attended at all times by a member of staff. The duties of that person shall include ensuring that the patio area is used in a responsible fashion and that noise is kept to a minimum, this shall include taking all reasonable steps to reduce shouting, screaming and other loud vocalisations that may cause nuisance to neighbours".
- 2. They wish to have live music until midnight all year round indoors only (365 days a year). They have offered the further condition that "Noise from amplified music and amplified voices emanating from the premises between 2300 and 0900 will be inaudible when measured at the boundary of all noise sensitive premises". There is already a condition specifying the noise levels prior to 2300.
- 3. They further want to have recorded music (not live) in the garden until 9pm, no more than 12 times a year.

I wish to object to this application.

Following a discussion with the landlord and e-mail correspondence with the applicants solicitors they have agreed to lessen what they are applying for to:

- 1. That people can use the garden until midnight, Friday and Saturday nights, Christmas eve, New years eve, St Patrick's Day and Pedal Car Race Day, we will have supervision by security or a licensee on these days in the garden.
- 2. We can have live music until midnight all year round indoors only (365 days a year)
- 3. We can have recorded music in the garden until 9pm, no more than 12 times a year.
  - All other conditions on our license will remain the same.

This would reduce significantly the potential impact on neighbouring properties over what they had applied for. I have included the correspondence below.

At the time of writing this objection the applicant has not agreed in writing to the addition of two further conditions on their licence, one with regards to the role of the landlord and security guard in the rear patio area and one to deal with the music noise level from events held inside the premises after 2300. These have been agreed verbally with the landlord but I waiting to hear back from the solicitor with regard to this matter. I believe that he is on leave until the 7th September.

With out these additional conditions in place that I am concerned that there maybe public nuisance from the activity and it is on this basis that I wish to object. If these conditions are agreed to (or conditions which achieve the same) then I would be happy to withdraw my objection.

The first condition refers to the use of a member of staff to limit the noise impact from people using the patio. I have come up with a form of words but am happy to look at your suggestions for the wording of a condition to achieve the same thing.

1. Between the hours of 2300 and 0000 when the patio is licensed to be open. It shall be attended at all times by a member of security or the licensee. The duties of that person shall include ensuring that the patio area is used in a responsible fashion and that noise is kept to a minimum, this shall include taking all reasonable steps to reduce shouting, screaming and other loud vocalisations that may cause nuisance to neighbours.

With playing music inside the premises after 2300 as agreed with the licensee may I suggest the

Extension of Licensing hours and planned revamping of Finn M'Coul Public House, Ringwood

Further to the proposed changes in music entertainment and licensing hours at Finn M'Coul's public house in Market Place, Ringwood, I am writing to register my strongest objections to such a proposal. I cannot comment on the planned revamping of the area, because I have yet to see the planning proposals; they are not on the NFDC website.

In effect I am raising objections under two heads: Public Nuisance and Prevention of Crime and Disorder.

Public Nuisance: If the Licensing Authority goes ahead with these proposed changes in time and frequency of musical performances, I am sure it must be unaware that there are private houses and flats with bedrooms and living rooms overlooking Finn M'Coul's garden area and next door to the public house and that this proposal infringes the human rights of the occupants of these premises. Already customers stay on the Patio Area until 12 a.m., which is an hour later than that agreed in the licence and they cause a great deal of annoyance.

I also notice that there would not only be an increase in the frequency of amplified and unamplified live and recorded music performances but also a relaxation on the number of performers and gigs inside the public house and outdoors. Having relatively recently been serenaded by a singer bellowing his way through a popular number through the whole of a Sunday (it may have been more but they all sounded the same), I can assure you that it is not conducive to a pleasant, relaxed and civilized environment. This kind of noise pollution is not acceptable and certainly constitutes a public nuisance in a residential area.

With the last makeover of Finns, I did complain about the bright side light that shines directly into my bedroom window and frequently is not turned off until 12.15 a.m. at weekends or, on occasion, even as late as 1a.m./1.30 a.m. I mention this because I noticed from your website that this is not considered to be a satisfactory situation when the light is so close to private premises: but of course nothing significant has been done about it. I could not fill in the diary forms because I became ill after this and actually this should not have been necessary, a quick look, as taken by the Environment Officer, should have made it apparent that this situation was was not viable.

Prevention of Crime and Disorder: Already at the weekend there is a high level of noise from people going into and leaving Finns as well at those congregated around Keskins and Legends. I accept that a certain amount of noise is to be expected over the weekend (Friday, Saturday, Sunday), but it can continue until 1 a.m. or 1.30 a.m. with people waiting for transport and generally skylarking around and it is beginning to become too much. It is also quite worrying as there are two quite vulnerable shops under these premises; one of which has certainly experienced problems.

I hope you will take account of these points when making your decision and protect old Ringwood so that it can continue to attract adults who appreciate the surrounding buildings and dignity of the area and are not led to feel they are in a rundown student area of Bournemouth.

The Town Council wishes to OBJECT to the Application for Variation of Premises Licence by Finn M'Couls on the grounds that it would infringe or violate the licensing objective for prevention of public nuisance.

There are a number of residential areas that would be affected if the application were to be granted, particularly those in George Mews, Handley Court and around Strides Lane and Deweys Lane. Therefore, the Council believes that, due to the location of the establishment, it would not be appropriate to grant the application for the following reasons:

- 1) To remove the condition that "the patio shall not be used by customers after 23:00hrs" will result in the patio being used for the duration of the establishment's already extended opening hours. We understand that the existing licence allows for alcohol to be sold until 1am Monday to Wednesday, 2am Thursday to Saturday and midnight on Sunday. The Council believes that this would create an unacceptable disturbance to residents in nearby properties.
- 2) The Council does not accept that the establishment should be given carte blanche for live music indoors, due to its proximity to a number of residential properties.
- 3) There appears to be no restriction on the request for 8 live outdoor music events per annum. The current licence restricts these events to 4 per annum, with no more than one of those being amplified. The Council believes that any increase in the number of outdoor music events would have a detrimental impact on the residents of the surrounding properties, particularly if all of those events were to be amplified.
- 4) The Council does not accept that the establishment should be given carte blanche for recorded music played outdoors or that the finish time should be extended to 23:00hrs. Again, this is due to the proximity of the establishment to a number of residential properties.
- 5) As you are aware, residents of George Mews have been particularly affected by the significant problems associated with Legends Cue & Sports Club at 17 Market Place, just a few doors down from Finn M'Couls. The Council is therefore concerned that any increase in disturbance which would result from the granting of this application, would have a cumulative impact on those residents.

I write with reference to the application by Finn M'Couls public House, Ringwood to alter the licensing terms.

May I lodge a total objection to the altering of any part of the license being tampered with. The reasons are 1) Public Nuisance, and 2) anti social behavior and /or Prevention of crime On the one hand, the noise element, is more than

disturbing, in what is primarily a residential area to the rear of the premises.

The town is already well served with premises that have a music license, and I feel to extend the time and frequency

would be detrimental to the peace and quiet the residents are entitled to. The increase in noise has been considerable

since the smoking ban has driven most of the customers into the car park until the early hours, where they are very rowdy and noisy and anti social.

Secondly, on a public nuisance side, the number of persons, urinating in the alleys and car-park access, has been found to have increased, and for that reason I would also urge a ban on any further variation to the license. Simple health and safety should be paramount.

I am somewhat disturbed by the application made by Punch Taverns to what amounts to seeking permission to legally make a public disturbance. This area is a conservation area, and is a very pleasant area to live. We do suffer from noise problems when the weather is hot when Ringwood Social Club have live bands playing, and they leave the rear door open to give a cooling effect. But Ringwood Social Club do operate strictly to the agreed timetable.

I oppose this application on the grounds of noise pollution. I write as the owner of 10 The George Mews, Ringwood, in respect of the above Licensing Application and must advise that I object most strongly to the amendments contained in the Application.

#### Public Nuisance

As you will be aware, George Mews is a residential area adjacent to the Finn M'Coulls Public House and any further easement of the existing Licence relating to playing of music will make life for the residents unbearable and cause a public nuisance.

If 8 live music sessions are allowed outside, as well as recorded music until 2300 hours each day, it will cause a lot of noise pollution for the George Mews Residents. At present recorded music is restricted to a maximum of 8 occasions outside per annum and must finish by 2100 hrs which is just about bearable but the new Application requests unlimited recorded music indoors and outdoors until 2300 hours plus the 8 live music events outside. This will have a direct impact on those living in George Mews which is in very close proximity to the premises concerned.

In addition, if the condition 'the patio shall not be used by customers after 2300 hours' is lifted, this will lead to more people outside with the accompanying noise.

I thought that the NFDC's Statement of Licensing Policy relating to Public Nuisance stated that stricter conditions would be applied in respect of areas having denser residential accommodation such as George Mews.

#### Prevention of Crime and Disorder

If 1 Sic is to be played outside Finn M'Coulls more regularly, this will encourage customers to drink and congregate outside also which will lead to an increase in noise level and drinking in and around the car park area which is adjacent to George Mews. Any extra activities at the back of the pub may encourage an increase in crime and vandalism to both vehicles and property.

I trust that the variation to the existing Premises Licence will be refused.

With respect to the above application we would like to state our objection to the proposed change to the restrictions on performance of live & recorded music.

When Punch Taverns developed Finn M'Couls in 2008 it did so knowing that it was in close proximity to a residential area where any amplified music or large crowds would disturb local residents and intrude upon their privacy, and the License restrictions in place reflect this. Indeed, even on the limited occasions when there has been music performed at Finn M'Couls we have been disturbed and unable to enjoy our own garden and keep the door and windows closed for an afternoon & evening until the cessation of the entertainment at 21.00 hours.

We would therefore strongly suggest that removing the existing restrictions such that live & amplified music could be played at Finn M'Couls as frequently as they wish and until 23.00 hours at night is wholly unacceptable.
