- The area in the front of the premises is only situated 6
 metres from the objectors front window where people
 can sit and look straight into the objectors home.
 Frequently the objector has had to go and pick rubbish
 up from the premises, cigarette ends and serviettes.
- The front door of the premises has been wedged open in the past, increasing noise from people talking loudly in the bar which can be heard in the residents home.
- Since the premises opened, residents within the area have found the noise levels generated from the premises intrusive, particularly in the evening when customers have left by the front entrance. It is felt that any extension to these hours will only magnify problems still further.
- It is further suggested that the door on the opposite side
 of the building which opens into the Marina should
 become the entrance after 18:00hrs. This would
 significantly reduce the noise nuisance caused by the
 business for local residents.

Public Safety

- It is felt that this area is not suitable for a late licence as the residential properties are in such close proximity.
 There is a lack of parking facilities for the premises which is situated on a busy narrow road.
- Bath Road is one way and a narrow paved area, individuals or groups leaving the premises at night under the influence of alcohol is at high risk of injury from vehicles.
- Unlike the busy High Street, where most late night activity in Lymington takes place, here there is little street lighting, a dark expanse of boatyard into which anyone can walk and there is a low police presence.

I wish to protest in the strongest possible terms to the application of "Fine Food & Wine 4 Sail" to extend the licensing hours of their business.

Eighteen months ago I, and several others, objected to Mr Bayntun's original application for a license to serve alcohol on his premises opposite my house in Bath Road. As a result of our objections, a Hearing was held at Lyndhurst in June 2008 where the Licensing sub-committee listened to both the applicant and the objectors before agreeing to allow Mr Bayntun a license that was limited to the hours of 0900 – 2100 and which did not allow use of the front of the building in the evenings. I was obviously disappointed that a license had been granted at all but I did feel that the committee had made a very fair judgement in the circumstances.

Last week, whilst reading the Lymington Times, I noticed that Mr Bayntun had made a new application. We therefore looked for the notice that was supposed to be displayed on his premises and discovered it "Hidden from View" by their awning in a position so high that it couldn't be read! (It has now been moved down and can be seen). This new application is applying for everything we originally protested about i.e late night drinking, music and sitting on the forecourt outside my front windows.

The only thing that has changed since his last application is the size of his premises! Mr Bayntun has recently rented the property next door to the original bar which he has called "The Mess". This increase in capacity will obviously mean more customers, more cars, more noise and more nuisances.

During the last eighteen months there have been times when the existing Bar has been open far later than it should have been which has resulted in complaints to the appropriate authorities from another protestor. It seems to me that the applicant has a very cavalier attitude towards the alcohol license and only agreed to the original conditions believing that he could either ignore them or have them surreptitiously modified. Please do not allow him to get away with it.

I unfortunately suffer from ill health and need a peaceful area to live in; I have to go to bed early as I need plenty of rest. The extra noise created by the extended hours would be very detrimental to my state of health both physically and psychologically.

My partner also retires early as she starts work at 06.30 six days a week. Living here is ideal as she works next door and is close if I should need her in a hurry as I did when I had my second heart attack. Besides which we can not afford to move any where else.

We already have a great loss of privacy from the bar as we live opposite and since it extended into the adjacent unit they are now directly opposite our front window and next summer we fully expect them to extend there tables across in front of there extended frontage. I never saw any notice applying for the extension or change of usage to this unit which was an office.

Our house is only very small so we can not sit in a different area to avoid being observed from the seating area outside the bar. The noise of people outside echoes around the narrow street and even more so at night which would be unbearable in the summer when we like to have our windows open. The noise going on till 21.00 is bad enough but for it to go on until 23.30 would be too much to bear.

With the extension of there premises and the extension of opening hours the noise levels would increase dramatically. Not just peoples voices, shouting and laughter but their cars, motor bikes etc.

There is no further mention of recorded music, which can of course be just as intrusive as live music when the volume is turned up. The beat of rock and heavy-metal late at night, or at any time when the rolume is not under strict control, would badly expect the quality of like of many residents, largely retired, who live in this hitherto quiet corner of Lynington. I went on to Mr Baynton's website to find that he was advertising that he could cater for 60 people inside and a further 60 outside, this seems to be totally in breach of the original description given by him. It has made me have sleepless nights worrying about what he will do next. I have enclosed a page from the website. I feel that the original license was issued on the basis that it would mainly be a shop and off license where people could have a glass of wine when they come off their yachts, he is now trying to make it into a large restaurant and bar.

I was also reminded that we had a second episode of vandalism in front of his bar and the café (now shut down) again this was never heard of before they existed and was only possible due to all the signs, tables chairs and pots left out at night.

I also re-read the original licensing agreement which claims that he would be shut on Mondays. He has in fact been open on the bank holidays.

Please accept this as my official objection to the extension of licensed hours for the premises known as "Fine Foods for Sail". When the application was put in for eighteen months ago I opposed it then and wrote to you (copy of which is enclosed) and attended the meeting held at Appletree Court. When I attended the meeting I was very impressed by the way we were listened to and that one of the council members had even taken the trouble to come to our road and see what we were objecting to. He agreed then that it would not be good for us to have the bar (and that is what it is) open after 21.00.

At the original meeting the people from 'Fine foods for Sail' claimed it was going to be mainly for quality food's and claimed it was to be a shop, "Fine food 4 sail is a delicatessen, it will sell food, coffee and wine as an off licence" this was in a letter from Kenna Dacre just before the last hearing. I can honestly say that in the last year I have never seen anyone walking out with food to take away. They provided photographs of shelves full of food stuffs which are now full of alcohol. They are in fact listed in Yellow pages under 'bars', not under delicatessens as they implied the premises main purpose would be.

Since the bar has opened there has been several times that the terms of his license have been ignored, with hindsight I realise I should have complained at these times to keep you in the picture. For example people outside the front drinking after 17.00, (notices to advise customers this is not allowed are often covered by chairs, bikes etc.), people drinking in the bar after 21.00, people being served after 20.30, the front door propped open, I do not think he has installed the CCTV that was on the original agreement either etc.

Traffic has increased in the evenings in our single track road, there is increased noise levels from car doors being slammed, horns being blown, squealing tyres and shouting and swearing in the street. This is a very narrow road where cars have to

give way to each other either side of our row of houses which often causes sharp braking etc.

The area in front of the bar is only about 6 metres from my front window and people sitting out side look straight in. The wind blows rubbish across the road and I have often had to pick up cigarette ends, serviettes and rubbish from outside the house.

Groups of people hanging around outside is very intimidating for the local population, many of whom are elderly and live alone. We have even had a window broken in a house in the road just after the bar opened this may be completely coincidental however until we had the bar this never happened. In the original application they mention one table with four chairs they now have several tables with approximately 20 chairs, and I am sure this number will increase this year due to there increased frontage.

I have never seen any form of planning application notice for the brassiere they have now opened in the next door building that used to be offices, or in deed for all the signs and logos. This building is even closer to our front windows. In fact is directly opposite. Now they have the extra area this will mean they are capable of serving more people and that only means increased noise levels, increased traffic levels, increased lack of privacy, increased fear levels for local residents, increased rubbish, increased alcohol consumption etc. This will mean it will be even noisier at 21.00 so please please do not let them stay open later.

When I heard about the application for extended hours I went to see if there was a notice up. It was not visible from the road and was only when I stood right outside the bar I saw the notice, I could still not read it clearly as it was in the top left hand corner partially obscured by the writing on the window.

The street is no longer peaceful in the evenings and extended hours would mean extended noise and greater drinking times would mean greater volume. Especially if people are allowed to sit outside the front.

Please do not allow this extension to the hours as it will ruin our lives having to cope with the disturbance later in the evening will disrupt our lives, the noise levels will go up the traffic will be greater so there will be more risk to pedestrians, and the nuisance to us will be considerable.

Thank you for your letter dated 11 December 2009 advising that a revised application has been received.

As before I wish to object to the variation of the existing license to the above premises for the following reason:

The building opens onto an area which until the arrival of this business was quiet from evening until morning as all adjacent businesses operate normal business hours.

The present licence, which was supported by the landowner, sought to limit the opening hours to maintain the peace and quiet in this residential area.

I can confirm that one of the residents opposite has regularly phoned me since the premises opened asking for support as she was finding the noise generated by the business to be intrusive particularly in the evenings and when customers have left by the front entrance outside licensed hours.

Any extension in time will only magnify the problems already being experienced and I ask you to reject the new application.

Further I would ask you if it is possible to amend the existing condition such that after 6.00pm the door opening onto Bath Road should be used only as a fire exit. It should not be allowed to be used as an outdoor smoking area nor as a routine exit from the business.

There is an alternative door on the opposite side of the building which opens into the Marina. This door should become the entrance after 6.00pm. This would significantly reduce the noise nuisance caused by this business to local residents.



Thank you for your letter of 11 December informing me of the new variation application. I do reaffirm my views as set out in my original letter of objection.

I do not consider that the amendments, as set out in your letter to me of 11 December, make the application acceptable.

Sale of alcohol until 2300 and premises opening hours until 2330 are both still late and, in my view, out of place in this otherwise quiet residential area. Moreover the proposed extension for Sundays is even less acceptable than the original proposal.

Increasing the floor area increases the potential numbers at the premises, increasing in turn the probability of excessive noise.

I do not believe that the proposed restriction of the external area after 2030 hours is realistic. Will the staff of Fine Food really make customers who are in the middle of eating and drinking at 2030 move immediately away from that area? And, even if they did, is it realistic to suppose that all such customers, after having comsumed a few drinks, will move quietly? Who will ensure compliance with this restriction? Our Police Force are already too stretched. Will Fine Food be employing staff after 2030 to ensure that the last customers really do use the external area solely for the purpose of egress (and quiet egress) from the premises?

Even if it were possible to keep the external area empty and quiet after 2030 which, as I have indicated, I do not think that it is, noise will spread though open doors and open windows, disturbing the neighbourhood 7 days a week until late.

I am concerned that comments need to be with the Council by 8 January. A large number of residents are away over the Christmas and New Year Holiday and will therefore lose the ability to make their objections known. Even extending the 8 January deadline would not deal with this problem unless you were to give notice to all concerned of the extension. If the deadline is not to be extended with appropriate notice given, I trust that you will take into account when considering this amended application that there would have been more numerous objections to it had those affected been received actual notice in time.

I am writing in response to the letter ref PWL/LICPR/08/00010/SW Fine Food 4 Sail.

The amendments listed in the letter 11/12/09 are unacceptable. The area is a residential one, the boatyard work finishes at 1700 each day Monday to Friday and there is no disturbance outside those hours.

Whilst I can see that some form of cafe/bar is a benefit to the marina users, that trade will be limited to the sailing season, the real trade that the bar is looking for is the town trade, the sort that uses Longs, young, noisy and heavy drinkers.

Sale of alcohol on and off — is this really needed, there is Tesco open until 2200 selling alcohol, does Lymington really need another off sale point??

The extended opening hours – if you recall in the original application this was asked for then but changed to allow the licence to be granted, now the owner is trying to get this back having initially accepted the shorter hours.

No tables and chairs after 2030 – do you really believe that the staff will be asking people to vacate tables and enforce it? Or that customers will simply say 'Oh ok 'and move inside half way through a meal ?? Course they won't, that condition will be agreed and then ignored. The distance from the front of the bar to the houses across the road is very short 25'?? isn't there some legislation that prohibits the ingress and egress from a licensed establishment within a certain distance of residential property?. The noise from people leaving even if behaving reasonably will be unpleasant, just the normal goodbye chat etc., never mind if they are drunk. There is already a problem with groups of people who have been drinking walking down Bath Rd to the town late at night shouting and on occasions screaming. The Woodside Garden Park in the evenings is frequented by groups of young adults drinking alcohol — an early morning walk will show the empty cans and bottles of booze from the previous night.

Where will the cars be parked-there are no carparking spaces near the bar, has Berthons agreed that the bar customers can park in the marina?

Fine Food4 Sail are trying to get now what they weren't able to have granted initially, music, extended opening hours, outside tables. The reasons for these not being granted are still the same, it is a residential area, there are plenty of places in Lymington (in appropriate situations) where alcohol is sold until late. I feel that the NFDC has a responsibility to consider the type of place that Lymington is, the tourist trade (which is a high standard) and the problems that alcohol brings with it. The initial response from FF4S when the licence was granted of being considerate to the area and people living close by was just a smokescreen, they always had the intention of reapplying, they have no interest at all in the area and the discomfort that music, outside drinking, extended hours will cause to the local residents.



We write to object to the application on the following grounds.

1 Inappropriate Location For A Late Night Bar Brasserie and Off Licence.

The premises are immediately opposite private houses and has residential areas close by which will be affected by increased late night nuisance, increased parking congestion and late night noise (see objections 2,3 and 4 below).

2. Late Night Nuisance in the Surrounding Area.

Members and Officers of the Council will be aware that late night drinkers, after leaving the Mayflower Pub congregate in the Recreation Ground opposite the river in South Bath Road and the noisily disperse along Solent Avenue and other local roads.

The proposed late night opening of the bar/brasserie ("Fine Food 4 Sail") will materially increase the problem of noisy dispersal of late night drinkers and will materially reduce the living standards of the residents in the area.

3. Lack of Appropriate Parking.

The premises lie towards the Northern End of Bath Road which has a section of narrowed roadway and is subject to a double yellow line parking restriction throughout.

We are writing to lodge our objection in respect of the above application to extend the premise's late night alcohol and music license to 23.30hrs, seven days per week.

As a relatively new resident from London we are all too aware of how much disturbance such a late license can have in predominantly residential areas. The immediate and surrounding area within which Fine Food & Wine 4 Sail is set is mainly residential and is an integral part of Lymington's charm. Such a use would not only cause intolerable problems for its residents but change the landscape of this area.

Extending hours to 23:30 hours every night of the week would mean absolutely no respite for residents in this area. The property in question has an open terrace area and the late hours and noise within the close proximity of compacted housing to the sides and front of the property would no doubt cause a great deal of distress and disturbance to residents sleep and right to peaceful enjoyment of their homes. This would be seven days a week until at least midnight every night by the time revellers and patrons leave the area.

As well as noise pollution there would also be the issue of increased parking and traffic in an already busy area; residents already find it difficult to park near their homes. The only immediate unrestricted evening parking would be in residential areas which are already heavily congested by parking and traffic, especially in the summer months when this bar is likely to be at its busiest. Indeed, we have been surprised by the volume of traffic and the lack of any parking restrictions or traffic calming measures.

On a personal note, our side of Nelson Place has experienced intolerable issues with parking and being able to access and exit our premises. So much so, that we have found ourselves in extremely difficult circumstances of not being able to leave our home by car in emergency situations let alone whim. This is because drivers park, inconsiderately, opposite our garage as there are currently no restrictions. It is a very narrow road and there is no space to be able to access/exit our garage if a vehicle has parked opposite. This has resulted in us effectively being "stuck" at home once our cars are garaged. We have even considered calling the police during one emergency situation where we had to travel.

We will be writing to the council under separate cover regarding this issue however increased parking, which another bar would bring, can only add to parking congestion and the well regarded Lymington Rowing Club who only have Nelson Place available to park. Patrons of this bar could only park in already saturated residential areas.

from people leaving various quay side establishments at night, especially at the weekend and during the summer months, let alone seven nights a week. This noise and disturbance is coupled with the issue of people having drunk too much, shouting, smashing bottles etc etc. Many of the residents are hard working people with long hours and early starts, something not conducive with having to put up with noise until very late at night. Unlike "Fine Food & Wine 4 Sail" we don't have the luxury of opening our business late in the morning or the advantages of shift work. Surely we have an expectation of peace within our homes, especially after a hard day's work contributing to the local economy, which was the expectation when we/other residents moved to this area.

Granting such an application would be hell for local residents who would suffer unnecessarily just for another late night venue – surely there are already enough in Lymington – and a business making money. If this application were allowed it would come down to one business profiting at everyone else's misery.

Given the issues we already have to deal with in this area I fail to understand why this application is even being considered.

We therefore object strongly to this application and we would like our objections from Sue Sparks and Andrew Daton-Lovett of the below address to be duly noted. We would appreciate confirmation of receipt of our objections.

My name is Catherine Ryan. I am seventeen years old and currently am studying at Brockenhurst College until 2011. I live at Pier View in Bath Road opposite the bar, Fine Food & Wine 4 Sail which opened in June 2008.

Following the opening of this bar there has been an increase in noise. The front door at Fine Food & Wine 4 Sail has been wedged open many times so I can hear people talking loudly in the bar across the narrow street in my room. I have been disturbed by customers slamming car doors and accelerating their engines when leaving from either the car park adjacent to my home, or in front of the locked entrance gate (opposite) to Berthon Boatyard.

This application by the licensee at Fine Food & Wine 4 Sail to:

- 1. extend the opening hours until 11.30 p.m.
- 2. sell alcohol until 11.00 p.m.
- 3. sell late night refreshments 11.00 11.30 p.m.
- 4. play recorded music from 9.00 a.m. to 11.30p.m.
- 5. restrict the use of the forecourt facing our home until 8.30p.m.

every day and night of the week is excessive.

This application ignores the rights of families and individuals to peace and quiet and sleep who live in the quiet residential street opposite Fine Food & Wine 4 Sail.

Should this application be granted, I would be very badly affected by the daily increase in noise disturbance from the following:

- 1. constant recorded music being played at the premises
- 2. customers talking loudly, laughing and shrieking when using the forecourt in front of my home
- 3. increased numbers of people outside my home late at night drawn to the premises for late night refreshments
- 4. customers talking loudly and slamming car doors and accelerating their engines when they leave the premises late at night

I benefit from studying in the calm atmosphere of my home and aim to go to university when I have completed my studies at Brockenhurst College.

Thank you for your letter of 11 December 2009 regarding the new variation application by Fine Food and Wine 4 Sail, Unit 3-4 Anchor House, Bath Road, Lymington, SO41 3Y.I.

We wish to reaffirm our objection to the application to extend the licensing hours for sale of alcohol on and off the premises, to extend the opening hours and to extend the hours of use of the forecourt at these premises.

We objected in May 2008 when the original, much reduced, licence was awarded. Our arguments against this current application remain unchanged although we have no personal issues with the licence as it currently stands after the last hearing.

We live very close to the premises and we still believe a licensed property is totally inappropriate to the neighbourhood, which is a quiet residential area. We believe that extending the licensing hours would bring unacceptable noise levels during the evening and weekends, which are currently peaceful times when the boat yard in Bath Road is closed.

Bath Road is extremely narrow with a contra flow system at that point and there are houses immediately opposite that would be very badly affected by the noise. Those of us a little further away (but still within direct line of sight) would still be disturbed by the noise from smokers and other drinkers on the forecourt and from people arriving and departing.

We are concerned about the impact on the neighbourhood, particularly on children, of antisocial behaviour of inebriated patrons arriving and departing the establishment, past houses both opposite the property and in either direction along Bath Road. The current licensing hours restrict this disturbance – extending the hours into the evening would be unacceptable.

We are also concerned about the safety of local residents when faced with late night drinkers outside. This area is unlike the busy High Street where most late night activity in Lymington takes place; here there is little street lighting, a dark expanse of boatyard into which anyone can walk, and a low police presence.

We object to the use of the forecourt as a drinking area after 5pm. Any activity in this area will cause high levels of noise to reverberate off the high slab-sided shed to the north and carry across the adjacent water. This would further exacerbate the problems outlined above.

In our opinion, Bath Road is unsuitable for increased pedestrian and vehicular traffic (that would be associated with any bar or club), particularly at night, due to its narrow width and single pavement, so public safety is a consideration. There is also no real provision for parking on or off road at the premises so the increase in vehicles would be detrimental to the residents parking in adjacent roads.

The bar is aimed at attracting visiting yachtsmen from the marinas so we do not believe this facility is aimed at catering to the locals' needs. The temporary patrons would have less reason to give due regard for the neighbours peace and well-being.

Many of our neighbours are either elderly or are families with young children. They will be particularly vulnerable to the increased noise and rowdy, intimidating behaviour frequently associated with drinkers departing such premises. Young children are usually in bed by 8pm and any noise after this hour, especially in summer when houses have their windows open, will be very disturbing.

In our opinion there are already sufficient licensed premises open late at night around the Town Quay and High Street area that are in close enough walking distance from the marinas to negate the need for this establishment to extend its hours in a peaceful residential area. In the opposite direction there are sailing clubs, a bar and pub that also cater for visiting yachtsmen's needs.

At the previous hearing, when the licence hours were restricted to 8.30pm, the proprietor claimed that a misunderstanding had led to the application for late night licence – is this the case again this time, or is this actually what he intended all along?

We would also like it brought to your attention that this premises has never held planning permission status to be a bar. Therefore it should not be granted a licence to operate as such. The bar has also doubled in size since the last licence application by extending into the adjacent shop unit.

We appreciated the fair methods by which the resolution to the previous application was reached and hope that your committee will understand when we say that we are not willing to compromise beyond the current arrangement – already a step further than many of our neighbours find acceptable.

Please register our renewed objection and advise us on how the application will be reviewed.

I very strongly object to the application to vary a Premises License at Fine Food & Wine 4 Sail, Unit 3&4, Anchor House, Bath Road, Lymington.

In early April 2008, Paul Bayntun applied for an alcohol license at Fine Food & Wine 4 Sail at Unit 3, Anchor House, Bath Road, Lymington. In this application, Mr Bayntun applied for:

- opening hours: 09.00 -23.30, seven days a week.
- supply of alcohol 09.00-23.00, seven days a week, 24.00 during Cowes Week and 00.30 on Christmas Day and New Years Day.
- the provision of live and recordable music and late night refreshments.


On 16th April, 2008, the provision for live and recordable music and late night refreshments was removed.

Objection letters from local residents were sent to Licensing Services at the NFDC by 14th May 2008. On 29th May 2008, all objectors received a letter from Paul Bayntun's landlord, Brian May, Managing Director of Berthon Boat Company, confirming the terms of the lease for Unit 3, Anchor House and stating the opening hours were to be 08.00-21.00, seven days a week, 'to prevent the possibility of noise and raucous behaviour at night to protect both local home owners and yachtsmen returning from town from the possibility of disturbance'.

On 9th June, 2008, a hearing took place at Appletree Court in Lyndhurst. The decision of the Licensing Sub-Committee hearing granted:

- Sale of alcohol: on sales, Tuesday to Sunday 9.00-20.30
- Sale of alcohol: off sales: Tuesday to Sunday 09.00-21.00 these times are in accordance with the lease.
- In addition, Paul Bayntun agreed at the hearing to remove tables and chairs from the front of the premises after 17.00 daily and keep the front door closed as far as possible to minimize potential noise disturbance to local residents.

On 13th June 2008, Fine Food & Wine 4 Sail opened, the front door was wedged open and people stood outside in front chatting and laughing at 20.30. As I live with my family at Pier View immediately opposite these premises (see map below), I decided to phone Councillor Mrs. Lewis who advised me to commence a log to record all activities (below map).

This log demonstrates breaches observed in both the licensable times permitted and noise control at Fine Food & Wine 4 Sail over a period of seventeen months. These observations are limited by the fact that I work unsocial hours, including late duties and night duty.

The log was finally sent to the Licensing Enforcement Officer on 11th November, 2009, after the continued erosion of the opening hours on Friday nights throughout 2009, which culminated with this bar being open until after midnight on 6th November, 2009. Paul Bayntun was interviewed by the Licensing Enforcement Officer on 24th November, 2009, which resulted in violations of the Licensing Act 2003 being identified. This log has been sent by Licensing to the Environmental Health department at the NFDC.

The current variation application with amendments (submitted 11/12/09) applies to:

- Extend premises opening hours to 09.00-23.30 seven days a week
- Extend the sale of alcohol (on and off) to 09.00-23.00 seven days a week
- Play recorded music during opening hours
- · Sell late night refreshments 23.00-23.30 during opening hours
- Use of the outside area facing my home to be restricted after 20.30

This application is almost identical to the original submitted in April 2008 on which the hearing in June 2008 was based.

I very strongly object to this application on grounds that the licensing objectives of prevention of crime and disorder, public safety and prevention of public nuisance will not be met.

· Prevention of crime and disorder

Since Fine Food & Wine 4 Sail opened in June 2008, our front door window was smashed in the middle of the night on 14th August 2008. The police were called but no suspects identified. The window was replaced at a cost of £200.

On 5th September, 2008, the forecourt at Fine Food & Wine 4 Sail at night was vandalised by youths destroying pot plants and turning over tables and chairs; the police were informed by a 101 call. Recently, drunken youths have been attempting to climb the high entrance gates to Berthon Boat, adjacent to Anchor House at night.

The serving of late night alcohol opposite our home would lead to an unavoidable increase in anti-social behaviour and the area around my home becoming less safe. There are already a more than adequate number of premises with late night licenses within a five minute walk in the High Street which support the need for late night drinking.

Public Safety

Bath Road, between my home, Pier View, and Unit 3, Anchor House, is one way (see map) and has a narrow pavement. Public safety is of paramount importance to individuals or groups, leaving the premises at night, under the influence of alcohol, due to the risk to injury from vehicles, especially 'joyriders' who drive at speed along Bath Road at these times.

Prevention of Public Nuisance - Noise

We – my two teenage children and I have lived in Bath Road for six years. I myself am employed as a Staff Nurse at a local hospital, which is a tiring and demanding job. I work unsocial hours: early, late and night duties all year working weekends, Bank Holidays, Easter, Christmas and New Year.

Our home, is located approximately **4-5 metres** across Bath Road from Fine Food & Wine 4 Sail. This is a residential area which was quiet from evening until morning, as all adjacent businesses operated normal business hours, until this bar opened (see log).

The current variation application with amendments (submitted 11/12/09) is totally unreasonable and indicates a complete indifference to the rights to peace and quiet and sleep to those living in opposite and in very close proximity to Fine Food & Wine 4 Sail.

As we live facing Fine Food & Wine 4 Sail, granting this application will expose my family and I to very substantial increase in noise due to:

- 1. incessant recorded music being played at the premises during opening times
- 2. the attraction of increased numbers of people to the premises late at night, every night of the week, to purchase late night refreshments
- 3. customers gathered outside in the forecourt, in front of my home, talking loudly, laughing and shrieking, every evening of the week
- 4. customers talking loudly, slamming car doors and accelerating their engines when they leave the premises late at night, every night of the week

On New Year's Eve 2009, a Temporary Event Notice was given to Fine Food & Wine 4 Sail permitting the use of recorded music. On this night, music could be heard from the premises, with the door closed to Fine Food & Wine 4 Sail, until about 02.00 when the party finished.

Finally there are two issues concerning planning:

- 1. Unit 3, Anchor House, where Fine Food & Wine 4 Sail is located, only has planning permission for use as a coffee shop (Class A3).
- 2. Fine Food & Wine 4 Sail has expanded over the past few months into the adjacent office unit 4, opening 'The Mess' a deli- brasserie. No planning permission was sought.

To conclude, the decisions taken by the Licensing Sub-Committee at the hearing in June 2008 were reasonable and even-handed. Naturally, I am not willing to make concessions which erode this current arrangement.

I write to provide an update regarding this matter and the process thereafter, should your objection remain.

The following additional conditions have been agreed with Environmental Protection:

The licensee or nominated representative will receive and respond to complaints;

The disposal of empty bottles and refuse into out door storage receptacles will not take place between the hours of 19:00 and 07:00hrs;

Deliveries of consumables will not take place between the hours of 19:00 and 07:00hrs:

Waste collection contractors will not collect between the hours of 19:00 and 07:00hrs; No tables or chairs in the external area outside the shop facing Bath Road to be available for use after 20:30hrs, nor shall there be any use whatsoever of this external area (after this time), apart from customers accessing and egressing to from the premises. Notices to this effect shall be placed within the premises.

Staff will be given appropriate instructions and training to encourage customers to leave the premises quietly and not to loiter in the vicinity of the premises. At each exit point a prominent and clear notice will be displayed to this effect.

External doors will be kept closed between the hours of 20:30 and 23:30hrs, except where necessary for access and egress, i.e. the doors will not be secured open and will be fitted with self- closers if necessary.

Speakers will not be positioned outside at any time.

There are no other adverse comments from any other Responsible Authority (Fire, Police, Trading Standards etc.)

In view of the above I write to enquiry whether you now wish to withdraw your objection and I would be grateful if you would inform this office accordingly.

Where objections are not subsequently withdrawn, the matter will have to be determined by a licensing panel at a formal committee meeting. This will be arranged through Democratic & Legal Services with the costs being the responsibility of the council tax payers in the New Forest administrative area.

In taking this option you will need to produce evidence to support your representation and this matter including your comments and relevant details will become part of a public record.

Further, it should be noted that any decision made is subject to appeal at the magistrate's court and in defending its position the Council may ask that you appear as a witness to give evidence on its behalf.

Any licence produced is also subject to the review process should future problems occur.
