Police officers have regularly been required to attend the premises late night, mainly on Saturday and Sunday mornings to deal with high volum alcohol fuelled incidents relating to violent offences, linked to closing an dispersal time of customers. This has had a significant impact on the availability of Officers to patrol other area's of their communities at othe of the day.	es of
Several measures have been taken by Hampshire Constabulary prior to odging the request for review of the Premises Licence, to work with the nanagement in endeavouring to reduce levels of alcohol fuelled crime a disorder. However, no significant improvements have been made and to premises continues to cause concerns.	nd
ncidents have continued as stated in the Police report and examples have been listed from March 2010 through to present date. It is alleged that management of the premises and its customers are at the root of the problems, as customers are permitted to consume excessive quantities alcohol. Despite numerous efforts by the Police to work with the managen trying to alleviate the continued problems surrounding the premises, it been to no avail, hence the requirement of a review of the Premises lice to offences and clear breaches of the Licensing Act 2003, which is a detrimental effect on peoples quality of life who live and work within the premises and Police resources.	ooor of ement has nce naving

Hampshire Constabulary seeks a review of the premises licence in respect of Longs, due to the disproportionately high levels of crime and disorder associated with the premises. The poor management of the premises and its customers has a detrimental effect on local businesses and residents who report issues such as criminal damage, people urinating in shop doorways and disturbance late at night from people and music noise. The Designated Premises Supervisor (DPS) has failed to properly protect children from harm by allowing underage customers to drink alcohol with out being challenged.

Longs is situated in the High Street, Lymington the entrance is next to the Carphone Warehouse shop and is opposite the bus station (see map at ANNEX H). The premises is a basement club with a maximum occupancy of 80 people. The capacity was reduced following Hampshire Fire and Rescue Service issuing a prohibition notice in October 2009 due to inadequate means of fire detection and means of warning in case of fire and restricted exit width.

The premises operate as a late night club venue and promotes its self on their website as "Lymington's only late night party venue" and advertises Karaoke and "DJ's" playing requests until 0200hrs.

Longs premises licence originally permitted the following licensable activities;

- Performance of live music 0800 0000
- Performance of dance 0800 0000
- Facilities for making music 0800 0000
- Facilities for dancing 0800 0000
- Late night refreshment 2300 0200
- Supply of alcohol 0800 0200 (0000 on Sundays)

The premises opening hours are currently;

- Monday Saturday 0800 0230
- Sundays 0800 0030

It has recently come to our notice that in July 2009 the Licensing Authority issued an

amended licence which added Recorded Music until 0230hrs. The police were not advised of this change and no formal consultation as required by the Licensing Act 2003 appears to have taken place.

There are a number of conditions attached to the licence:

- Existing operating procedures and policies, which include risk assessments, training of staff in all aspects of regulatory compliance and operating policies and measures for the avoidance of noise or other nuisance to neighbours, will continue to apply.
- Prior to opening to the public, on each occasion the rear fire exit route must be checked to ensure:
- The route is clear of storage.
- o Doors are unlocked and available for use in an emergency.
- The lighting is correctly functioning.
- CCTV is installed at the premises.
- Between the hours of 08:00 and 00:00 Monday to Sunday, the fire door at the rear of the premises shall be kept closed except in an emergency.
- Between the hours of 08:00hrs to 00:00hrs Monday to Sunday, the front door leading to the High Street shall be kept closed except when persons are leaving or entering the premises.
- Between the hours of 08:00hrs and 23:00hrs, music noise and noise from voices emanating from the premises, shall be of a level whilst audible, is so low in volume that distinct lyrics, tunes, musical instruments and any base beat cannot be recognised at and beyond points A (currently Lloyds Bank) and B (currently Benetton UK Ltd) as shown on the attached plan. Point A being outside 39 High Street Lymington and Point B outside 33 High Street Lymington.
- After 23:00hrs, music noise and noise from voices emanating from the premises shall be inaudible at and beyond Points A (currently Lloyds Bank) and B (currently Benetton UK Ltd) as shown on the attached plan. Point A being outside 39 High Street Lymington and Point B being outside 33 High Street Lymington.
- To enable the hearing of patrons to re-adjust and reduce the disturbance to residents from patrons leaving the premises, a period of 15 minutes cooling down (Chill Out) shall be employed before the end of each event.
- All live music will cease at 00:00hrs.
- All customers are asked to leave quietly either by a member of staff or someone on the door.
- The premises operate an over 21 policy although admittance is permitted to those under 21 with the requisite I.D.

Officers are regularly required to attend the premises late at night and particularly into the early hours of Saturday and Sunday mornings to deal with high levels of alcohol related problems and violent offences, especially linked to closing time and the dispersal of customers. Many incidents of disorder in the High Street can be directly linked to people who have been drinking, often to excess, in Longs. Each weekend officers have to be deployed to the High Street in order to keep the peace and maintain order. If they are

required to work into the early hours to police late night venues and their customers it means that they are not available to patrol their communities at other times of the day. An impact statement has been written by the local Safer Neighbourhood Sergeant, PS 2410 Adams in relation to the impact that Longs has on local policing and community issues. The statement can be located in Annex A.

Officers from Hampshire Constabulary have engaged with the premises management over a protracted period and attempted to work with them to prevent breaches of the Licensing Act 2003 and to promote best practice. Despite working with the club management for several years to try and reduce levels of alcohol fuelled crime and disorder associated with the premises. No significant improvements have been achieved and the club continues to cause concerns and generate complaints. Please see PS 405 Barry's statement at Annex B which outlines her interaction with the premises over the past year.

PC 23072 Cross has been the town beat officer since September 2009 his role involves dealing with and trying to resolve long term issues of crime and disorder. Very soon after arriving he was made aware by residents of the High Street that their lives were being made miserable by noise and disorder in the street in the early hours of the morning. Their general belief was that the people responsible were on their way to or from Longs. PC 23072 Cross has provided a statement which can be located at Annex C.

When people are arrested for offences within the premises or linked to it they invariably have to be held in police cells overnight due to their high level of intoxication, in simple terms, they are too drunk to be dealt with. The victims are also often unable to provide statements because they are too intoxicated. As well as the initial abstraction of officers to deal with the incident on the night it also has an affect on the policing levels for the following day; committing officers with interviews, tracing witnesses, and diverting them from dealing with other matters arising in the community.

At 02.20hrs on 21st March 2010 officers were on patrol in High Street, Lymington when they saw a male leave Longs. As he walked past their vehicle he made an obscene hand gesture towards the officers. They warned the male to stop but he became abusive and swore at the police officers within the hearing of other members of the public. The male was arrested under section 5 of the Public Order Act having been given several warnings regarding his behaviour. In interview the male stated he had drunk a large volume of alcohol, mainly pints of cider and admitted he was very drunk when he left Longs at closing time and did not remember a lot of what happened that night because he had consumed too much alcohol.

On 19th June 2010 police were called to Longs by a member of the public reporting a fight inside. Officers arrived very soon after the call as they were already heading to the area prior to monitor customers leaving the premises. On their arrival the place was fairly busy and the officers' entry was hindered by a large number of customers hanging around on the road and the entrance; the doorstaff were doing very little to clear customers. Once inside there were still drunk customers milling around. The officers located a male lying on the floor, being tended to by a number of female customers, and there was a second victim standing nearby. Officers stated that the staff, including the owner, appeared very disorganised in relation to the incident. They seemed more interested in clearing up than

helping the injured people. The staff were not making any attempt to empty the club, or ask anyone if they witnessed the assaults. Hampshire Ambulance Service took the two injured males to Southampton General Hospital; both males had received serious injuries which included broken eye sockets and cheek bones. One of the victims sustained a broken foot after being stamped on and required re-constructive surgery. It transpired that both of the victims arrived at Longs Wine Bar around 0030hrs. Later that night both males went to the bar to get a drink when the offender attacked them. In interview the offender stated he had drunk 8/9 pints and two Jäger Bombs (Jägermeister and Redbull), he described himself 7/10 for drunkenness with 10 being "legless".

A public meeting was convened on 3rd August 2010 to discuss problems raised by local residents and shop keepers. Concerns were raised over the damage caused by drunken patrons of Longs as they left the area after closing time, examples cited were smashed shop windows, car mirrors broken off and persons urinating in alley ways and doorways. Further concerns over the length of time crowds of people were allowed to remain immediately outside Longs and the foul language used; this was of particular concern to residents with children.

During autumn 2010 the Force launched Operation Denver which focused on the reduction in violent crime, particularly alcohol related violent crime. One of the strategies adopted by Western OCU was to conduct high visibility reassurance/compliance visits at our high risk licensed premises; Longs was one of those premises. It was noted that here was a significant reduction in incidents connected to Longs during the period these visits were taking place.

On 30th October 2010 PS 2410 and PC 23072 were on patrol in the High Street, they went to Longs about 2345hrs and saw that the front door was open and remained so throughout their attendance. They describe the crowd outside as loud with people shouting. The DPS, Andy Johnson, was outside for some of the time along with a member of door staff, neither took any action to quieten or disperse the crowd. At 0045hrs the loud base notes of the music emanating from Longs could be heard clearly from outside Lloyds TSB bank (Point A).

On 28th November 2010 a member of doorstaff flagged down a passing police van asking for assistance to move on a customer who had just been ejected from Longs. Officer's state that the subject was clearly very drunk and later stated he had consumed 12 pints of beer and 4 glasses of brandy. The subject wanted to complain about being assaulted but was told that no statement could be taken at that time as he was too drunk. The male walked away down an alleyway to a residential courtyard where he was seen urinating against a wall. Officers confronted the man and explained his options at which the subject hit his own head against a wall several times whilst saying "Please don't hit me again officer". The male was arrested for S5 Public order and transported to Lyndhurst custody.

On the 3rd December PC 3735 attended Longs and saw that a member of doorstaff was not displaying his SIA badge correctly as it was being obscured by his jacket. He refused to give his licence number, expiry date and date of birth to the officer. PC 3735 returned later and although he now had his badge on the outside of his jacket pocket he covered it up with

his hand when she asked for the details. The officer described the doorstaff's attitude uncooperative and obstructive. Subsequent checks revealed that one of the doorstaff was not licensed.

On 12th December 2010 police were called to Longs by New Forest CCTV to a report of a fight outside. It transpires that the initial fight started inside Longs where a victim was punched on the dance floor which caused his lip to split and swelling to his nose. A second victim stated he was on the dance floor when he was hit to the right side of his face resulting in two chipped teeth. A third victim was trying to break up the fight when an unknown male bit his finger which breaking the skin. The suspects were ejected by members of doorstaff. The victims left the premises a short while later to go home. NFDC CCTV shows the two suspects attack them before running off as several police units arrived. Statements were taken from the victims, which indicated their level of drunkenness; Victim 1 statement "On arrival on a scale of intoxication I would say I was a good nine out of ten" then went on to say "We continued to drink in Longs mixing our time between standing around talking & dancing on the dance floor". Victim 2 said "On arrival at Longs I would describe myself as pretty intoxicated on a scale of one to ten I would say a good nine". The investigation ongoing.

On 18th December 2010 a member of the public flagged down officers on patrol and informed them that a shop window in the high street had been completely smashed and some property in the store was damaged. New Forest CCTV unit reviewed the footage and saw the male responsible had gone into Longs. Although the male was very drunk he was able to enter the club without being challenged. Officers attended Longs and the male was arrested for criminal damage. In interview the next day the subject stated that he was so drunk, he didn't know whether he had broken the window or not. He was issued a conditional caution and required to pay cost to repair the window of £356, although the overall cost to the business was far greater.

On 19th December 2010 police were directed to Longs following a report of a fight. A description of a female was given to officers, this female was stopped and spoken to by officers, she was heavily in drink and unable to stand. The female could barely look after herself and had to be taken home as officers were concerned for her own safety as well as others. As it was impossible to ascertain what had happened at the time, it was agreed an officer would attend her home address the next morning to take further details. It transpired that the female had appeared to be picking fights with people on the High Street after drinking at Longs. In the officers opinion the female was drunk and on a scale of 1-10, with 10 being drunk she was at least 9 as she could barely look after herself.

On 16th January 2011 officers were on routine patrol outside of Longs at closing time to ensure customers leaving the premises did so quickly and quietly. Officers witnessed a fight between two males in front of several other members of the public. Whilst one of the suspects was being arrested and handcuffed, officers' attention were drawn to a female who became hysterical, the female ran straight towards the officers and assaulted them. The female was restrained and arrested for assault on a police officer. There were approximately 10 people surrounding the female and were trying to pull the officers away to prevent the arrest. The group became agitated and extremely aggressive towards the

officers. An officer stated he looked across to the door at Longs and saw that it had been shut and the light was out and there were no doorstaff from Longs dispersing their customers from the area. Three people were arrested and transported to Lyndhurst custody centre. One of the males arrested stated he had 6 pints of Stella before entering Longs, then a further 2 pints in Longs. He described himself as 7 out of 10 on the drunkenness scale.

On 22nd January 2011 PC 23072 was on duty and monitored Longs various times throughout the evening, every time he did so the front door was propped open. At midnight he attended and spoke with the doorman who indicated that the club was very busy and almost full to capacity, which was indicated by the pair of "clickers" being used. However, whilst speaking to him 3 or 4 more customers arrived and entered the bar and the doorman made no apparent record to count them in. The officer entered the bar and said that whilst it was impossible to count the number of patrons he strongly suspected that there were more then the 80 people the venue is permitted.

On the 28th January 2011 the local Safer Neighbourhood officers, supported by the Licensing Team mounted an operation focusing on licensed premises and the night time economy in Lymington. During the evening several drunken males and rowdy groups were seen in the town centre and warned by police. They were then seen to go into Longs wine bar without being challenged. They were showing all the classic signs of drunkenness and were so clearly and very obviously drunk they should not have been admitted. PS 721 and PC 22915 were in plain clothes and visited several premises including Longs. They describe seeing drunken customers being served alcohol in the club and at one point PS 721 had to move from the bar as a drunk male leant on her. PC 22915 stated that the male looked like he was about to either fall over or vomit on PC 721. PS 721 statement can be located at Annex E.

AT 0050hrs on 29th January Insp 2556 and PS 1634 were in the vicinity of Longs. As they stood in the entrance of the Oakhaven Hospice Trust shop they could clearly hear the base beat and vocals of the music emanating from Longs. This is in breach of a condition on the premises licence. There was also a considerable amount of 'people noise'. Insp 2556 and PS 1634 then entered Longs and spoke to Andy Johnson, the music was so loud they had to go to a back room in order to hold a conversation. Whilst in the club PS 1634 saw one of the drunk males he had had cause to speak to earlier, the male had been served alcohol in the club and was holding a half drunk pint of beer. The officers had to advise the DPS that he should be told to leave. When the male and the group he was with left the club they immediately became involved in a scuffle outside which other officers had to attend to deal with. The group were then involved in a further incident where a male was punched and kicked - two of the group were arrested for assault. One of the group then walked off but a short time later became involved in an altercation in which he was assaulted. His own conduct was such that he was arrested for a public order offence. Due his level of drunkenness the officers had to assist the male to the police van and then lift him into the back as he was unable to use his legs to lift himself up. Significant police resources were tied up dealing and investigating these offences both on the night and the following day. PS 1634 statement can be located at Annex F.

At 0200hrs on the 5th February officers witnessed a drunken youth stagger out of Longs

holding a bottle of Corona lager. The young male was not challenged by a member of doorstaff for leaving the bar with a bottle. He remained outside the bar in front of the member of doorstaff for a couple of minutes. He then walked over to the alleyway next to Longs and began to urinate against the wall. Officers spoke to the male and they discovered he was only 17 years old.

On 6th February 2011 PC 23072 stood 75 yards away from Longs outside 'New Look'. Although the door to the premises was closed each time it was opened he clearly heard the heavy beat of the music emanating from the club. The Officer entered the bar with the intention of speaking to the DPS, as he walked down the stairs he saw Andy Johnson working behind the bar; however he disappeared from view almost immediately. The officer remained inside for about 2 minutes; loud music was being played by the "DJ" with disco lights and people dancing on the dance floor. Eventually one of the members of staff spoke to the officer and claimed that Mr Johnson was busy, so the officer left.

A schedule of incidents, police visits and support offered has been prepared and can be found at Annex G.

Almost without exception the recorded incidents on the occurrence summary are after midnight on a Thursday, Saturday and Sunday morning. These coincide with the main trading pattern of the club i.e. Wednesday is Karaoke night hence the peak in the early hours the following morning. The same applies to the early hours following the Friday/Saturday night trade.

We believe that poor management of the venue and its customers is at the root of the problems. In many cases customers are permitted to consume excess quantities of alcohol. Local residents and businesses are suffering noise and disturbance into the early hours of the morning and alcohol related crime and disorder is having a detrimental effect on local police resources. The police have been engaging with and trying to support the management over a considerable period. The number of assaults and public order incidents leave us with no option but to call for a review of the licence.

I also noted that at no time was the front door to the premises shut as required by the licence and the sound of music and general people noise could be clearly heard at fairly high levels. After speaking to him briefly we entered the premises and walked down the stairs into the club. It looked very busy inside with very little room to move. There was loud dance music being played on the far side of the premises and I could see disco lights flashing and people dancing on the dance floor. I spoke to the DPS, who was now behind the bar and queried why the disco was still going on at 00.30 hours when the premises licence stated that it should cease at midnight. He stated that it would be going on until 'normal time' due to the clocks going back. I subsequently checked the licence and there did not appear to be any dispensation for BST to GMT. Additionally as the disco should have ceased at 00.00 hours anyway it is unaffected by the change to GMT which occurs after this time. We left the premises at about 00.45 hours and the disco was still going. We walked along the High Street to Lloyds Bank and listened to noise coming from the club. Loud base notes could clearly be heard together with the sound of people noise from the club from Lloyds Bank and some considerable distance beyond. At the conclusion of our visit I returned to the police station and completed a Licensed Premises Compliance Report with my findings. I am an officer with over 26 years service, the majority of which has been as a frontline officer and in that time I have considerable experience in dealing with licensed premises. It is my professional opinion that pubs and clubs that cause the most problems in terms of crime and disorder and general issues are those that are poorly managed. Whilst serving at Lymington I have received more complaints and concerns from both the public and police officers about Longs than any other licensed premises on my area. crime which directly links to the closing time of Longs. All licensed premises have a responsibility to reduce crime and disorder and this responsibility does not stop when a customer leaves the premises. It also means they have a degree of responsibility for the assault that happens just down the road involvoving one of their customers or their customer who urinates on a nearby shop front. These are not fictitious incidents but real examples of events that happen regularly involving customers from Longs. One of the main issues is that Longs is the only premises that operates a late licence and it is for want of a better description, 'the light that attracts the moths'. It attracts people hoping to continue their drinking into the small hours some of whom turn up drunk. I have heard evidence from the management at Longs that they are not responsible for people turning up drunk and this is the fault of other pubs. This may be true, however what is also evident is that these people are rarely refused entry and as the only late opening premises in Lymington this an obvious risks that they must manage. If not managed correctly problems associated with crime and disorder will inevitably occur.

Over the past year or so there has been a lot of work done by the police to support the management of Longs to find a solution which meets their business needs but also addresses the concerns of the community. This has included a public meeting where the concerns of local residents were aired and also support checks to ensure that the licensing conditions are being adhered to and where breaches have been apparent, appropriate advice given. Despite this engagement there remains a significant problem with crime and disorder directly associated with the premises.

Lymington is not a city centre police station and has limited resources to police a large geographical area. The policing of Longs regularly causes a considerable drain on police resources and takes up a disproportionate amount of police time. This has a direct affect on the wider community and means other areas are not policed as they should be - that is simply not right or fair.

On 3 rd August 2010 I attended a public meeting at Lymington Town Hall with the residents and shopkeepers of Lymington High Street, DPS A and staff of Longs Wine Bar and the following partnership professionals: PS Nick Adams, PC Ian Cross, Group Manager HFS , Environmental Health Officer Verity Potter and Licensing Enforcement Officer Pat Curran. The meeting was called by myself in order that the staff of Longs Wine bar could gain first hand accounts from residents of how the late night licensing trade affected the quality of their lives. The following Actions were agreed at the meeting; residents to ring Police instances of crime & disorder and make note in their community diaries; Longs to work with residents in identifying anti-social patrons and exclude any person who have disturbed and distressed local residents; environment health to review community diaries and consider further monitoring; Longs to inform patrons of ongoing Partnership monitoring and explain potential consequence of threat to late night licence; PS Barry to continue working with Longs management and to monitor progress.

At 00.30hrs PS Adams & I attended the Bar, at this time the Disco was still in progress and PS Adams queried this with the DPS who was by then working behind the bar.
At 00.45hrs loud bass note emanating from Longs Wine Bar could be heard clearly from outside Lloyds Bank on the High Street.
On Saturday 22 nd January 2011 I monitored Longs Wine Bar throughout the evening at various times and on each occasion the front door was propped open fully. I attended on foot at 00.00hrs and spoke to inches that the club was very busy and was almost a full capacity indicated by the pair of "clickers" he uses. However, whilst I was speaking to him 3 or 4 more customers arrived and entered the Bar but I made no apparent record or count of this. After 15 minutes I entered the Bar, it was impossible to count the numbers of patrons but I strongly suspected that there were more than the licensed 80 allowed.
On Sunday 6 th February 2011 I drove past the venue at 00.30hrs, was on duty and the door was closed except to allow patrons to enter/exit. I then stood on the pavement outside New Look on the High Street some 75yds away from Longs Wine Bar. As the door to the bar opened each time I heard clearly the heavy beat of music emanating from inside the Bar.
I approached and entered the Bar with the intention of speaking to the DPS, I made my way down the stairs and identified busy working behind the bar, however he disappeared from view almost immediately. I remained inside for approximately 2 minutes and loud music was being played by a DJ, disco lights were running and patrons were dancing throughout. I was eventually approached by in the manager, she explained that J was busy and I left.
Since my arrival in Lymington in 2009 I have become aware of a clear pattern of behaviour on Friday and Saturday evenings by the patrons of the local licensed establishments. Lymington retains a pleasant, friendly atmosphere during the early evening whilst groups including families visit to eat and drink. During the evening however, the atmosphere changes and by 23.00hrs there remain only those who are engaged in serious late night drinking. Unfortunately, due to the layout of the town, there are concentrations of late licensed premises at the top of town in Queen Street and at the bottom of town near the Quay. At around 01.00hrs patrons of all these premises migrate towards the centre and Longs Wine Bar which has the only 02.00hrs license in the town. The movement of these persons, not all of whom actually gain entry to Longs Wine Bar, and their rowdy, drunken behaviour leads to reports of Criminal Damage, Theft, Violence and Anti-Social Behaviour all along St. Thomas Street and the High Street.

Upon entering Longs wine bar I saw that there were approximately 20 persons inside. There was a female DJ playing loud music and about 5 females dancing in the dance floor area. PC Lockwood purchased a pint of beer for himself and a soft drink for me. The noise level inside was such that I had to shout at the top of my voice to converse with PC Lockwood. We stood near the door at the bottom of the stairs and observed a white male stood about 3 feet away by the bar. I would describe this male as approximately 50 years old, with short grey hair and wearing a grey checked top and white jeans. He was drunk. His speech was slurred and he was unsteady on his feet. PC Lockwood observed him getting served and I saw him drinking a clear drink from a glass. When he left he went behind the bar area and removed a jacket which he put on.

Whilst we remained stood at the bottom of the stairs by the bar area I saw several persons go up and down the stairs leaving and re-entering the premises. The door to the premises was open at all times. I also went outside of the premises to make a phone call to PS Barry and the door remained open. The music was loud so I walked up the high street so I could hear PS Barry.

At approximately 00.05 hours I went into the first Ladies toilet at the top of the stairs. I performed an Iron Track swab along the rim of the toilet seat which I produce as identification number MB/LW/1.

At approximately 00.15 hours we moved into the dance floor area. We stood by the bar next to the DJ. The music was still playing as loudly as it was when we entered the premises. I ordered a soft drink for myself and a KWD alcoholic drink for PC Lockwood. We became aware of a group of 6 young males who were in drink and being boisterous. One of the males was particularly drunk. I would describe this male as white, very tall and very thin, with short light brown hair. He was wearing a grey sweater and jeans. He was dancing and staggering, unsteady on his feet, his eyes were glazed and he was knocking into people. I stood at the bar and at one point this male stood right next to me. He was served an alcoholic drink by a female member of staff which was observed by myself and PC Lockwood. The tall male stood at the bar and leant on me. I felt that I needed to move and PC Lockwood also made comment to move as I felt this male looked like he might either fall on me or vomit. He could hardly open his eyes and was swaying. His friends were also in drink but some were amiable and one of the males made friendly conversation with me. This was all in the sight of the two door staff that were stood by the dance floor.

At approximately 01.00 hours two uniformed officers entered Longs wine bar and spoke to some of this drunken group. At 01.20 hours we left Longs wine bar. The music was still playing loudly. We returned to Lymington police station where I wrote my statement and updated my pocket notebook.

On 28th January 2011 I was involved in a policing operation in Lymington town centre focusing on the night time economy. About 23.50hrs that night I was on patrol, in full uniform, with the Sector Inspector, Steve Jackson, in High Street Lymington when I had cause to speak with a young man who was clearly drunk. He was noisy and disorderly and swaying as he tried to stand. Having given him suitable words of advice regarding his conduct he made his way along the High Street towards Longs. As he approached the premises I saw him stagger into the road. He then appeared to be allowed into the premises without challenge. When I spoke to this young man he was very obviously drunk and displayed all the classic signs - breath smelt strongly of intoxicating liquor, speech slurred, eyes glazed and unsteady on his feet but was still able to enter Longs unchallenged a few minutes later.

About 00.25hrs I also had cause to speak to a young male in a blue jumper who was very drunk and loud. I had seen him early in a group who we had to speak to as they were causing a disturbance in St Thomas Street. The male in the blue jumper was, again, clearly drunk and I warned him that he had drunk enough and should not drink anymore and go home. I was subsequently advised via the CCTV control room that this male had been allowed to enter Longs. At 00:50hrs I stood in the doorway of the Oakhaven Hospice Trust shop which is on the opposite side of the road to Longs. This shop is next door to LloydsTSB Bank and a little further away from Longs.

Conditions of Longs' Premises Licence state;

- Between the hours of 08:00hrs and 23:00hrs, music noise and noise from voices emanating from the premises, shall be of a level whilst audible, is so low in volume that distinct lyrics, tunes, musical instruments and any base beat cannot be recognised at and beyond points A (currently Lloyds Bank) and B (currently Benetton UK Ltd) as shown on the attached plan. Point A being outside 39 High Street Lymington and Point B outside 33 High Street Lymington.

I could clearly hear the base beat of music and the vocals of the music emanating from Longs. There was also a lot of 'people noise' including shouting and swearing from smokers and customers waiting outside Longs.

Insp. Jackson and I entered and walked downstairs into the club. I could see there were about 20 people dancing on the dance floor, there were flashing lights and loud dance music was being played. I could see a 'DJ' in the booth who appeared to be operating the equipment. I then saw the Designated Premises Supervisor, out from behind the bar. The music was so loud that it was impossible to hold a conversation and we had to go into a back room in order that we could hear each other. I explained that we had seen and spoken to a number of drunken males in the High Street who had subsequently been allowed entry into the club. n initially tried to distance himself from this and claim it was the doorman's responsibility. I made it clear that as the DPS he was responsible. I then spoke to him about the music and disco and advised him that his licence only permitted these activities until tried to argue that it wasn't a 'DJ' and disco. I told him that in my view there was a person midnight. Mr. playing dance music, with disco lights and people dancing on the dance floor and it could not be described as anything other than a disco (and therefore beyond that which was permitted by his licence). Whilst this was happening we were approached by one of his friend who was also very obviously drunk, so much so that he was almost incoherent and had difficulty string a sentence together. They eventually left but not before I had to warn the male in the blue jumper again regarding his conduct and foul and abusive language in the presence of several other customers, including females. Within a very short space of time I heard, over my radio, the control room despatch officers to a disturbance outside the club. I left the Insp. with Mr and went upstairs to try and deal with the incident. As I left the club I saw that the two drunken males who had just been ejected from the club had been involved in a scuffle with other members of the public. Once matters had calmed down I left other officers to deal with the incident and returned to the club where I concluded my conversation with Mr.

About 01.40hrs the same morning I left the club. I could see a group of 6 or so people in the distance near St Thomas' Church it was clear from their movements that some sort of confrontation was taking place. En route to the scene we were advised that two males from the group had assaulted another man and one had made off. We arrived around the same time as other officers and immediately I could see that it was the group of males who had been in Longs including the male in the blue jumper. One of the group was arrested at the scene on suspicion of assault and I understand that another was arrested nearby.

Once the group had been dispersed I followed the male in the blue jumper who I had had dealings with earlier. He walked west along St Thomas Street towards Queens Street where I lost sight of him. A short time later I saw him being spoken to by Insp. Jackson. We resumed our patrol but a few minutes later we called to a report of a fight in Priestlands Place. On our arrival I saw the male in the blue jumper again. He had injuries to his face, his trousers were undone and he was shouting at a male who was standing on the opposite pavement. Both males were subsequently arrested – the male in the blue jumper for a public order offence, the other on suspicion of assault. In interview the male arrested on suspicion of assault stated that prior to the incident he had been drinking in Longs and had consumed about 7 pints.

It was clear to me from the incidents I attended that many were linked to Longs and the conduct of their customers and all of those I dealt with were drunk. Officers have had to stop patrolling their communities to escort prisoners to the cells or take statements from victims and witnesses and many hours of police work have been spent investigating these crimes and taking officers off the street in order to do so. Several also needed hospital treatment putting an additional strain on Health Service resources. Each weekend officers have to be deployed to the High Street area in order to keep the peace and maintain order. If they are required to work into the early hours to police late night venues and their customers it means that they are not available to patrol their communities at other times of the day

I identified clear breaches of the Licensing Act such as serving people who were drunk and specific breaches of Longs' premises licence in respect of noise and provision of regulated entertainment beyond permitted hours.

I believe it is the late licence which draws people to the premises but once there they are not properly managed which results in disturbance to local residents and unacceptable levels of alcohol related crime and disorder.

We have worked with the venue management over a protracted period but no significant improvement has been observed and crime and disorder associated with the premises and its customers remain at unacceptable levels which are disproportionate to other licensed premises in the area.

- (1) Each individual at the premises to carry out a security activity must be licensed by the Security Industry Authority.
- (2) But nothing in subsection (1) requires this condition to be imposed:
 - (a) in respect of premises within paragraph 8(3)(a) of Schedule 2 to the Private Security Industry Act 2001 (c.12) (premises with premises licences authorising plays or films), or
 - (b) in respect of premises in relation to-
 - (i) any occasion mentioned in paragraph 8(3)(b) or (c) of that Schedule (premises being used exclusively by club with club premises certificate, under a temporary event notice authorising plays or films or under a gaming licence), or
 - (ii) any occasion within paragraph 8(3)(d) of that Schedule (occasions prescribed by regulations under that Act).
- (3) For the purposes of this section:
 - (a) "security activity" means an activity to which paragraph 2(1)(a) of that Schedule applies, and
 - (b) paragraph 8(5) of that Schedule (interpretation of references to an occasion) applies as it applies in relation to paragraph 8 of that Schedule.

Where licence authorises supply of alcohol:

- (1) No supply of alcohol may be made under the premises licence:
 - (a) at a time when there is no designated premises supervisor in respect of the premises licence, or
 - (b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.
- (2) Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

d) The prevention of public nuisance

Between the hours of 08:00 and 00:00 Monday to Sunday, the fire door at the rear of the premises shall be kept closed except in an emergency.

Between the hours of 08:00hrs to 00:00hrs Monday to Sunday, the front door leading to the High Street shall be kept closed except when persons are leaving or entering the premises.

Between the hours of 08:00hrs and 23:00hrs, music noise and noise from voices emanating from the premises, shall be of a level whilst audible, is so low in volume that distinct lyrics, tunes, musical instruments and any base beat cannot be recognised at and beyond points A (currently Lloyds Bank) and B (currently Benetton UK Ltd) as shown on the attached plan. Point A being outside 39 High Street Lymington and Point B outside 33 High Street Lymington.

After 23:00hrs, music noise and noise from voices emanating from the premises shall be inaudible at and beyond Points A (currently Lloyds Bank) and B (currently Benetton UK Ltd) as shown on the attached plan. Point A being outside 39 High Street Lymington and Point B being outside 33 High Street Lymington.

To enable the hearing of patrons to re-adjust and reduce the disturbance to residents from patrons leaving the premises, a period of 15 minutes cooling down (Chill Out) shall be employed before the end of each event.

All live music will cease at 00:00hrs.

All customers are asked to leave quietly either by a member of staff or someone on the door.

e) The protection of children from harm

The premises operate an over 21policy although admittance is permitted to those under 21 with the requisite I.D.

Where the number of children attending the entertainment exceeds 100 the licensee shall ensure that the provisions of Section 12 of the Children and Young Persons Act 1933 are complied with.

PUBLIC ENTERTAINMENT CONDITIONS

STANDARD TERMS CONDITIONS AND RESTRICTIONS UPON WHICH PUBLIC ENTERTAINMENT/SPORTS ENTERTAINMENT/CINEMA and THEATRE LICENCES ARE GRANTED, RENEWED, VARIED OR TRANSFERRED (REGULATION 9)

1. INSPECTION

- 1.1 ALL PARTS OF THE LICENSED PREMISES must be open to inspection at all reasonable times by:
 - (a) Duly authorised officers of the Licensing Authority (Council);
 - (b) Police Officers; and
 - (c) Fire Officers

THE PLAN

- 2.1 The premises must at all times conform to the plan deposited with the Council. The plan must be to a scale of 1:50 and include the following details:
 - layout of the premises
 - emergency exits and any external escape routes
 - location and type of fire fighting equipment
 - location of emergency lighting units (whether maintained or non-maintained)
 - fire alarm call points
 - public telephone
 - sanitary accommodation including W.C's, urinals and wash hand basins
 - potable drinking water points
 - fixed and moveable seating and table plan
 - any storage area for combustible materials or flammable liquids
 - any areas set aside for disabled persons
 - all fixed furniture e.g. bars, ticket booths, stages, DJ consoles, dance floor, pool tables etc.
- 2.2 Any changes to the details contained in the plan (see condition 2.1) must be approved in writing by the Council. A revised plan must be submitted to Council at least 28 days prior to the commencement of work.

3. MANAGEMENT

3.1 THE LICENSEE(S) must ensure that the permitted number of people in the licensed premises is not exceeded. The permitted number includes patrons, staff and performers.

- 3.2 The relevant licence(s) (or a clear copy) must be exhibited at all times, in or near the licensed area conspicuously, in such a position that it can be easily seen by people using the area, to the satisfaction of the Council. The licence must be adequately protected against theft, vandalism or defacement.
- 3.3 THE LICENSEE(S) must take all necessary precautions for the safety of the public, performers, competitors and employees. Any instructions regarding safety given by an officer listed in 1.1 above, must be put into effect immediately.
- In the absence of the LICENSEE(S) a responsible person, at least eighteen years of age, must be in charge of, and present in, the premises whenever entertainment is provided. Details of any nomination must be entered in the log book (see 3.10) prior to the public entertainment taking place.
- 3.5 All parts of the licensed premises including fittings, seating, door fastenings, floor surfaces and coverings, notices, steps, staircases etc. and all electrical installations must be maintained in clean and good order.
- 3.6 Safe, suitable and sufficient means of heating and ventilation must be provided to the satisfaction of the Council.
- No exhibition, demonstration or performance of hypnotism, mesmerism or any similar act may be given without the written consent of the Council.
- 3.8 An application to the Council for consent must be in writing and signed by the applicant or his agent and must be made not less than 28 days in advance of the performance concerned. This period may be reduced in some cases and in the case of a hypnotist who has performed at the same venue within the last three years without any problems occurring. The Council will normally respond within 7 14 days; less where the hypnotist has previously performed at the same venue.
- 3.9 No entertainment involving special effects (e.g. pyrotechnics, real flames, smoke machines, firearms, strobe lighting, foam parties, lasers etc.) or any sporting event involving SPECIAL RISKS OR DANGER may take place without the written consent of the Council. Applications must be made to the Council in writing, not less than 28 days before the event and additional conditions will apply.
- 3.10 A Log book and log file must be maintained together in the premises and kept available for inspection by any of the officers listed in condition 1.1. The log book and log file must contain the following information and documents:
 - dates and times of visits of any officers, their names and observations made
 - copies of inspection reports e.g. electrical installation, gas installation, emergency lighting, fire fighting equipment, fire alarms, ceiling fixings, lifts, hoists etc.
 - details of routine testing of the emergency lighting and fire alarm systems in accordance with the current British Standards (including dates, times, people carrying out test, faults found and rectification dates)
 - list of registered door security persons on duty that day

details of events including fire drills, incidents involving fires, disorder, drugs, items seized by door / security staff with dates, times and any comments

 the name and address of any person nominated to act in the absence of the licensee and the date when he or she is acting in that capacity

4. DISTURBANCE AND PUBLIC ORDER

- 4.1 No entertainment may be held if it causes a disturbance to the occupiers of any other premises which the Council in its absolute discretion considers to be unreasonable.
- 4.2 THE LICENSEE(S) must at all times ensure, as far as is reasonably practicable, that people on, or leaving the licensed premises conduct themselves in an orderly manner, and do not cause annoyance to the neighbourhood.

5. **EMERGENCY TELEPHONES**

5.1 If no telephone service is available in the premises a notice must be displayed in a conspicuous place, giving particulars of the nearest telephone together with details of how to summon the emergency services.

6. ELECTRICAL INSTALLATIONS

- The power, lighting and emergency lighting systems must be maintained for the prevention of danger. The Council requires production of a certificate of examination and test of these systems from a competent electrical contractor being a member of the Electrical Contractors' Association (ECA) or the National Inspection Council for Electrical Installation Contractors (NICEIC). A copy of the current certificates must be submitted with any application for grant or renewal of a licence.
- No alterations or additions to the electrical installation, either permanent or temporary, may be carried out without prior approval from the Council, (see condition 2.1). Alterations must be carried out by a qualified electrician in accordance with the current Institute of Electrical Engineers Regulations. An additional certificate of examination and test must be obtained and submitted to the Council within 14 days of the completion of the works.
- 6.3 The electrical supply to musical instruments, amplification equipment and any other portable equipment must be fitted with a residual current device (RCD) of 30 milliamp rating.
- There must be sufficient, correctly installed and rated, electrical power sockets within the premises so that there is no use made of long trailing flexes to portable equipment and/or multi-socket adapters. Where equipment is suspended by ropes, cables or other combustible materials, safety chains or other non-combustible means of support must be provided.

7. GOOD ORDER

- 7.1 THE LICENSEE(S) must ensure that no person is admitted to or remains in the premises whilst in a state of intoxication. If any person acts in an offensive manner, or to the annoyance of other people, he must be removed immediately from the premises.
- 7.2 No profanity or impropriety of language, dress, dance, gesture, strip tease or other thing which is offensive to public feelings is permitted on the premises, unless a warning of these things is displayed on advertisements, posters and tickets. Nothing calculated to produce a disturbance or a breach of the peace is permitted on the premises.
- 7.3 No poster, advertisement, photograph, sketch, synopsis or programme or other thing which contains any offensive representation of a living person may be displayed, sold, or supplied on the premises, by or on behalf of THE LICENSEE, which is likely to be injurious to morality or encourage or incite crime, or lead to disorder, or be offensive to public feeling.
- 7.4 No part of the premises must be used by prostitutes for the purposes of soliciting or conducting their business.
- 7.5 All members of staff must be instructed in the safety precautions to be observed and the action to be taken by them in the event of fire or emergency.
- 7.6 At entertainments attended by adults there must be one attendant provided for every 100 people, or part of 100. At entertainments attended by children under the age of sixteen at least two attendants must be provided for every 100 children or part of 100. In either case there must be at least one attendant per exit, whichever is the greater. All attendants must be over eighteen years of age, readily identifiable to members of the public at all times and must not consume alcohol whilst on duty.
- 7.7 The primary duties of attendants include:
 - ensuring that no overcrowding occurs in any part of the premises
 - keeping all gangways and exits clear at all times
 - preventing standing on seats and furniture
 - being aware of any special requirements needed to ensure safe evacuation in emergency
 - Attendants do not include THE LICENSEE(S), responsible person acting for the licensee or bar staff.
- 7.8 Where people are employed or used in premises licensed to hold public entertainment in order to:
 - vet, regulate or control people entering the premises or
 - supervise patrons to ensure good order, public safety or internal security, the door security registration scheme will apply except in:

community centres

- village halls
- schools
- church halls

when volunteers such as parents, school or committee members assist in controlling security. This exemption will not apply when these premises are used for functions organised by an outside body not connected to the Community Centre, Village Hall, School or Church Hall when other persons are employed for security purposes. This may be varied at the discretion of the Council, having regard to the venue and type of activity. Where the door security registration scheme applies conditions 7.6 and 7.7 are deleted and 7.8 and 7.9 substituted.

7.9 At nightclubs and venues where the council considers there is a potential for disorder and other problems the number of Registered Door / Security People required will be:

1 male and 1 female for the first 100 members of the public or part of 100; two additional door / security staff for the next 100 members of the public or part of 100 and 1 per 100 thereafter or part of 100.

All other premises:

1 per 100 members of the public or part of 100.

7.10 People awaiting admission to the premises must not be allowed to congregate except in locations approved by the Council in writing. Where people wait in queues for admission, THE LICENCEE(S) must do what is reasonably necessary to prevent people from obstructing the exits, external courts, passageways, stairways and ramps leading to the outside of the premises.

8. SANITARY ACCOMMODATION

- 8.1 The sanitary accommodation must be clearly and legibly labelled to indicate for which sex it is intended.
- 8.2 All parts of the sanitary accommodation must be kept clean and properly maintained with provision for hand-washing including a constant supply of hot and cold water, soap and hand-drying facilities.

9. FIRE SAFETY

- 9.1 THE LICENSEE must ensure that the premises conform to the approved plan (see condition 2.1).
- 9.2 The emergency lighting system and fire alarm system must be tested at least once a month in accordance with the current British Standards, and a record kept of the tests in the log book (see condition 3.9).

- 9.3 All gangways, corridors, staircases, and external passageways intended for exit must be of sound non slip construction, properly maintained, and kept free from obstruction. The edges of the treads of steps and stairways must be made conspicuous.
- 9.4 THE LICENSEE(S) must maintain artificial lighting in the premises at a level whereby the people and activities may be monitored and supervised.
- 9.5 All exit doors and gates must be unlocked with all bolts drawn and be available for egress during the whole time the public are on the premises. Where collapsible gates or roll up shutters are used, they must be locked in the open position whilst the public are present.
- 9.6 Before the public is admitted to the premises, THE LICENSEE(S) must inspect all doors and exits to ensure that they comply with condition 9.5 and that all panic bolts are in proper working order.
- 9.7 Seating, tables, chairs and other furniture and fittings must be so arranged as to allow free and ready access to exits.
- 9.8 Accumulations of refuse must be kept in proper containers until removed from the premises.
- 9.9 Fire fighting equipment must be provided and located as approved by the Council, and be clearly marked to show their purpose. All extinguishing appliances must be inspected and maintained annually by a competent Fire Equipment Engineer. A certificate from the Fire Engineers must be obtained annually and kept available in the log file (see condition 3.9). A copy must be submitted to the Council with any application to renew the licence.
- 9.10 Combustible materials or flammable liquids must not be stored or allowed to accumulate except in areas approved by the Council and shown on the plan (see condition 2.1).
- 9.11 An event involving a closely seated audience must not be held without the written consent of the Council. Applications must be made not less than 28 days before the event and additional conditions will apply.
- 9.12 All costumes, scenery, decorations, hangings, curtains, carpets and furnishings must be of non-combustible, inherently non-flammable or flame proofed materials.

10. GENERAL MATTERS

- 10.1 All heating appliances must be adequately guarded to prevent danger to any person. All such appliances must be situated a safe distance from combustible materials.
- 10.2 Liquified Petroleum Gas heaters must not be installed or used in the premises without the written permission of the Council.
- 10.3 An adequate supply of potable cold drinking water and a hygienic means of drinking it must be provided without charge to patrons.

- 10.4 THE LICENSEE(S) must ensure that people entering and leaving the premises are counted using a method approved by the Council and that the net total of people recorded inside the premises must, at all times, be available for inspection by Officers.
- 10.5 Where there is more than one area licensed for public entertainment in the same building arrangements must be made, which may include the use of attendants with counting devices, to ensure that the total number of people in any one area does not exceed the number specified for that area.
- 10.6 THE LICENSEE (S) must have regard to the needs of disabled people and in particular:
 - When disabled people are using the premises they must be accommodated
 in seating or reserved places in close proximity to exits capable of being
 used by them with or without assistance. Such exits must be clearly
 indicated by the display of a disabled symbol.
 - The arrangements and provisions made for disabled people must be effectively maintained at all times.
- 10.7 First Aid staff and facilities must be provided to the satisfaction of the Council.
- 10.8 THE LICENSEE (S) must ensure that no bottles or glasses are removed from the premises.
- 10.9 THE LICENSEE(S) must ensure that toughened glass is used in respect of pint and half pint glasses within the premises.
- 10.10 Customers must not be served drinks in bottles. In every case the drink will be poured into appropriate vessels by the bar staff.
- 10.11 All lighting and electrical apparatus likely to become heated must be provided with suitable protection to prevent contact by scenery or any other combustible material.
- 10.12 Curtains over exit doors or across gangways must be made to part in the centre and hang in such a way that they may be easily drawn aside and not trail on the floor. Curtains must not conceal notices.
- 10.13 Where there is a closely seated audience, seating and gangways in the premises should be so arranged to allow free and ready access to exits. A maximum of 12 connected seats shall be provided in each row, provided there is a gangway at each end of the row not less than 1.05m wide. Other seating arrangements may be permitted by application to the Council not less than 28 days before the event.
- 10.14 Storage of materials under the stage is not permitted without the consent of the Council.
- 10.15 Smoking is forbidden within any stage area, dressing or changing room (except where it is necessary in connection with the performance) and notices must be prominently displayed to this effect.

10.16 A current certificate of examination is required for any suspended ceiling.

11. DEREGULATION (SPECIAL HOURS CERTIFICATES) ORDER 1996

11.1 On the morning that British Summer Time begins, the permitted hours for the provision of music, singing and dancing at premises normally open between 0100 hours and 0200 hours will extend to one hour after the normally specified terminal hour.

20. CINEMA AND THEATRE SPECIFIC CONDITIONS

- 20.1 Premises licensed as a Cinema must not be opened as a Cinema earlier than 0900 hours and must close no later than 2300 hours. On Sundays a Cinema must not be opened earlier than 1200 hours and must close no later than 2300 hours.
- 20.2 Premises licensed as a Theatre must not be opened as a Theatre earlier than 1200 hours and must close no later than 2300 hours on Monday to Saturday. They must close on Christmas Day and Good Friday except where the permission of the Council has been granted. On Sundays a Theatre must not be opened earlier than 1400 hours and must close no later than 2300 hours.
- 20.3 Extension of these hours for a Cinema and Theatre Licence may be given on application in writing the Council.
- 20.4 Only such parts of the premises as have been approved by the Council, in writing, may be used for storage of scenery, as workshops, dressing rooms, retiring rooms or cloakrooms and provisions for hanging hats or coats must not be made in corridors, passages, gangways or exitways used by the public.
- 20.5 Where the Council has given notice, in writing, to THE LICENSEE(S) prohibiting the exhibition of a moving picture on the ground that it contains matter which, if exhibited, would offend against good taste or decency or be
 - likely to encourage or incite to crime or to lead to disorder or to be offensive to public feeling, that moving picture must not be exhibited in the premises except with the consent, in writing, of the Council.
- 20.6 If the Council do not agree with the category in which any moving picture passed by the British Board of Film Classification is placed, they are at liberty to alter such category, and, on notice of such alteration being given by the Council to THE LICENSEE(S), the moving picture thereafter must be treated as having been placed in the altered category and the conditions applicable to the exhibition of moving pictures in such altered category must be complied with.
- 20.7 If the Council request THE LICENSEE(S) to exhibit to them any moving picture he must do so at such reasonable time as the Council may, in writing, direct.

20.8 Moving picture classifications

No moving picture may be exhibited unless:-

- It has received a "U", "PG", "12", "15", or "18" certificate of the British Board of Film Classification or
- It is a current news-reel which has not been submitted to the British Board of Film Classification.

No person under the age of eighteen years may be admitted to any exhibition at which there is to be shown any moving picture which has received an "18" certificate from the British Board of Film Classification.

No person under the age of fifteen years may be admitted to any exhibition at which there is to be shown any moving picture which has received a "15" certificate from the British Board of Film Classification.

No person under the age of twelve years may be admitted to any exhibition at which there is to be shown any moving picture which has received a "12" certificate from the British Board of Film Classification.

20.9 Film classification certificate to be shown

A representation or written statement of the terms of any certificate given by the British Board of Film Classification must be shown on the screen immediately before the showing of any moving picture to which it relates and the representation or statement must be shown for long enough and in a form large enough for it to be read from any seat in the auditorium.

20.10 Notice of moving picture classifications and times of showing

There must be prominently exhibited at each public entrance whenever the premises are open to the public a notice indicating in tabular form and in clear bold letters and figures:-

- The title of each moving picture to be shown on that day, other than trailers and moving pictures of less than five minutes duration;
- The approximate times of commencement of each such moving picture;
- Whether each such moving picture has received a "U", "PG", "12", "15", or "18" certificate from the British Board of Film Classification; and
- The effect of such "U", "PG", "12", "15", or "18" certificates in relation to the admission of people under the age of eighteen years.

20.11 Advertising

The nature of any certificate received in respect of a moving picture from the British Board of Film Classification must be clearly indicated by the letter "U", "PG", "12", "15", or "18" in any advertisement of the moving picture displayed at the premises.

Advertisements for any film displayed at the cinema may only depict scenes or incidents which are included in the film as certified by the British Board of Film Classification or the Council.

- 20.12 There must be no standing in the Auditorium during a performance without prior written approval from the Council.
- 20.13 Where appropriate the opening to the stage must be guarded by such type of safety curtain as may be approved by the Council, and other necessary openings in the proscenium walls must have fire resisting and effectively self-closing doors, so that the auditorium may be completely separated from the stage. The safety curtain must be lowered or closed at least once during each performance.
- 20.14 All rope or similar barriers across gangways must be fitted with automatic catches or slip connections, and must be so fixed as not to trail on the floor when parted.
