SOUTH ELEVATION



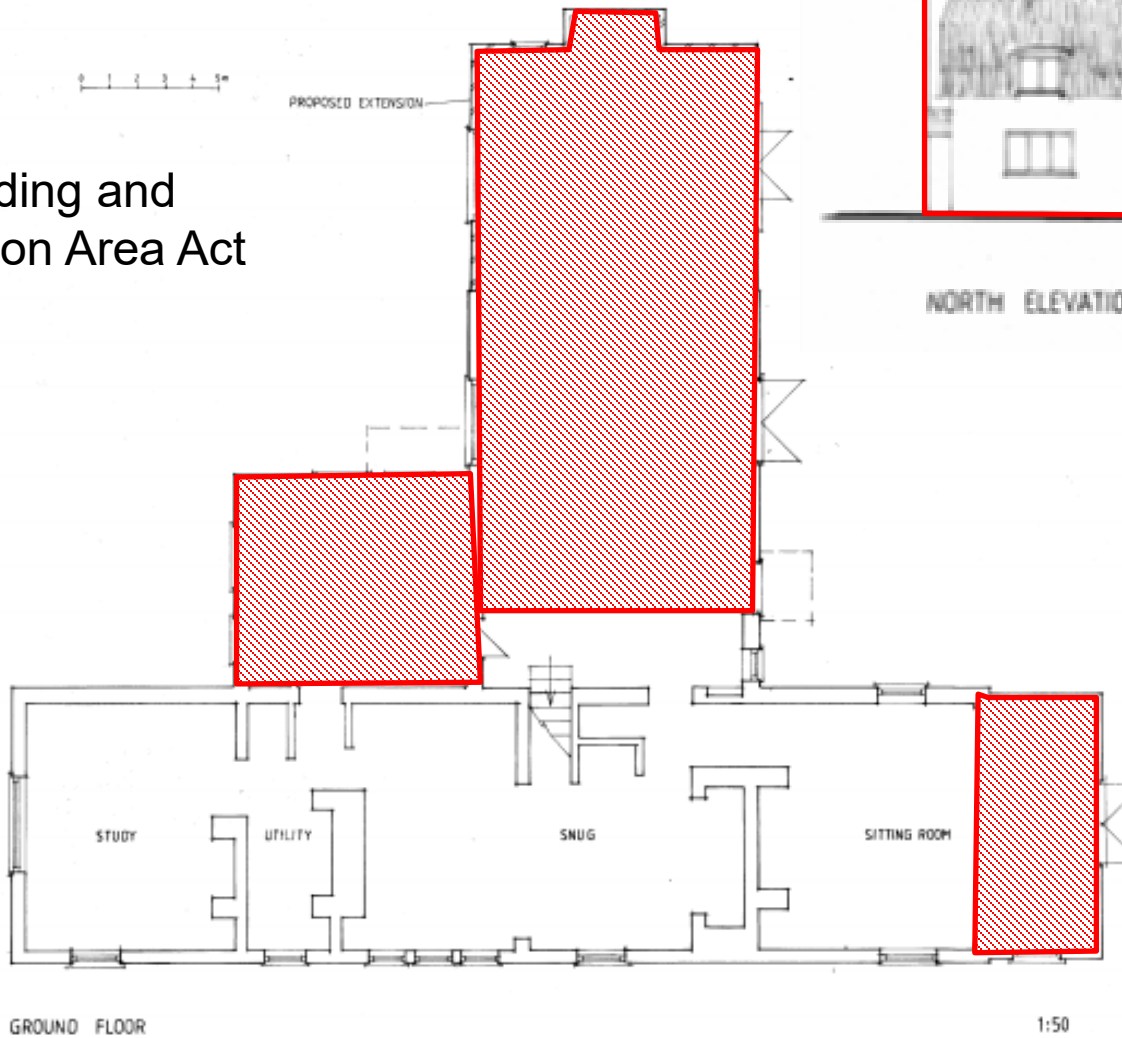
