Dear Mr Rogers,

Thank you for letting us know about the hearing on 5<sup>th</sup> September regarding an application by Vivien Sheriff for a new premises licence in respect of Harry's Meadow. Our objection still stands on the grounds that the site is in a quiet part of the National Park, and we feel that the sale of alcohol will only fuel more unruly behaviour and noise, affecting us and neighbours. The site is also surrounded by Sites of Important Nature Conservation and Wildlife which has already been impacted upon. Increased noise as a result of the sale of alcohol will only cause further harm. The sale of alcohol on site will also take trade away from the Horse and Groom, which the organisers promote as a venue on their website.

Our objections are based on our monitoring of the site over the last two years, which was made easier last year when camping was allowed too close to ours and our neighbours' boundaries. The organisers have other sites and there have been police incidents reported at Harry's Field, Frogham, which coincided with loud music and the sale of alcohol on the night. I am afraid we do not fully understand the process of alcohol licensing. Therefore, we are not sure if this licence is retrospective for this year's camping. Harry's Meadow cannot operate next year or in the future due to the National Park putting an Article 4 Direction on the forest, preventing pop up camping under the out-of-date 28-day rule. Consequently, we are unsure as to the motive for applying for a licence for a camping site that cannot operate at Hale Park (Harry's Meadow) beyond 29<sup>th</sup> August 2022.

I respectfully request that, while we do not wish to attend the hearing in person, the above points are taken into account and put to the applicant. We are aware that neighbours have also objected and hopefully other members of the community will raise concerns shortly in order that they can be taken into account. We hope that Christa Ferguson or Sue Jennings will respond to the above concerns, especially regarding what the granting of a Premises Licence actually allows the Sheriffs to do regarding the sale of alcohol. It would appear that they could sell alcohol all week as well as the weekends, which is clearly unacceptable.

We look forward to a written response.
