#### LICENSING SUB COMMITTEE - 17 JUNE 2019

#### APPLICATION TO VARY A PREMISES LICENCE – THE SAIL INN, QUEEN STREET, LYMINGTON.

#### 1. INTRODUCTION

1.1 The purpose of this report is to provide members with information at the hearing to determine an application to vary a premises licence under section 34 of the Licensing Act 2003. The premises is The Sail Inn, Queen Street Lymington, SO41 9NG.

#### 2. BACKGROUND INFORMATION

- 2.1 The Sail Inn is situated at a busy junction to the eastern end of Lymington, near to the Waitrose store and opposite the Thomas Tripp Public House. A location plan of the premises is provided at **Appendix 1.** The premises are positioned on a busy main road, however, to the rear of the premises are a large number of residential houses and apartments situated in a quiet residential area.
- 2.2 The premises have held alcohol and entertainment licences for a number of years under the Licensing Act 2003 although more recently, it has been previously known both as The Fusion Inn and The Black Cat.
- 2.3 In summary, the current premises licence permits the following:-Sale of alcohol- from 10:00hrs to midnight Sunday to Thursday and 10:00hrs to 02:00hrs on Friday and Saturday.
  Recorded music- from 20:00hrs to 00:45hrs on Saturday.
  Live Music-Monday to Sunday 20:00hrs to 23:00hrs.
  Late Night Refreshment- until 01:30hrs Friday and Saturday.
  Opening hours of premises-08:00hrs to 00:30hrs Sunday to Thursday, 08:00hrs to 02:30hrs Friday and Saturday.

The licence also contains some restrictions, seasonal variations and non standard timings, the full details of which can be seen in the current premises licence (with conditions) as provided as **Appendix 2**.

- 2.4 As members can see from the current licence, a large number of conditions were placed on the licence following a hearing on 10 August 2015. The hearing took place to determine a variation application to extend the hours for the sale of alcohol on Fridays and Saturdays from 01:00hrs to 02:00hrs with the closure hours extending from 01:30hrs to 02:30hrs and the introduction of late night refreshment on Fridays and Saturdays until 01:30hrs. As representations were received from members of the public to this proposal, a Licensing Sub-Committee determined the application. - 2.5 Photographs of the property, front and rear, are provided for members as **Appendix 3**. These photographs also reference the properties next to and above the premises.

The photographs are described as follows-Photo 1- Front of premises, including private side access path designated for smoking Photo 2- Front of premises and Thomas Tripp pub opposite Photo 3- Small area to the front right of the premises Photo 4- View up Queen Street including Kebab shop Photo 5- Back of the premises, access road to the right, next to bakery Photo 6- Back of premises and residence to the left Photo 7- Back garden area and residence at Roundhouse Mews Photo 8- Rear garden area Photo 9- Grassed area to the rear of the premises on St Thomas Park Photo 10- St Thomas Park, view toward car park

#### 3. THE APPLICATION

- 3.1 On 9 April 2019 New Forest District Council received a variation application from Flint Bishop Solicitors on behalf of the Premises Licence Holder – Star Pubs and Bars Limited. The application is attached as **Appendix 4** (blank pages removed).
- 3.2 The variation application seeks the **following:**-
  - **Plans-**Amend the licensing plan in accordance with drawing number 7482-08 revision B dated 31 May 2017 which accompanies the application.
  - Live Music-Extend the daily start time to 10:00hrs, remove the twice weekly restriction and extend the terminal hour to midnight on Friday and Saturday.
  - **Recorded music**-extend to allow an earlier start time of 10:00hrs on Saturdays, remove the current restriction of every other Saturday and add recorded music from 10:00hrs to 23:00hrs Sunday to Thursday and from 10:00hrs to midnight on Friday.
  - Late Night Refreshment-Extend the hours to 02:30hrs on Friday and Saturday and until 00.30hrs Sunday to Thursday.
  - **Films**-Add this provision to the premises licence 08.00hrs to 00:30hrs Sunday to Thursday and 08:00hrs to 02:30hrs on Friday and Saturday.
  - **Non-standard timings**-Remove all existing non-standard timings and add new timings.
  - **Non mandatory Conditions**-Remove all current licence conditions in Annex 3 and replace with updated conditions attached in the variation application.
- 3.3 However, the application does not seek to increase the hours permitted for the sale of alcohol or the opening/closing times of the premises. It is intended that these would remain as set out at Paragraph 2.3 of this report apart from the change to non-standard timings.
- 3.4 Further information about the variation application and the plans for the venue has been provided in section M (a) of the application form. As members can see proposals include refurbishments (internal and external), new Designated Premises Supervisor (DPS) and a "strong focus on the local community with it being family friendly and providing home cooked food"..
- 3.5 Public consultation as required by the Licensing Act 2003 has been correctly carried out and the application has been advertised both on the premises and in the local newspaper.

#### 4. **REQUIREMENTS FOR A HEARING**

- 4.1 The Licensing Authority must hold a hearing to determine the application where relevant representations are made regarding the likely effect of the grant of the application to vary the licence on the promotion of the licensing objectives. These being:
  - 1) The prevention of Crime and Disorder;
  - 2) Public safety;
  - 3) The prevention of public nuisance;
  - 4) The protection of children from harm.

4.2 Members are referred to the statutory guidance issued by the Home Office under section 182 of the Licensing Act 2003 dated April 2018, in particular the sections on the licensing objectives and variations.

- 4.3 In determining the application the Licensing Sub-Committee must give appropriate weight to:
  - 1) The steps that are appropriate to promote the licensing objectives;
  - 2) The relevant representations presented by all the parties;
  - 3) The Home Office guidance;
  - 4) The Council's own Statement of Licensing Policy.

#### 5. **REPRESENTATIONS RECEIVED**

- 5.1 Following receipt of the application a meeting was arranged on-site by Mr Arran Harmer, the Council's Environmental Health Officer. The meeting had been arranged to address concerns with the application and the proposed removal of the current conditions, many of which were placed on the licence to address complaints about noise from the premises. The meeting took place at the premises on 15 April 2019. The Council's Licensing Manager, Licensing Compliance Officer and Mr Harmer were all present. Mr Taylor from Star Pubs and Bars also attended the meeting but unfortunately the proposed Designated Premises Supervisor, responsible for the management of the new venture, was unable to attend.
- 5.2 At this meeting, concerns with regard to the application and the proposal to remove key conditions together with the extension of some licensable activities were raised by Council Officers. Following the meeting, a response from the Premises Licence Holder had been expected, however, this was not received by the end of the representation period. The Environmental Health Officer submitted a formal response and representation which is presented as **Appendix 5.** This representation documentation also proposes further conditions in addition to the later conditions the applicant's solicitor has proposed in the email dated 13 May.
- 5.3 Concerns have been raised with regard to the proposal to remove conditions on a premises licence that permit the late terminal hour and the impact on the crime and disorder licensing objective. These have resulted in a representation also being received from the Police Licensing Officer. This is provided in **Appendix 5**. The representation outlines the history of police involvement at the premises, concerns with previous turnover and management and the impact of being the latest venue in the town together with the removal of key conditions proposed in the variation application. The Police Licensing Officer has also suggested which conditions would be appropriate to keep on the licence in order to promote the licensing objectives.
- 5.4 In addition, during the 28 day representation period, the Licensing Authority received 46 representations from other persons, in the main, these being residents of neighbouring properties and those living in the area close to the premises. Representations were also received from a landlord of multiple properties in the area, the proprietor of a guest house near the premises and the owner of a Pilates studio. These are attached as **Appendix 6**.
- 5.5 The representations highlight concerns that the variation of the premises licence and removal/amendment to the licence conditions will undermine the licensing objectives. A summary of issues that have been raised in the representations are:-

- Increase in Anti-social behaviour (ASB) caused by alcohol,
- Noise issues and disturbance to neighbours in a residential area,
- Noise/ASB in the rear garden of the premises by those drinking and/or smoking,
- Increase in music related disturbance,
- Fears that the venue will become more popular and therefore increase the risk of further disturbances and incidents for nearby residents,
- The addition of live music until the early hours will appeal to a younger clientele, leading to increases in problems,
- Additional crime and disorder for a reduced Police presence to deal with,
- Increased numbers attending the premises, queuing up at the entrance to the premises and also numbers of patrons "loitering" at the end of the night waiting for transport home.
- 5.6 There is no Cumulative Impact Policy for the town and the consideration of "need" for additional or varied licensed premises cannot be taken into account. However, as mentioned in some representations there are a number of licensed premises in the area. For members information **Appendix 7** provides the location of similar licensed premises in the area together with the hours provided by their licences.

#### **Further Information from the Applicant**

5.7 The applicant has provided additional information about the site, the refurbishment and the development of the business at the premises and this is provided at **Appendix 8**. The additional information also includes some email exchanges between a local resident and the Applicant's solicitors regarding the premises when they were unoccupied and plans to lease the premises to the Applicant. The applicant has also provided additional conditions, further to those proposed in the application. The additional conditions are included in **Appendix 8**.

#### 6. LEGAL IMPLICATIONS

- 6.1 This hearing is governed by the Licensing Act 2003 (Hearings) Regulations 2005. These provide that hearings should be held in public unless the Licensing Authority considers that the public interest in excluding the public outweighs the public interest in the hearing taking place in public.
- 6.2 The Applicant and those parties making representations have been invited to this hearing and have been provided with this report and the procedure to be followed at the hearing.
- 6.3 The Applicant and those who have made relevant representations are entitled to address the Sub Committee and to ask questions of the other party as set out in the procedure.

#### 7. RIGHT OF APPEAL

- 7.1 It should be noted that the Applicant and those who have made relevant representations may appeal the decision made by the Licensing Sub Committee to the Magistrates' Court. The appeal must be lodged with the Magistrates' Court within 21 days of the notification of the decision.
- 7.2 In the event of an appeal being lodged, the decision made by the Licensing Sub Committee remains valid until any appeal is heard and any decision made by the Magistrates' Court.

7.3 A Responsible Authority or any person may apply to the Licensing Authority for a Review of a Premises Licence. Whether or not a Review Hearing takes place is in the discretion of the Licensing Authority, but, if requested by a person other than a Responsible Authority will not normally be granted within the first 12 months except for the most compelling circumstances.

#### 8. CONCLUSION

- 8.1 The Licensing Sub-Committee must, having regard to the application and any relevant representations take such steps as it considers appropriate for the promotion of the licensing objectives. Members may:
  - 1) Modify the conditions of the licence or
  - 2) Reject the whole or part of the application.

(and for this purpose the conditions of the licence are modified if any of them is altered or omitted or any new condition is added).

#### 9. **RECOMMENDATION**


9.1 That the Licensing Sub-Committee determines the application to vary the premises licence.

- No patrons carrying bottles, either sealed or open, will be permitted to enter the premises 1. at any time that the premises are open.
- The Designated Premises Supervisor or their nominated representative will be available 2. to receive and respond to complaints at all times that the premises are open to the public.

#### Prevention of Crime and Disorder

Door staff will patrol both inside and outside of the premises checking for suspicious 3. behaviour and will be in touch with the other bars in Lymington Town, via walkie talkies. The premises will have in place Night Watch radio which will enable instant communication with Lyndhurst CCTV operatives. The Designated Premises Supervisor will regularly attend both Lymington and New Milton Pubwatch.

- 4. The premises shall have sufficient cameras located within the premises to cover all public areas including outside of the premises covering the entrance and exit. The system will be able to cope with strobe lighting (where used) and all levels of illumination throughout the premises as well as outside areas.
- 5. CCTV warning signs must be fitted in public places.
- 6. The CCTV system must be operating at all times whilst the premises are open for licensable activity. All equipment shall have a constant and accurate time and date generation.
- 7. The recording system will be able to capture a minimum of 4 frames per second and all recorded footage must be securely retained for a minimum of 28 days.
- 8. Records must be made on a weekly basis confirming that the system has been checked to ensure that it is functioning correctly and that recorded data is being securely retained. Records of these inspections must be kept for at least 6 months and made available to the Police on request.
- 9. The DPS or premises manager must be able to demonstrate that the CCTV system has measures to prevent recording being tampered with, e.g., password protected.
- 10. There shall be sufficient members of trained staff at the premises during operating hours to be able to provide viewable copies immediately to police on request when investigating allegations of offences or criminal activity. Any images recovered must be in a viewable format on either disc or VHS. Footage supplied in a digital format on CD or DVD will also have a copy of the CCTV system software enabled on the disc to allow playback.
- 11. In the event of technical failure of the CCTV equipment the premises licence holder/DPS must report the failure to the Hampshire Western Police Licensing Unit within 24 hours.

#### **Incident Book**

- 12. An incident book will be provided and maintained at the premises. It will remain on the premises at all times and will be available to police for inspection upon request.
- 13. Any incidents that include physical altercation or disorder, physical ejection, injury, ID seizure or drug misuse will be recorded in the incident book. The entry is to include an account of the incident and the identity of all person(s) involved (or descriptions of those involved if identity is now known). Should there be any physical interaction by members of staff and the public the entry will include what physical action occurred between each party. The entry shall be timed,dated and signed by the author.
- 14. If the member of staff creating the entry has difficulties reading or writing then the entry may be written by another staff member. This should however be read back to the person creating the entry and counter signed by the person who wrote the entry.
- 15. At the close of business on each day the incident book will be checked by the manager on duty and any entries shall be reviewed and signed. If incidents have occurred the duty manager will debrief staff (including, where applicable, door staff) at the close of business. Should there be no incidents then this will also be recorded at the close of business in the incident book.

#### **Refusals Book**

- 16. A written log shall be kept of all refusals including refusals to sell alcohol. The premises licence holder shall ensure that the refusals log is checked, signed and dated on a weekly basis by the DPS or manager.
- 17. The refusals log will be kept and maintained at the premises and will be available for inspection immediately upon request by Hampshire Constabulary and any responsible authority.

Records will be kept of such training, which must be signed and dated by the member of staff who has received that training.
- All staff will receive refresher training every six months as a minimum and records are to 24. be kept of this refresher training which should be signed and dated by the member of staff who received that training.
- In addition to their training a written test related to the training given will be conducted 25. before the staff member is permitted to sell or authorise the sale of alcohol. The Premises Licence Holder, Star Pubs & Bars Limited, are a subsidiary of Heineken (UK) who now have approximately 3000 sites in their estate. Given the changes proposed, we have carefully considered the application, the effect on the licensing objectives and the Council's Licensing Policy. These premises have been previously closed for three years and our client has now found an experienced operater to trade the premises with the requested hours and conditions proposed in the operating schedule.

Our client is planning a substantial investment of over £250,000 for these premises to undego an extensive refurbishment to create a premium venue concept offering a great quality selection of food and drink for both the local community and seasonal tourists. The kitchen area is to be extended to meet the demands of the developed food offer while enhancing the pub's ability to cater for larger groups. The dining area will be refurbished and redecorated, creating an attractive environment for customers to enjoy the great new food offer. Overall the premises will benefit from a complete external refresh with a new signage and lighting scheme, creating a welcoming entrance appealing to passers-by. Please note that the proposed changes to the layout are not to take effect until such times as the works are complete and the Licensing Authority are notified.

The new tenant and Designated Premises Supervisor (DPS), Mr Paul Smith, has 30 years experience in the licensed trade and takes his responsibilities under the Licensing Act 2003 very seriously. The premises will have a strong focus on the local community with it being family friendly and providing home cooked food. The Premises Licence Holder have a tenancy agreement in place with the DPS who they will work closely together with in partnership to make the premises successful and an asset to the local community.

The proposed extension of hours for both live and recorded music, along with removing the existing restrictions, would allow the premises the flexibility around trading. In any event no

Premises Licence is required for live and recorded music from 08:00 to 23:00 daily due to the deregulation of the Live Music Act 2012.

Amending the existing permitted timings for late night refreshment and also adding this for the rest of the week from 23:00 until the permitted closing time would allow the premises to sell hot drinks to their customers during these times. We are seeking to add the provision of films to allow the premises on occasions to show pre-recorded films to customers.

The variation application has also been submitted to update the Premises Licence conditions to ensure that they are suitable for the style of operation at the premises moving forward and to uphold the licensing objectives.

Considering the above, we believe that the variation would not have an adverse impact on the licensing objectives and we believe that the measures proposed will ensure the premises continue to promote the licensing objectives, and that these measures are adequate and further conditions are not required.

### b) The prevention of crime and disorder

- 1. No customers carrying bottles, either sealed or open, shall be permitted to enter the premises at any time that the premises are open.
- 2. The premises shall install and maintain a comprehensive CCTV system. All entry and exit points will be covered enabling frontal identification of every person entering the premises. The CCTV system shall continually record whilst the premises are open for licensable activities and during all times when customers remain on the premises. All recordings shall be stored for a minimum period of 28 days with date and time stamping. Viewing of recordings shall be made available upon the request of Police or authorised officer throughout the entire 28 day period.
- 3. A staff member from the premises who is conversant with the operation of the CCTV system shall be on the premises at all times when the premises is open. This staff member must be able to provide a Police or authorised council officer copies of recent CCTV images or data with the absolute minimum of delay when requested.
- 4. A record shall be kept detailing all refused sales of alcohol. The record should include the date and time of the refused sale and the name of the member of staff who refused the sale. The record shall be made available for inspection at the premises by the Police and other officers of Responsible Authorities at all times whilst the premises are open.
- 5. An incident log shall be maintained at the premises and details of all known incidents recorded within the log. The log shall be kept on the premises and be produced to an authorised officer on reasonable request.
- 6. Full training shall be provided to all staff involved in the sale of alcohol on commencement of employment relating to prevention of underage sales of alcohol, proxy sales of alcohol to underage persons and sales of alcohol to a person who is drunk. Refresher training shall be provided at regular intervals at least every 121 months. Records detailing the training provided shall be kept on the premises for-a minimum of 12 months and be made available for production upon request by the Police and other officers of Responsible Authorities.

### c) Public safety

### d) The prevention of public nuisance

- No waste or recyclable materials, including bottles, shall be moved, removed from or placed in external storage receptacles between 23.00 hours and 07:00 hours the following day



Hampshire Constabulary are not opposed to the change in the licensing plan submitted with the application, or point 8 - the removal of existing non-standard timings.

Hampshire Constabulary are opposed to the amendments to regualated entertainment that fall outside of the Live Music Act 2012 and Deregulation Act 2015, and the changes requested to the current conditions (point 9).

The Fusion Inn currently benefits from a premises licence authorising the sale of alcohol until 0200 on a Friday and Saturday. The current conditions were agreed with the applicant at the time of that variation to support the licensing objectives.

The Fusion Inn is presently the latest opening premises in Lymington, and as such requires conditions and an appropriate operating schedule which reflect the client base and authorised hours.

The nature of the town is such that customers for The Fusion Inn have used other local licensed premises for the early part of their evening. Due to the authorised hours, The Fusion Inn has defaulted to being the 'end-destination' venue. This has brought problems with noise, both from regualated entertainment and the general noise of customer outside the venue.

The customer noise is made up of a number of factors, including:

- noise of customers attending the premises, being attracted by the late hours

- noise of customers being refused entry due to intoxication

- noise of those customers who have been asked to leave / ejected and refuse to do so

- noise on dispersal at the end of the night
- noise from the smoking area.

This noise is exacerbated by the close proximity of residential premises, and the narrowness of the road.

It is appreciated that the Licensing Act 2003 is not a mechanism for the general control of anti-social behaviour by individuals once they are away from that premises. However, the public nuscience noted is predominantly directly outside and within the control of the venue.

During the last year of trading, 2016, The Fusion had a number of changes in management. This led

to a considerable drop in standards, increasing crime, disorder and public nuscience. Over the course of the year, the various DPS's were spoken to at length about compliance with the conditions, the impact the business was having on local residents, and improvements that could be made.

Throughout November 2016, efforts were being made to address the continuing issues. This included work to reduce the last entry time from midnight to 2300hrs. At the time of closing, the last entry time was 23:30, the DPS reporting that this step was assisting in reducing issues after midnight.

Other steps, including the use of Body Worn Video recording (BWV) by staff, particularly security staff, restricting the numbers of customers outside, increasing due diligence training as examples, were being discussed.

Before any formal enforcement action took place, the premises closed, and has been closed since.

Of note, immediately following the closure of The Fusion Inn, the customer base moved to a nearby premises which, at the time, had a late premises licence with no conditions. The problems seen at The Fusion migrated to that premises, the eventual decision by that premises licence holder was to reduce the terminal hour for the sale of alcohol to midnight.

A late-trading premises licence in Lymington must have strong conditions in place, and a robust management to enforce those conditions in order to promote the licensing objectives,

Whilst the application has outlined a concept of increasing the food offering, and the current DPS has some 30 years experience, to remove the current conditions whilst retaining the authorised licensable hours will undermine the licensing objectives detrimentally.

Reducing the other due diligence aspects, such as the age verification policy and training, will also have a negative impact on the licensing objectives.

Annex A provides information on some of the police licensing attendance to The Fusion Inn during 2016.

Thank you for your time earlier today to discuss the variation to the premises licence with myself, Christa Ferguson (Licensing Manager) and Peter Donelan (Licensing Enforcement Officer). I have provided a summary of the key points we discussed below.

As you are aware, this department has significant concerns over the removal of key conditions from the licence (relating to the Prevention of Public Nuisance) and the extension of some licensable activities (mostly in relation to live and recorded music).

There is a considerable history of issues associated with the premises arising from music and people noise causing a nuisance to the surrounding area, which has culminated in several abatement notices (in respect of statutory nuisance) being served on previously licensee's.

I would stress that the majority of the current conditions and timings on the premises license have come about as a result of issues identified and significant consultation between all parties to mitigate any impact.

In terms of music noise, it has been highlighted on a number of occasions that the premises is not suitable for regular late night live and/or recorded music as it is structurally attached to a neighbouring property.

Historically, a noise limiter has been employed to control noise being transmitted through the structure of the building as this cannot be effectively monitored by staff; however, even with the use of a noise limiter certain elements of live music (bass frequencies: drums, bass guitar etc.) have proven to be very difficult to control given the nature of the premises- hence the restrictions on the terminal hour and frequency of such activities. Regulated entertainment on a very limited basis (i.e. live music ceasing at 23:00hrs and recorded music every other Saturday) has been acceptable in the past; however, increasing the timings and frequency of such music, especially without the aid of a noise limiter will undoubtedly cause nuisance.

Similarly, due to the very close proximity of the rear garden to a number of residential properties (several metres), the use of the area beyond 23:00hrs (even if just for smoking) is likely to cause problems. Smokers are currently directed to the front of the premises after 23:00hrs to minimise nuisance.

In terms of people noise, again, there is a history of issues associated with people out the front of the premises and large numbers of people congregating on the street/ in the road, especially after other pubs in the vicinity have emptied out. I believe I'm correct in saying that the Fusion Inn currently has the latest licence in Lymington and is therefore naturally attractive to receiving an influx of customers late at night, which has historically been very difficult to manage and has brought about extensive issues- hence the conditions relating to door staff and last entry. Since the closure of the Fusion Inn, this very issue was recently observed at The Borough Arms in Lymington which at the time had the latest licence. The removal of the conditions relating to door staff, re-entry of patrons late at night and restrictions on those using the front of the premises to smoke etc. will undoubtedly result in issues associated with crime & disorder/ public nuisance by virtue of the opening hours and location.

In light of the above, the application in its current format is likely to undermine the licensing objectives and is therefore not acceptable to Environmental Health.

There is scope to vary the licence, however, suitable controls in relation to the key points outlined above must form part of any granted licence.

Following our meeting, you advised that you may wish to reconsider the opening hours (a midnight closing time was muted) as this may help address several of the above issues.

Once you have a clearer idea of the changes you wish to make in light of the concerns raised, please advise our licensing team accordingly so we may assess the application further.

I have copied the Police into this email in case they wish to add anything at this stage.

In the meantime, I am happy to discuss the situation further should you need.

Thank you for your email.

Could you confirm whether the suggested conditions are intended to <u>supplement</u> or <u>replace</u> those accompanying the initial application listed in box D under the heading Prevention of Public Nuisance (numbered 7-13)?

Assuming that these conditions are intended to supplement the conditions initially suggested, they go a little way towards allaying my concerns; however, they do not adequately address the issue of music noise emanating from the premises. As such, I would like to see the following conditions retained from the existing premises licensing:

36. All music noise emanating from the premises, whilst it may be audible shall be so low that distinct tunes,

lyrics, musical instruments and any bass beat cannot be recognised at the boundary of all noise sensitive premises.

For these purposes, noise sensitive premises shall include premises used for residential purposes, hospitals or similar

institutions, educational establishments (when in use), places of worship (during recognised times and days of

worship) and any other premises used for any other purpose likely to be affected by music noise .

39. The noise limiting device installed shall be retained and maintained in good working order and all amplified regulated entertainment shall be channelled through the device and shall not exceed a noise level

determined by Environmental Health Officers from New Forest District Council . The maximum noise level set by

Environmental Health Officers from New Forest District Council shall be reviewed as required by Environmental

Health Officers from New Forest District Council.

### 40. The noise limiting device shall be sealed to avoid tampering

In addition to the above, I have concerns relating to the provision of live music until midnight on Friday and Saturday nights. Previous experience from has shown that it is very difficult to control live music from this premises (especially that which is amplified or contains drums or bass) given the proximity to nearby properties. Therefore, it would be sensible to retain controls relating to the restriction of live music; namely:

- Live music shall only take place indoors (condition 30); and
- · Live music shall only take place on two occasions per week (Box E); and
- cease at 23:00hrs Monday to Sunday

I would be grateful if you would confirm that you are agreeable to retaining the above conditions and restrictions, so that I may withdraw my representation.

Following on from the emails on this matter and whilst I wait for our client to respond to me regarding postponing the hearing date, please find below a list of conditions which we wish to propose and add to our application:-

- 1. Door staff shall be employed at the premises on Friday and Saturday whenever the premises trade after 01.00. Door staff shall commence no later than 23.00 and will remain on duty until 30 minutes after the premises are closed to the public to aid with the dispersal of customers
- 2. No new customers shall be permitted entry to the premises after midnight. Re-admission to existing customers to retrieve personal belongings and those who have gone outside to smoke is permitted
- 3. No customers shall be allowed to use any external area of the premises after 23.00 hours, except for customers permitted to temporarily leave the premises to smoke in the external area to the front of the premises. No drinks shall be permitted to be taken into the external area after this time
- 4. A Challenge 25 proof of age scheme shall be operated at the premises where the only acceptable forms of identification are recognised photographic identification cards, such as a driving licence, passport or proof of age card with the PASS Hologram
- 5. Full training shall be provided to all staff involved in the sale of alcohol on commencement of employment relating to prevention of underage sales of alcohol, proxy sales of alcohol to underage persons and sales of alcohol to a person who is drunk. Refresher training shall be provided at regular intervals at least every 6 months. Records detailing the training provided shall be kept on the premises for a minimum of 12 months and be made available for production upon request by the Police and other officers of Responsible Authorities

I was alerted yesterday to the new application, suddenly sprung upon us, by Star Pubs and Inns for the Fusion Inn, Queen Street, Lymington.

I have now read the details of this application cable tied to the rear temporary security fence on the garden exit of the Fusion Inn. In principle, I would welcome a new owner or tenant at the Fusion as it is now, as a property, an utter disgrace to our beautiful town - it currently looks like a derelict blot on the landscape and an embarrassment to the locals and passers bye. BUT - this new application is ludicrous and totally unacceptable to me and I am sure my neighbours.

I am sure you will hear more from then individually and collectively.

This part of elegant Lymington is a compact residential area. The new application is for variation of the current license to extend starting times and late night music until way after midnight with opening hours up to 2.30am at weekends. I am writing in connection to the variance of licence for The Fusion Inn, (to be named The Ship Inn), on Queen Street, Lymington, as described in The Lymington Times on Friday 12 April.

I wish to make objection to this application. First might I point out that the insertion in The Lymington Times was printed with such small print, it was almost impossible to read. My sight is not unduly poor, but I had great difficulty in being able to see what had been written. One might suspect this was intentional!

I wish to object to this extension and alteration of licence on the grounds that it is unnecessary, and that it is not appropriate to the ambience of the area.

This is largely a quiet residential area, with a considerable number of elderly residents. The noise and potential nuisance from live music, recorded music and film, until 02:30 in the morning is considerable, and certainly not conducive to the make up of the surrounding streets.

Since the arrival of Wetherspoons (The 6 Bells), the increase in noise and broken glass has been considerable. Residents often have to clear away broken bottles and glasses from the small road that joins St. Thomas Park to St. Thomas Street, as well as needing to remove bottles and glasses pushed into fences and hedgerows. 

We strongly object to the application for the variation as lodged with N.F.D.C. on the 09/04/19.

Our reasons are as follows:

1. Many years ago when the public house was called The Olde English Gentleman it was approximately six metres away from our home. It was then extended many years ago and to our astonishment no noise installation was installed. Our external wall was used as the internal wall in what was renamed The Black Cat. The girder beams were left resting on our bedroom wall and as I was in the building industry I was aware this contravened building regulations as no dividing wall was built. We complained to N.F.D.C., the planners did not intervene and after much discussion told us the plans had been mislaid and were no longer available.

This is still the current position and has been proved on two separate occasions, once when The Black Cat contravened its licensing conditions and again when New Forest Environmental Health was involved because of the volume of noise emulating from the then called Fusion Inn in 2015. On both occasions at N.F.D.C. our objections were upheld and noise limiters were installed in The Fusion with monitors in our home.

The application as in item 6 and 7 ask for the removal of these conditions alongside the removal of all Annexe 2 conditions. These were put in place by the Licensing Committee so that we could have 'our human rights.'

2. My wife has recently been diagnosed with a terminal illness. If the license is granted as per the application, the customers will leave The Sail Inn at approximately 1.00am Sunday to Thursday and approximately 3.00 am on Saturday and Sunday mornings. Added into this equation, unrestricted music noise will be from 10.00am until 11.00 pm all week and an unlimited volume from live bands on Friday and Saturday nights until midnight. I will, under no circumstances whatsoever, tolerate this intrusion into our private lives again. During one hearing re. the noise, the barrister representing the public house came into 24a Queen Street, our home and agreed that noise levels were intolerable. I am writing in respect of the request for an extended licence for the Sail Inn formerly the Fusion Inn, Lymington.

We own and operate a guest house around 200 yards from the premises in question. Back in the days when the pub was operational and called the Fusion an extended hours licence was granted to them I believe on the basis that it was assumed that people would leave at different times from the pub rather than everybody leaving at the normal licencing hour of 11pm and thus reduce trouble and noise. I can assure you that this idea is nonsense. Agreed people did leave at different times but made the same amount of noise when they were leaving and caused the same amount of trouble, so nothing was achieved by this as to the benefit of anyone but the licensee and clientele. People screaming and shouting and swearing at each other in the street in the middle of the night actually caused a lot of distress and loss of sleep to us, mostly all nearby residents and our guests who rent rooms both at the front of our property which is on the Southampton Road and at the rear which is close to the sports field car park and rear entrance to the pub.

Some people might say you chose to live where you do knowing that a pubs were in the vicinity and yes we did but that was when we had normal licencing hours the noise was generally over by 11.30. Some people might say we should install double glazing, well we have, but double glazing isn't very effective when you sleep in the summer months with your window open and everyone should have the right to do that without pub goers waking them several times a night from the time they retire up until 4 am in the morning with their inconsiderate behaviour.

I wish to make an objection to this application on the grounds of public safety.

I note from the application that the new management of these premises wish to extend the hours of the establishment to 00.30 on Sunday to Thursday and 02.30 on Fridays and Saturdays. I am concerned that customers of the premises, probably mainly young people who may have consumed a quantity of alcohol will be leaving the Sail Inn in the early hours with no obvious means of getting home. Unlike Southampton, Reading or other big towns and cities there are no all night buses, no trains after 22.36 and precious few taxis. I also understand that the street lights are dimmed between 1 and 4am. Having raised two children myself in the area I have spent many a night worrying how they were going to get home and although they always did it was sometimes not without incident.

I am also concerned that staff at the Sail Inn who work these long hours may not get the statutory 11 hours break between shifts if the premises are open again the next day. This is a regulation that I know again from experience is frequently ignored by employers especially in the hospitality industry. Who will be checking that someone who is still clearing up at 3am on Sunday morning is not 'persuaded' to come back in to open up again for lunchtime the same day?

Please note that although I live fairly close the the Sail Inn I am not objecting on the grounds of noise. I am not one of those people choose to live in the centre of a town and then expect it to fall silent at 7pm.

Please take these matters in to account when considering this application.



The Fusion Inn, now to be renamed The Sail Inn is about to be open in May according to their website.

They have a licensing application asking for music and refreshment until 0030 hours all week with the customers leaving at 001am. On Fridays and Saturdays nights they have applied for live music and the Inn to close at 0230am with customers leaving at 003am.

They have also requested that all of the previous restrictions on The Fusion Inn to be lifted. This will mean that any customers can access the premises at any time. They want the noise restriction to be lifted, no security guards on the doors, the garden and rear access is to be accessible at all times and the windows that had to be closed to be open.

I wish to object in the strongest possible terms to the pending application to vary the premises licence (S34) in respect of The Sail Inn, Queen Street, Lymington SO41 9NG as submitted 09/04/2019 by Star Pub & Bar Limited.

Chief among my concerns is the application to extend the licence to 02.30am on Fridays and Saturdays and to 00.30am on every other day of the week.

I have numbered the paragraphs of this rather lengthy objection for your convenience. In each I try to make a different point.

- The premises to which this application relates sit in a largely residential area of Lymington. Extending the licensing hours until 02.30am on Fridays and Saturdays – a full 2 hours and 30 minutes later on a Friday and Saturday than most pubs in town – is likely to seriously affect nearby residents' quality of life at weekends, increase the level of public nuisance experienced by residents in surrounding streets and lead to an increase in late night/early morning crime and disorder offences in the area.
- 2. The application to extend opening hours to 00.30am on every other day of the week a full 1 hour 30 minutes later than almost every other licenced premises in Lymington opens during the week and later than many of them open at the weekend is also unacceptable. Residents in neighbouring streets, myself included, have families of school age and work in the mornings. The prospect of being woken up in the small hours during the week by people making their way back from The Sail Inn at half-past-midnight and, no doubt, much later as patrons loiter in the streets, fills me with dread and will no doubt have a material impact on my family's quality of sleep during the week in addition to the prospect of sleepless weekends.
- 3. There is already a degree of late night noise, mainly at weekends, experienced by local residents in the streets near Queen Street, including Southampton Road, due to people leaving Lymington's many licensed premises. Loud conversations and shouting often wake residents, litter from fast food premises is dropped, and there are occasionally street fights and minor acts of drink-induced vandalism and theft, such as stealing the lids from rubbish bins.
- 4. However, thanks to the sensible licensing hours enforced in the town this period of noise, and occasionally anti-social and criminal behaviour, tends to be over not long after midnight at the weekends, and much earlier during the week when there is very little disruption.
- 5. It is beyond question that allowing The Sail Inn to open until 02.30am on Fridays and Saturdays (and to serve alcohol until 02.00 am) will lead to a rise in drink-related noise, anti-social behaviour, violence and vandalism by some of the patrons leaving the premises in question. There can be no doubt that many of the people leaving The

Sail Inn after 02.30am will have consumed much more alcohol than those who left the town's other pubs much earlier and went home. This will mean that some people leaving The Sail Inn will be drunk or very drunk with all the potential problems this creates in terms of loud, drunken street conversations, shouting, arguing, litter, public urination, violence and other illegal acts.

- 6. No amount of conditions attached to the licence, for instance making the licensee responsible for putting up notices urging patrons leaving the premises to be respectful of local residents, will make a difference to the behaviour of a large number of drunk, noisy and potentially violent people once they are away from the venue and on the neighbouring residential streets in the small hours of the morning during the week and, especially, the weekend.
- 7. It goes without saying that many patrons leaving these premises will not disperse quietly and quickly, but will hang around the area, perhaps getting something to eat from any fast food outlets that seek to capitalise on any successful licensing extension by extending their own opening hours, or waiting for a taxi. This will strongly increase the likelihood of noise, anti-social behaviour and violence well beyond the actual closing time of The Sail Inn itself, meaning local residents will be woken up and kept awake until 03.00am, 03.30am or later.
- 8. The reopening of these licensed premises will, even without the granting of a late licence, also increase the number of late night/early morning traffic movements in the area, and the associated noise from car and taxi engines, doors closing and car stereos. Currently, thanks to sensible licensing restrictions, the streets around Queen Street see little in the way of traffic beyond midnight at the weekends. Granting The Sail Inn a licence until 02.30am on Fridays and Saturdays, and until 00.30am every other day of the week, will change that situation dramatically, and additional traffic will compound the levels of noise created by people in the street in the small hours of the morning.
- 9. It is highly likely that, given its pursuit of late licence and market positioning as a music-based venue, The Sail Inn will attract a relatively young clientele. The Sail Inn is unlikely to hold much appeal for older customers out to enjoy a few quiet drinks and then home to bed. The relative youth of the likely clientele and their natural exuberance combined with alcohol gives me additional concerns about the risk of rowdiness and public nuisance from patrons leaving the premises in the early hours. Put it this way, if it was a traditional folk club seeking a late license I would be less concerned about some of the potential disruption, although by no means unconcerned by the lateness of the proposed closing times. But it is not going to be a traditional folk club.
- 10. Overall, the racing certainty is that the granting of a 02.30am licence to these premises will lead to more calls to the police from local residents reporting noise, arguments, fights and vandalism. All of which will increase the workload for our already stretched police service, not to mention paramedic and ambulance services called to deal with drink-related injuries.
- 11. I am all for more live music but that should not be an excuse to extend licensing hours to 02.30am for premises in residential areas. Indeed the licensing variation application for The Sail Inn states that live music will be allowed no later than

midnight at the weekends – two-and-a-half hours before the proposed closing time and that recorded music will be allowed until 00.45am on Saturdays still an hour-and-45-minutes before closing time. The Thomas Tripp pub, opposite the proposed Sail Inn to which this licence extension application relates, is known for its live music. The TT, as it's known, manages to be a popular music venue which closes at 11pm during the week and midnight on Fridays and Saturdays. It is therefore hard not to conclude that this application to vary the licence for The Sail Inn has more to do with facilitating drinking into the small hours of the morning than with any desire to provide live music fans with another venue.

- 12. Another very important factor to consider is that the granting of such a late weekday and weekend licence to The Sail Inn would set a precedent, making it harder for the council licensing authority to refuse future applications for late licences from other licensed premises in Lymington. Granting this variation in licence would invite a domino effect that could significantly change the nature of Lymington for the worse, causing misery for the many people who live in and near the town centre.
- 13. Lymington attracts many residents who are retired as well as those with families who appreciate the town's charms, its community, access to the sea and the forest and, of course, the relative peace, tranquillity and quality of life that living in a smallish town like Lymington affords. A pub licensed until 02.30am is detrimental not only to the quality of the lives of the residents living near the premises not to mention potentially negatively affecting property values since it goes without saying that the close proximity of a late night pub tends not to appear on estate agent's lists of selling points but also to the character and appeal of Lymington as a place to live.
- 14. One of the beauties and attractions of Lymington is that people still live in, and very close to, the town centre. For very many people the High Street is only a short walk. Lymington's town centre is, thankfully, not some hollowed-out commercial and entertainment zone which at night, and especially at the weekends, turns into the sort town centre blighted by binge drinking and all of its associated problems. This late licence application is wholly at odds with the essential nature of Lymington and the quality of life enjoyed by its residents. The last thing Lymington needs is to gain a reputation, deserved or undeserved, as a magnet for binge-drinkers who trash the town every Friday and Saturday. Such reputations have led to families and the middle classes fleeing many an English town for better places to live. If this late licence is approved I fear that will be the first of many late night licences to follow in Lymington.
- 15. By all means allow The Sail Inn to provide live and recorded music, but do so within licensing hours that reflect its location in a residential area. Or, if someone wants to open a late licence venue, then let them do so in premises well away from a residential area of Lymington. As someone who runs his own business, I appreciate the need to allow businesses to meet perceived market demand and also the benefits of creating employment. No-one wants to see any business premises lying unoccupied. But there is a reason why, for example, planning authorities don't allow cement works to set up shop in the middle of charming market towns. It wouldn't be in keeping and would be better sited elsewhere. The same goes for pubs/clubs seeking to open until 02.30am in residential areas.

16. The proposed variation will result in overall harm to the public good (evidenced by my experience of the results of the terms of the existing license) by effecting the promotion of the following licensing objectives:

- a. The prevention of crime, disorder and anti-social behaviour,
- b. The prevention of public nuisance,

within a mixed business and <u>residential</u> area which is already populated with a licensed premises offering extended opening hours and live music<sup>1</sup>.

2. **Crime, disorder and antisocial behaviour.** As a result of the operation of the premises under the current license the following anti-social behaviour<sup>2</sup> is witnessed routinely in Queens Street at all hours: nuisance, rowdy or inconsiderate behaviour, vandalism and graffiti, street drinking and littering. Crime and disorder (abusive and violent behaviour) was witnessed periodically particularly leading up to and post closing time<sup>3</sup>. The proposed extension of hours is likely to increase these occurrences in both volume and potentially severity.

3. **Public Nuisance.** As a result of the operation of the premises under the current license excessive noise is routinely experienced from the following:

a. the premises itself (customers and music).

b. customers queuing for, entering or leaving the premises, and loitering in Queens Street, often up to 1 hour after closing time.

c. customers entering or leaving via St Thomas Park.

The noise nuisance has most impact late-evening or early morning when attempting to sleep or sleeping. The proposed extension of hours is likely to increase the period of disturbance to residents potentially up until 01.30 Weekdays and 03.30 on Saturday and Sunday mornings.

4. **Responsible Licensee**. It is highlighted to the Committee that The Fusion Inn is not currently being operated and as such the application for extended hours is in the context of no existing proof of the responsible supervision by the licensee of the sale and supply of alcohol, further risking the promotion of the following licensing objectives.

5. **Appropriate License Controls**. Given the above concerns / observations the following license controls would be seen as appropriate:

a. Refreshments, Music and Films no later than 22.00 Sunday, 23.00 Monday – Thursday, 23.59 Friday and Saturday.

6. I am prepared to attend any hearings if available and I acknowledge that my representation will form part of a public document at a hearing,

I have received a notice through my letter box concerning the above. The purpose of this e-mail is to object in the strongest possible terms to this application. For some 34 years I have been the owner/occupier of 29 Southampton Road, Lymington and I have long experience of what happens after the said venue reaches closing time. In recent years when it was the Fusion Inn things were not so bad because the venue closed reasonably early and it was in the main a restaurant. However the same was not the case when it was known as the Black Cat. At closing time which was long after 23.00 large numbers of drunken young people would trapse in gaggles up Southampton Road, sometimes rowing and fighting, screaming young girls, totally disrupting the sleep of the residents and making them fear for their safety. Regularly rubbish such as packaging for take away meals, condoms and bottles were tipped everywhere including into the front gardens of the homes along Southampton Road. On one occasion I even found a hypodermic needle. The Black Cat itself was a semi night club and it seems as if this is what is proposed here. The longer the drinking hours permitted the more drunk people will get and the worse will be the problem. Many of the discarded bottles ended up broken risking punctures to the tyres of cars and personal injury. Compared to the days of the Black Cat we simply do not have the police presence that we used to have.

If this application is granted it will provide a a nightmare to those who live close by and have to endure the nuisance. Southampton Road is totally residential and not typical of a town centre.



# 'Pubs will prosper' under Heineken's proposed £50m investment

Heineken's bold £50m investment programme, that will see the refurbishment of 150 pubs, has been hailed as a 'much-needed' boost to the industry.

The Morning Advertiser reported last month that the brewer and pubco giant had announced plans to invest the substantial figure, which will create an estimated 1,200 hospitality jobs, as well as seeing 150 pubs refurbished.

The world's second largest brewer has already siphoned £190m into the refurbishment of its estate since 2013 and now 150 more of its 2,700 sites have been earmarked for an average spend of £250,000 per venue.

# Customer spend impact

Having already pumped millions of pounds into hundreds of its Star Pubs & Bars businesses over the past six years, its 2019 investment is set to become the most the Dutch brewer has ever spent on UK pubs.

Star Pubs & Bars managing director Lawson Mountstevens dubbed the significant investment as a "breath of fresh air" for the category and explained that such investment will help impact customer spend.

"Investment can impact customer spend quite dramatically indeed," said an enthused Mountstevens.

"The clear majority, if not all, will open up a quality food opportunity to attract a new type of punter.

"All our major investments are focused on a true transformation of the pub and, furthermore, the investment has got to work for the operator.

"Ultimately, they need to be able to deliver a plan in order to drive a sustainable business – otherwise it's a very poor investment for all involved."

## **Tender loving care**

Focusing on investing in a mixture of Star and former Punch pubs, Mountstevens said that the investment comes at a time when attention must be given to pubs that had been neglected and uninvested in over the past five years.

He added that operators can make financial contributions themselves, dependant on the nature of the agreement, investment and style of pub.

"Regardless of all that, all the way through, we would have an outline view and vision in order to get the process moving," Mountstevens concluded.

"For example, if you think of someone that's quite new to running pubs, then we would probably take much more of a leading role.

"On the other hand, a more mature operator would have a clearer understanding of what they want and what they don't want."

The plans to spend a record amount on transforming dozens of its pubs in the UK comes as the Amsterdam-based brewer searches for growth opportunities in a mature market – even as the prospect of Britain leaving the EU looms.

The investment also comes at a time when almost one in four pubs have closed across Britain since 2008 – the Government's statistics agency said last November – bringing the total in the country to about 39,000.

# Heineken promises £50m for 150 pubs

Brewer and pubco Heineken has ring-fenced £50m to pump into 150 of its Star Pubs & Bars sites, a record sum for the business, which is estimated to create 1,200 jobs in the sector.

The company has already siphoned £190m into the refurbishment of its estate since 2013 and now 150 more of its 2,700 sites have been earmarked for an average spend of £250,000 per venue.

All aspects of the pubs lined up for investment will be considered, including gardens, kitchens, bars, snugs and toilets.

Star said bespoke refurbishments will be given to each pub to emphasise various characteristics, while environmentally friendly technology Smart Dispense will also be installed.

Refurbishments won't be about creating "a nicer pub", said the group, but about enhancing the customer experience and generating better returns for licensees.

# The great British pub

"We believe in the great British pub," said Heineken UK managing director David Forde. "We've invested just shy of £200m in the past six years into hundreds of our Star Pubs & Bars businesses.

"They all have bespoke refurbishments that respect the heritage of the buildings, keep the soul of the pub, and give a fresh and welcoming look for its locals.

"Pubs are the hubs of communities – they are where people meet, chat and laugh, where we enjoy everything from pub quizzes to karaoke, from a quiet pint to a fabulous home-cooked meal," he continued.

"Some would have you believe the pub is in danger. We are in the business to keep pubs open and thriving, providing a boost to the local community."

The Extraordinary Hare in West Hendred, Oxford, has already received £500,000 of investment, having been boarded up for four years.

The only pub in the village is now said to be thriving, with a new exterior, exposed brickwork and original fireplaces the focus of the renovation. Some 10 jobs have also been created in the community as a result.

### Forgotten by many

Licensee Kate Hayden said: "The Extraordinary Hare had been closed for so long that it had been forgotten by many people.

"There's plenty of competition and expectations are high, so changes had to be eyecatching to put it back on the map.

"The response has been amazing. Residents are delighted to have their local back and are using it for all sorts of different occasions."







I was delighted, and so were my neighbours, to receive your e-mail of January 5th, 2018 informing me that - and I quote you " the lease has been signed and that work is due to start on site imminently". Well Karen, I know you meant well and your intentions sincere and so we had no reason to doubt your word - after all you are a lawyer ! We were optimistic that at last Star Pubs had found a new tenant and encouraged that the plan remains for the premises to be turned back, as you stated, in to a traditional "Great British Pub". But, Karen the harsh reality is that nothing has happened here in 10 weeks whatsoever - in fact the situation has deteriorated even further to the point where action has to be taken.

where thieves and con men run riot, I can only conclude that the Area Manager was telling massive Porky Pies - excellent Cockney rhyming slang to exclude those not in the now.

The Fusion Inn continues to crumble into an ugly eyesore, battered, neglected, grimy and derelict, a gaunt shell of a pub and a hideous blot on our landscape. The rear single gate lies hanging from one rusty hinge edged by broken glass since the debacle on New Year's Eve. Old beer barrels roll across the garden courtyard and rubbish accumulates in the storage area becoming a health and safety hazard. One month ago, a security man arrived, much to my surprise. I happened to be outside. He was taking over from the previous security man, whom we hardly ever saw. The new chap was looking for the key to get into the Fusion Inn as it had been left somewhere under a brick outside. He asked me if I knew which brick it was under. This incident alone deserves a Dad's Army award. None of us can understand why the Fusion Inn was not secured properly at the back in the first place. Matters though have got much worse.

Last Wednesday around 11.30pm I heard scuffling and shouting outside which came from the garden area and I think a couple of chaps were searching the storage huts. Last night there was a break in through the side window ( one window is permanently open above the rear door) and the fear is that it now won't be long before rogue travellers - squatters - take over the Fusion Inn which has dangerous implications. It is our intention to do something about this before matters totally get out of hand.

I would ask you please to seriously get on the case. I hope that that you won't be fobbed off again with idle words from the Area Manager. I feel it would be more productive if I made contact with the Managing Director of Star Pubs - do you have his e-mail details ?

I am trying to get in touch with the person of the VPS company, which I believe is part of your Group, that has the agreement to oversee the security of the Fusion Inn in Lymington. This pub has been closed for many months now but the back courtyard garden is wide open with very poor security. The place is grim, derelict, decrepit and seriously delapidated now, and is a blot on the landscape. I gather Star Pubs are having great difficulty in finding a new tenant for the Fusion Inn. On Christmas Eve there were several drunken youths celebrating Christmas, I assume, but their behaviour was out of order and a damn nuisance at 11pm. ( or any time for that matter ) The rear of the pub is open to the public as one gate fell off 3 years ago and was never replaced and the second gate is left swinging from one old broken rusty hinge, ( the lack of gates is an infringement of their New Forest District Council license) This provided the opportunity for the troublemakers on Sunday evening to roll empty beer barrels across the old garden paving stones they opened the 2 storage sheds, presumably for items to steal and they threw beer glasses across the courtyard and there is a lot of broken glass outside and the open shed doors clatter away.
