### 2. PLANNING APPLICATIONS FOR COMMITTEE DECISION

# (a) Land West of Burgate, Salisbury Street, Fordingbridge (Application 21/11237) (Pages 5 - 78)

Hybrid planning application comprising: Outline planning application (all matters reserved except means of access only in relation to new points of vehicular access into the site) for resident development and change of use of land to Alternative Natural Recreational Greenspace, together with a community hub (to comprise a mix of some or all of; local non-food retail, community use and business use) and all other necessary on-site infrastructure. Full planning application for the first phase of development comprising 112 dwellings, public open space. Alternative Natural Recreational Greenspace, surface water attenuation and all other necessary on-site infrastructure.

#### **RECOMMENDATION:**

Delegated Authority be given to the Executive Head of Planning, Regeneration and Economy to **GRANT PERMISSION** subject to the completion of a planning obligation entered into by way of a Section 106 Agreement and the imposition of conditions.

# (b) Roseville, 11 Yew Lane, Ashley, New Milton (Application 22/11064) (Pages 79 - 92)

Erection of detached chalet dwelling; new vehicle access from Yew Lane.

## **Human Rights**

In coming to this recommendation, consideration has been given to the rights set out in Article 8 (Right to respect for private and family life) and Article 1 of the First Protocol (Right to peaceful enjoyment of possessions) of the European Convention on Human Rights.

## Equality
