**Annex 1 - Mandatory conditions**

**Where licence authorises supply of alcohol:**

- (1) No supply of alcohol may be made under the premises licence:
  - (a) at a time when there is no designated premises supervisor in respect of the premises licence, or
  - (b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.
- (2) Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

**Where licence authorises door supervision:**

- (1) Each individual at the premises to carry out a security activity must be licensed by the Security Industry Authority.
- (2) But nothing in subsection (1) requires this condition to be imposed:
  - (a) in respect of premises within paragraph 8(3)(a) of Schedule 2 to the Private Security Industry Act 2001 (c.12) (premises with premises licences authorising plays or films), or
  - (b) in respect of premises in relation to:
    - (i) any occasion mentioned in paragraph 8(3)(b) or (c) of that Schedule (premises being used exclusively by club with club premises certificate, under a temporary event notice authorising plays or films or under a gaming licence), or
    - (ii) any occasion within paragraph 8(3)(d) of that Schedule (occasions prescribed by regulations under that Act).

(3) For the purposes of this section:

- (a) "security activity" means an activity to which paragraph 2(1)(a) of that Schedule applies, and
- (b) paragraph 8(5) of that Schedule (interpretation of references to an occasion) applies as it applies in relation to paragraph 8 of that Schedule.

**Annex 2 - Conditions consistent with the operating schedule**

**P) Proposals by the applicant in order to promote the four licensing objectives:**

**a) General -- all four licensing objectives (b,c,d,e)**

The premises have a nominated premises supervisor to ensure that alcohol is not taken off the premises.

**b) The prevention of crime and disorder**

The premises have been in business in the town for over twenty years and have a good relationship with the local Police.

**c) Public Safety**

The premises have adequate lighting inside and outside. Clear exit signs and a seating capacity for forty five persons. The premises have a policy to exercise due diligence with regard to health and safety and fire.

**d) The prevention of public nuisance**

A smart/casual dress code policy applies.

The premises do not promote 'Happy Hour' drinking offers.

**e) The protection of children from harm**

The legal restrictions on the admission of children and do not serve alcohol to underage children.

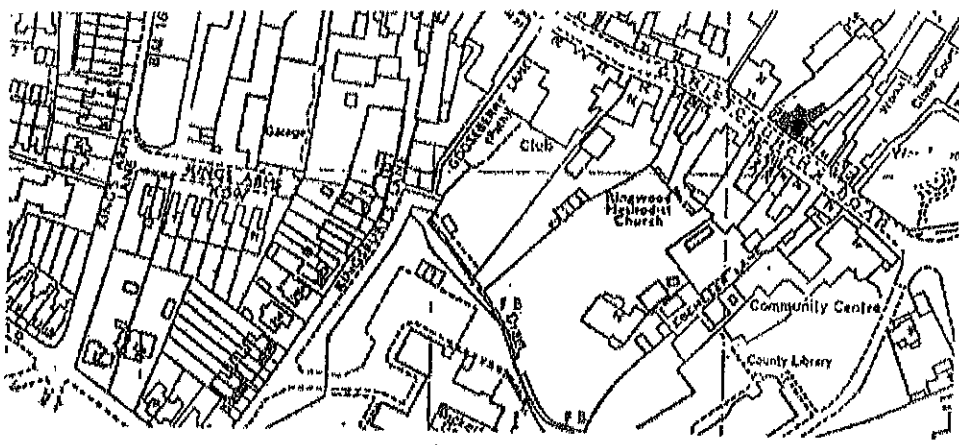

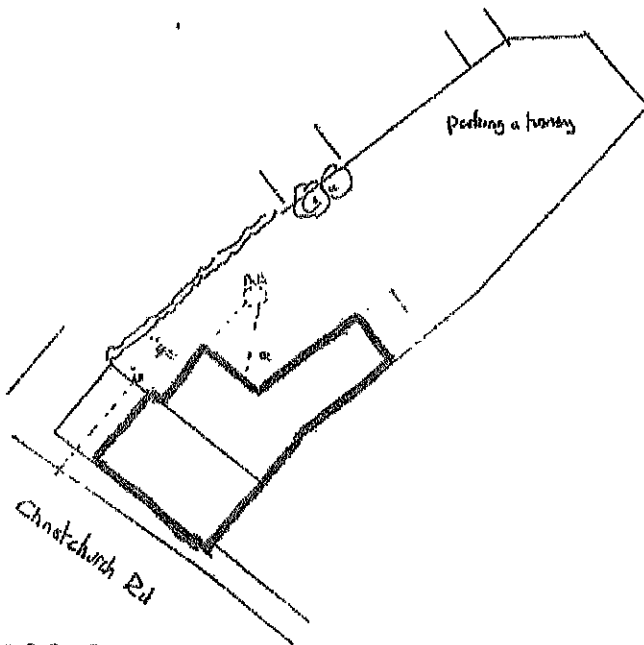
