The applicant of the current application has offered up several measures in section M which include CCTV, challenge 25, alcohol only with a meal, training & incident book. I'd be grateful if these becoming meaningful and enforceable conditions of the premises licence.

At present there is a condition that reads:

'The premises have been in business in the town for over twenty years and have a good relationship with the local Police'.

## India Cottage Conditions

Amend existing conditions to make them meaningful, precise, enforceable, unambiguous, prescriptive and clear).

The premises have a nominated premises supervisor to ensure that alcohol is not taken off the premises.

### **AMEND TO**

Alcohol must not be removed from the premises by customers

### **b) The prevention of crime and disorder**

The premises have been in business in the town for over twenty years and have a good relationship with the local Police.

### **c) Public Safety**

The premises have adequate lighting inside and outside. Clear exit signs and a seating capacity for forty five persons. The premises have a policy to exercise due diligence with regard to health and safety and fire.

### **AMEND TO**

The premises have adequate lighting inside and outside. Clear exit signs will be displayed. There is a policy in place to exercise due diligence with regard to health and safety and fire safety.

### **d) The prevention of public nuisance**

A smart/casual dress code policy applies.

The premises do not promote 'Happy Hour' drinking offers.

### **AMEND TO**

The premises shall operate a smart/casual dress code policy

The premises do not promote 'Happy Hour' drinking offers.

### **e) The protection of children from harm**

The legal restrictions on the admission of children and do not serve alcohol to underage children.

**Applicant offered conditions (amended as above criteria)**

**Crime and disorder licensing objective**

The DPS will nominate a responsible person to manage the premises in his absence.

Continuous CCTV recording will take place in all licensed areas of the premises.

An incident book will be provided at the premises and completed by staff.

There shall be in place for the premises a written policy to prevent the sale or supply of alcohol to persons under 18 years of age. That policy shall require any person who appears to be under the age of 25 years to produce a recognised proof of age card accredited under the Proof of Age Standards Scheme (PASS) or if a proof of age card is not available a photo driving licence indicating that they are over 18 years of age. (Armed Forces ID are also acceptable).

**Public Safety Licensing objective**

The Fire Risk Assessment will be reviewed annually.

Staff will be trained in H&S and fire safety and a record will be kept of all training.

**Prevention of public nuisance licensing objective**

Alcohol shall not be sold or supplied on the premises otherwise to persons taking table meals and for consumption by such a person as ancillary to their meal.

Frequent collection of glasses and bottles will be undertaken to ensure that empty containers do not accumulate in or around the licensed premises.

A smoking area for customers will be provided and suitable receptacles for cigarette debris provided.

**Protection of children licensing objective**

Children must be accompanied on the premises by an adult.

There will be no nudity or sexual performances at the premises.
