TRAFFIC MANAGEMENT & TRANSPORTATION PROGRAMME FOR 2015/16 TO BE PROGRESSED BY NFDC

1 INTRODUCTION

- 1.1 The purpose of this report is to seek:
 - i. Approval for implementation of the suggested programme for 2015/16 (attached as Appendix 1), subject to consultation with Local New Forest District Council (NFDC) & Hampshire County Council HCC Members, Town/Parish Councils and others on detailed design matters.
 - ii. Approval for the reserve schemes included in Appendix 1 to be progressed as soon as resources permit, subject to consultation with NFDC & HCC Members, Town/Parish Councils and relevant others on detailed design matters.
 - iii. Authority to advertise the proposed waiting restrictions, other draft Traffic Regulation Orders and speed tables (covered by The Highways Road Humps Regulations 1999) included in Appendix 1 subject to no objections from Local HCC Councillors or responsible HCC Officers.

2 BACKGROUND

- 2.1 NFDC entered into a Traffic Management Agreement with HCC in February 2009.
- 2.2 Under the terms of the Traffic Management Agency/Partnership Agreement NFDC has to prepare a proposed programme of Traffic Management Work for each financial year for the County Council's consideration. The anticipated annual budget for works and advertisement costs is £22,000 (subject to HCC review).
- 2.3 In accordance with the terms of the HCC/NFDC Capital Schemes Agency Agreement NFDC can implement minor highway engineering schemes on the highway. HCC funded Minor Capital Schemes and Developer Funded schemes are included in the proposed programme.
- 2.4 However, there have been changes in circumstance which affect future operation of the Traffic Management Agency, and in particular this Council's ability to implement minor highway schemes itself. With the retirement of the Principal Engineer (Transportation) Nick Hunt and because our in-house engineers have other priorities for their work, NFDC no longer has the in-house expertise or capacity to arrange and supervise the implementation of this type of minor engineering scheme. Where implementation work has already commenced the schemes will be completed under this year's proposed programme. However, the work programme for 2015/16 does not include the implementation of any further minor highway engineering schemes. Consideration will need to be given as to how (and by whom) this type of scheme will be delivered in the future. Accordingly, the programme set out in Appendix 1 has a separate section which records a number of projects which NFDC has progressed to a stage ready for implementation, but cannot itself implement.

2.5 It should be noted that the arrangement which NFDC has had with HCC, which has enabled NFDC to undertake the implementation of minor engineering schemes (which would otherwise be undertaken by the County Council), is beyond the scope of the normal arrangements in Traffic Management Agreements in Hampshire between the County Council and District Councils – in other words, the type of scheme we currently do not have the capacity to progress and implement ourselves, in other District Council areas, would normally be implemented by the County Council.

3 THE PROPOSED PROGRAMME

3.1 NFDC's Traffic Management Priority Assessment Process is based on its Traffic Management Strategy

(http://www.newforest.gov.uk/media/adobe/6/f/Traffic_Management_Strategy_4_Feb.pdf). This Strategy was agreed in consultation with HCC & NFDC Members, Town/Parish Councils and other stakeholders.

- 3.2 The size of the Programme is influenced by:
 - HCC's and NFDC's allocations for Traffic Management employee costs
 - HCC's allocation for advertising and works costs
 - The availability of developer/HCC funding to fully cover design and works costs
 - The availability of engineers to progress implementation of schemes.
- 3.3 The suggested Programme is based on the current resource situation, but if there is capacity to do so at least some work will be undertaken this financial year to progress initial design work on reserve schemes.
- 3.4 Priority is generally given to progressing proposals investigated or advertised in the previous year and agreed proposals for which external funding is likely to be available.
- 3.5 The schemes included in the work programme for 2015/16 take account of the discussions that have taken place over the year in meetings with District and County Councillors, at which Town and Parish Councils' representatives were in attendance. There have also been separate consultations regarding the allocation of developers' contributions to specific schemes (S106 contributions).
- 3.6 HCC officers have been consulted on the draft Programme and their comments have been taken into account in the programme set out in Appendix 1.
- 3.7 The Council is required to formally advertise draft permanent and temporary Traffic Regulation Orders (including waiting restrictions) and other measures such as speed tables (covered by The Highways Road Humps Regulations 1999). Having done so all representations in respect to draft permanent orders and Hump Regulations are considered in consultation with local NFDC/HCC Members before a decision is made to make or not to make the advertised draft Order etc. in accordance with the Council's scheme of delegation to officers.
- 3.8 For schemes in the Programme that do not require formal advertisement local NFDC/HCC Members, Town/Parish Councils and appropriate officers will be consulted prior to the design being finalised. For the more significant schemes that involve changing road layouts, providing new cycle routes etc. wider notices will be posted on site. Any responses to the notices will be considered in consultation with local NFDC/HCC Members before the design is finalised.

Work on reserve schemes set out in Appendix 1 be progressed as soon as resources are available, subject to the careful consideration of objections to proposals that require statutory public advertisement and/or the consultations referred to above if detailed proposals have not yet been prepared.
- iii. The traffic regulation orders referred to in Appendix 1 be formally advertised subject to no objections from the Local HCC Councillor or the responsible HCC officer if these have not already been consulted.
- iv. The Traffic Management Programme and list of reserve schemes be amended by either the Head of Planning and Tranasportation or Planning Policy Manager in consultation with NFDC's Planning and Transportation Portfolio Holder and HCC Officers to reflect any of the following:
 - Responses to advertised proposals
 - Changes to local NFDC and HCC Members' priorities
 - NFDC Cabinet and Portfolio Holder decisions for allocation of developers' contributions which HCC officers agree NFDC can progress as HCC's partner/agent.
