We intend to hold a cultural and music event, which will showcasing local artists and the local area.

Attendance will be limited to 499 persons on the site at any one time, including staff. The event will be strictly over 18s only. Music will run from 1100 until 2300. We intend to keep refreshments available until 0000 to allow people some time to refresh themselves before heading home, or to the campsite.

We intend to host two musical stages. One main stage and one very small alternative area. Further to this will be some displays of the work of local artists. We intend to have two food vans, which will be run by external local businesses, and two bar areas.

There will be a car parking area with 175 parking spaces.

With the ticket price of our event there includes camping on the premises for the night of Saturday the 4th September. We expect a large proportion of the attendees to camp.
