I understand that each of the shops in the parade, including Tesco's, have caveats in their leases which preclude competing with each other in terms of what they sell, this has lead to the parade being a group of individual businesses serving the needs of the local community.

Tesco appears to have a caveat preventing them from selling alcohol and hot food and the offlicence in the parade has a similar clause from selling items that would compete with Tesco. By making this application, Tesco is hardly adopting a "good neighbour" attitude.

If Tesco are granted a licence the likelihood is that the existing off-licence, restricted as it is with regard to what it can sell, would be unable to compete and would likely fail. Were that to happen, any argument about giving local people greater choice would fail and Tesco would be left with a monopoly that it would undoubtedly take advantage of in the longer term.

This might not be directly relevant to any of the licensing objectives but it does show the corporate attitude of Tesco towards the community, especially with the application being handled by the head office with no real knowledge of the local area.

I am instructed by Mr Ozkan Bulbul who is the proprietor of the Wine Box at 3 Butlers Lane, Poulner. He has traded from these premises since 2013.

We wish to make a representation against the application for the grant of a new Premises Licence for the above premises.

In the application, Tesco asserts "The company has a "good neighbour" policy which seeks to ensure that the premises play an active part on the local community".

Each of the leases for the units in this local shopping parade are subject to covenants, effectively preventing the different businesses from competing with each other. This helps ensure the diversity and vitality of the parade to the benefit of both local traders and shoppers.

Tesco currently have a covenant preventing them from selling alcohol. Mr Bulbul operates the sole off-licence in the parade and his lease contains a covenant preventing his business from selling food, newspaper or other items that would compete with Tesco. \_

By making this application, Tesco is hardly adopting a "good neighbour" policy and if granted, the likelihood is that Mr Bulbul, restricted as he is with regard to what he can sell, would be unable to compete and would likely fail. Were that to happen, any argument about giving local people greater choice would fail and Tesco would be left with a monopoly that it would undoubtedly take advantage of in the longer term.

Whilst this might not be directly relevant to any of the licensing objectives, it serves to demonstrate the attitude of Tesco towards the community.

There are however other, more relevant issues.

Over the past several months, Tesco has suffered a number of shop-lifting incidents, such that at times, it has been compelled to employ security staff. The inclusion of alcohol within its offering is certain to exacerbate the problem (of crime) and attract the less desirable elements of society who would in all likelihood linger outside, drinking and causing issues of anti-social behaviour and nuisance to other shoppers and shop-keepers.

This will no doubt be exacerbated because the competition between the off-licensed premises will undoubtedly result in something of a "price-war". Whilst this might at first sight seem to benefit consumers, it will simply increase the availability of cheap alcohol thereby also increasing the prospect of anti-social behaviour and crime in the locality, not to mention increased littering and the nuisance that causes.

The hours sought are excessive – Tesco propose to sell alcohol from 6 a.m. until midnight and also proposes late night refreshment until midnight. There is nowhere in Ringwood that we are aware of that is open from that time of the morning to that late at night, selling alcohol. That in turn will also no doubt lead to customers who are not local to Poulner and the parade, to travel there at anti-social times of day in order to buy alcohol, again causing nuisance to local residents. It should be noted that Tesco is generally open from 7 a.m. until 11 p.m. at the moment; my client's premises from 10 a.m. until 9 p.m. on Sundays through to Thursday and until 9.30 p.m. on Fridays and Saturdays. The Fish and Chip shop next door opens from 5 p.m. until 0 p.m. on Sundays and Mondays and on other days, it opens from noon until 2.30 p.m. and then again from 4 p.m. until 9.30 p.m.

The conditions proposed by Tesco in its application are woefully inadequate – this appears to be an "off-the shelf" application submitted by its Licensing Team in Welwyn Garden City who clearly have no idea of local circumstances and issues (nor, apparently of the terms of the lease of the premises).

For example, the application says nothing about how Tesco will do any of the following:

Carry out a risk assessment to determine whether and to what extent it needs to provide security personnel;

Ensure that alcohol bought at its premises is not drunk in the parade – there are a number of known alcoholics and drug-users in Ringwood who would no doubt welcome the opening of such an outlet where they could buy cheap and high strength alcohol (in that regard, there is nothing to prevent the sale of for example, "super-strength" ciders) – this is relevant to the issues of crime and disorder (anti-social behaviour), public nuisance and the safety of the public making use of the parade;

Ensure that "proxy sales" (where someone over 18 buys alcohol for someone under-age) do not take place;

Keep records of "refusals" and make those available to the police and other authorities;

Keep records of any other alcohol-related incidents that occur in the premises (such as drunken behaviour, shop-lifting of alcohol products etc);

Ensure that a suitability qualified person is present at all times that alcohol is offered for sale – the application says "a member of management will <u>ordinarily</u> be on the premises....." and not necessarily anyone who holds a personal licence issued under the Licensing Act 2003, nor even a manager at ALL times.

It is of course not for any objector to re-write an application to make it fit for purpose.

The Licensing sub-committee is therefore urged to refuse this application on the grounds that to grant it would undermine the licensing objectives of:

Preventing Crime and Disorder; Preventing Public Nuisance; Public Safety; and Protecting Children from Harm.

In support of this objection, one of the staff at my client's premises has organised a petition – please see the attached email for copies of the same which has some 150 signatures in opposition to Tesco's application..

Anyone wishing to object to an application must ensure that the objection relates to the likely effect of the grant of the licence on the promotion of at least one of the licensing objectives which are:-

- the prevention of crime and disorder
- public safety
- the prevention of public nuisance
- the protection of children from harm

There are matters that are unable to be considered under licensing legislation, such access, parking and road use as these have already been determined under other regulatory regimes such as planning or fire safety.

In addition, the "need" for licensed premises is also not a consideration when determining a premises licence application. It may be considered by some parties that there are sufficient premises in an area providing the licensed activity, already meeting the needs of the community. However, the commercial demand for another licensed premises, again cannot be considered under the terms of this application, but customers can continue to support other local businesses if they wish.

All licensed premises must adhere to licences granted under the Licensing Act 2003 and there are mandatory and specific conditions attached to any licence, including challenge 25 for the prevention of the sale of alcohol to minors, which, as a

responsible retailer Tesco promote. However, should we receive information relating to non-compliance, we will investigate the complaint. In addition, any of the responsible authorities which include the Police, Trading standards and Environmental Protection may call a licence in for review, where, at a hearing, the evidence will be considered.

Therefore, after careful consideration based on the content of the representation, I must inform you that we are unable to consider your representation against the application.
