

CHRISTMAS REFUSE, RECYCLING AND GLASS COLLECTIONS 2022/23 AND 2023/24

1. INTRODUCTION

Over the Christmas and New Year period, collection schedules are altered to accommodate bank holidays. This report summarises the proposed changes for 2022/23 and 2023/24.

2. CHRISTMAS REFUSE, RECYCLING AND GLASS COLLECTIONS

- 2.1 The proposed revised collection arrangements will inconvenience some NFDC residents, but some disruption to services over Christmas is inevitable. These revised arrangements minimise disruption and allow the refuse and recycling collection service to get back to normal as quickly as possible.
- 2.2 Several options were presented to all frontline staff for comment, and this has been considered in this decision, along with operational aspects and considering the impact upon residents.
- 2.3 The proposed refuse and mixed recycling collection arrangements are detailed below.
