It is quite expensive to stay at Harry's Meadow, so does not attract large groups of teenagers and young people. Their guests are families.

As a local business owner, we welcome visitors to this area, and has resulted in much needed revenue at the local pubs, restaurants, & shops.

I understand Harry's Meadow had a licence this year. I walk our own guests through that field twice a day, once in the morning, and once in the evening (with permission) and have seen the bar open, it's a small horsebox serving a few drinks to parents in the evening while their children play in the field.

To Whom it May Concern

I write in support of the premises licence application for Harry's Meadow at Hale Park.

Over the three years this campsite has been operating, the Sheriff family have shown themselves to be the most responsible, most attentive and most caring of leisure operators. They are very keen to do the right thing by the law and by social norms. No detail is too small for them to consider, either from my point of view or the campers'; and they make it very easy for all the campers to have a break from their urban lives in beautiful countryside. This includes restricting access to large groups and single sex or young groups so that the family clients can have an undisturbed rest. This of course reduces their income. I see firsthand the families skipping and singing down the footpath past the house towards Woodgreen and the river and on the slower route up they stop and talk to my wife or the livery owner who might be out feeding horses. I regularly get quizzed about the trees. This all sounds a bit much but I am actually holding back!

Turning to the objections I read, may I be permitted a few comments in my capacity as a local employer and supporter of this Northern Forest fringe? David & Tara Cutler send similar letters to both me and Stephen May, PCSO every year. I have just re-read them. The rumours, promises of legal action (never pursued) and untruths contained within is truly breathtaking. It was interesting to read about allegations of the police being called: this is true. I did call the police to talk to David Cutler about certain actions towards the campers in 2021 that were both distasteful and likely illegal. I should not state them here but would do so if summoned. Suffice to say that they gave him a stern talking to and a notice of action if there were any more complaints.

Harry's Meadow is an honest, clean operation that gives visitors to the Forest what they want in a responsible way while fulfilling their obligations and more to the environment. This licence makes no changes from previous years; the licence applicant is an experienced operator and the licence should be granted.
