

## PLANNING AND TRANSPORTATION/HOUSING PORTFOLIO HOLDER DECISION

### BRITISH TELECOM CONSULTATION ON THE INTENDED REMOVAL OF 80 PUBLIC CALL BOXES WITHIN THE DISTRICT

#### 1. INTRODUCTION

- 1.1 The Council has been consulted by British Telecom (BT) on a proposal to remove a total of 80 Public Call Boxes from within the District of which 32 are located within the National Park and 48 are located outside the Park. The Council is able to raise objection to the removal of any of these call boxes, provided such objections can be justified by reference to specified criteria and whilst having regard to the interests of telecommunication providers.
- 1.2. This report gives details of the consultation exercises that have been undertaken and provides an assessment for each of the 80 call boxes affected in light of the responses received. Approval is sought to issue a decision notice which identifies 11 call boxes which the Council wishes to be retained. Once issued, the decision notice is published and submitted to BT and the Secretary of State. BT has a right to challenge the Council's decision through an appeal process.

#### 2. DETAILS

- 2.1 A schedule of all the call boxes BT wish to remove is attached to this report at **Appendix 1**.
- 2.2 Each call box that BT has proposed to remove within the National Park is identified by numbers NPA 1 to NPA 32. Each call box proposed to be removed outside the National Park is identified by numbers 1 to 48.

#### 3. CONSULTATION

- 3.1 BT has displayed a notice on each call box to tell the public:
- i) that BT is planning to remove the phone box
  - ii) the name of the Local Planning Authority to whom people can send any comments (within 42 days)
  - iii) a Freephone number people can call to find out the next nearest phone box
- 3.2. In addition, all affected Parish Councils have twice been consulted on BT's list of proposed call boxes to be removed. The Parish Councils have also been advised of BT's scheme whereby individuals or community groups, including Parish Councils, may 'adopt' a call box for £1. The 'adopt a box' scheme is a matter for the individual or organisation that wishes to

adopt the call box and BT itself. The scheme has no bearing on the recommendations in this report, however it has been mentioned under the 'Parish Council Response' section of the assessment if a Parish Council have informed us of their wish to adopt a box which is proposed for removal in this consultation. A consultation between some parishes and the New Forest National Park Authority has taken place, however the National Park consultation only concerns to proposed adoption of PCBs. This report objects to the removal of certain payphones within the New Forest National Park. The findings of the other consultation response (completed by James Brown – NPA Archaeologist) should be noted.

3.3 In response to consultation the Council has received only one letter from a local resident in relation to the call box at 'The Weirs', Burley Road, Brockenhurst SO42 7TB (NPA15). The following Parish Councils have responded to the consultation:

#### 4. ASSESSMENT

4.1 The following factors are of relevance in assessing whether any of the call boxes should be retained:

- i) Usage. How many times has the payphone been used in the last 12 months
- ii) Emergency calls. What is the likelihood that the payphone may be required in the case of an emergency to contact services? Is the call box near a traffic accident black spot?
- iii) The demographic of the area. Does the social composition of the area indicate that a payphone may be required for residents who cannot afford their own home phone or mobile phone?
- iv) Mobile phone coverage. What is the quality of mobile phone provision for making voice calls?

4.2 All of the call boxes have been assessed using these criteria and the conclusions are set out in the document attached at **Appendix 2**. The assessment takes account of the consultation responses received.

4.3 In summary, the assessment identifies fifteen call boxes which it is considered necessary to retain as follows:

**Reason:** The modest level of usage of this public payphone indicates that it is of some value to the community. The consultation process with Hordle Parish Council has revealed that although the number of calls is relatively modest, the importance of the calls needs to be given significant weighting. The Council has considered the changing technological environment and commercial conditions that have generated the application for the removal of this PCB. On balance, the Council consider that the removal of the PCB would, in this instance, be disadvantageous to members of the local community. On this basis, its retention is recommended.

The Council has considered the changing technological environment and commercial conditions that have generated this application for the removal of this PCB. However, on balance, the Council consider that the removal of the PCB would, in this instance, be significantly disadvantageous to members of the local community. On this basis, its retention is recommended.

**Reason:** The high level of usage of this public payphone indicates that it is of value to the community. The Council has considered the changing technological environment and commercial conditions that have generated this application for the removal of this PCB. However, on balance, having regard to the social composition of the locality, the Council consider that the removal of the PCB would, in this instance, be significantly disadvantageous to members of the local community.

## 24. Rockbourne Road, Fordingbridge SP6 3NH

PARISH: Rockbourne Parish Council



**Usage (last 12 months): 2**

**Accident Provision:** One slight accident in the last 5 years up the road from this site (crashmap.com)

**Demographic:** No council-owned properties in vicinity of this payphone (Forestmap)

**Mobile Phone Coverage:** Varies from very poor to average depending on provider (Ofcom)

**PARISH COUNCIL RESPONSE:** *Rockbourne Parish Council opposes removal of this payphone as there is very poor mobile reception in this village. There has only been low usage of the phone as it has been out of order for long periods and villagers have been trying to arrange for it to be repaired. The phone box is opposite the Village Hall where a defibrillator is installed which requires a phone line so users can be given a code to access the equipment and usage instructions.*

---

Recommendation: **OBJECT**

**Reason:** The low level of usage of this public payphone, when considered in isolation, indicates that it is of very low value to the community. However, as recognised by Rockbourne Parish Council, the area suffers from having a particularly poor level of mobile phone coverage. The withdrawal of this PCB would leave residents and visitors without alternative forms of communication. This would put the local community at a disadvantage. The Council has considered the changing technological environment and commercial conditions that have generated this application for the removal of this PCB. But any benefits associated with the removal of this PCB are seriously outweighed by the factors outlined above, its retention is therefore recommended.

## 25. Cornpits Lane, Damerham SP6 3HS

**Accident Provision:** No accidents in vicinity on record since 2011 (crashmap.co.uk)

**Demographic:** No council-owned properties in close proximity. (forestmap)

**Mobile Phone Coverage:** Variable depending on network. (Ofcom)

**PARISH COUNCIL RESPONSE:** *Damerham Parish Council have no comments and do not object to the removal of this PCB.*

## 26. Near Village Hall, Damerham SP6 3HE

PARISH: Damerham Parish Council



**Usage (last 12 months): 13**

**Accident Provision:** No accidents in vicinity on record since 2011 (crashmap.co.uk)

**Demographic:** No council-owned properties in close proximity. (forestmap)

**Mobile Phone Coverage:** Variable depending on network (Ofcom)

**PARISH COUNCIL RESPONSE:** 1. *Accident provision: A footpath used twice daily by parents and children leads from very near the payphone to the school and there have been complaints of speeding traffic along this stretch of the road and the lack of awareness of drivers of the pedestrians.*

2. *Emergency calls: This box contains the only accessible phone within reasonable distance of the village defibrillator at the Village Hall, where there is no mobile phone coverage.*

3. *Mobile phone coverage: Contrary to what is claimed in the appendix – since the reciting of the reception aerial by the provider, mobile phone coverage is poor in some areas of the village and non-existent in others.*

**Recommendation: OBJECT**

**Reason:** The low level of usage of this public payphone, when considered in isolation, indicates that it is of low value to the community. However, as recognised by Damerham Parish Council, the payphone is located adjacent to a narrow and dangerous street, and is close to a defibrillator installed in the Village Hall. In addition, the area suffers from poor mobile phone coverage. The Council has considered the changing technological environment and commercial conditions that have generated this application for the removal of this PCB. But any benefits associated with the removal of this PCB are seriously outweighed by the factors outlined above, its retention is therefore recommended.

## 27. Lay-By Near Cartwell Inn, Whitsbury SP6 3PZ

PARISH: Whitsbury Parish Council



**Usage (last 12 months): 0**

**Accident Provision:** No accidents close to this site (crashmap.com)

**Demographic:** Some council-owned properties near to this payphone (Forestmap)

**Mobile Phone Coverage:** Varies from good to very poor dependant on phone network provider (Ofcom)

**PARISH COUNCIL RESPONSE:** *Whitsbury Parish Council objects to the proposed removal of this payphone as there is poor mobile phone reception in this village. The phone has been out of action for approximately 18 months and villagers have been trying to arrange for it to be repaired, which is why there are no calls listed.
